HIS EXCELLENCY the administrator of the Government directs the publication, for general information, of the following notice of the erection of a Lighthouse on the Bluff, at the south side of the entrance of Port Natal.

NOTICE TO MARINERS.

A Lighthouse has been erected on the Bluff, at the south side of the entrance of Port Natal, at an elevation of 292 feet above high-water, a light from which will be exhibited on the 23rd January, 1867.

The lighthouse is in latitude 29° 52' 50" S., and longitude 31° 3' 35" E.

The building is an iron tower in the form of a frustrum of a cone, 81 feet high, painted white, centre of light being 70 feet above the base, exhibiting a revolving white light of the 2nd class (dioptric), attaining its greatest brilliancy once every minute.

It is visible in all directions, from north (round by east and south) to S. 59° W., and can be seen from a ship's deck 24 miles in clear weather.

The above light is not visible from the aliwal shoal, which is 25 miles S. 53° W. from the lighthouse; vessels should not, therefore, when coming from the southward and westward, approach the shore nearer than 4 miles, or shoal their water under 40 fathoms, using the lead freely until they make the light well out from the deck, when they may stand in until it bears N. 59° E., which bearing will keep them outside all known danger, until they are abreast of the Umlazi River (about 9½ miles below the lighthouse), when they must keep it more to the northward, as the land trends more to the eastward, giving the shore a good berth of a mile; and when the lighthouse bears E.N.E. they can haul in to the northward for the anchorage, anchoring in 8½ to 10 fathoms, with the lighthouse bearing S.W. to S.W. ½ S., distant one mile.

REGULATIONS FOR ADVERTISING IN THE PUBLIC JOURNALS.

THE Government have determined that from and after the 1st of January, 1867, the duties connected with advertising in the public journals shall be performed by an Advertising Officer, and that all orders relating to advertising in the newspapers shall be issued through the Advertising Department of the Government Printing Office.

From and after the above date, therefore, Government advertisements from the different departments in Melbourne, for insertion in the newspapers, are to be forwarded under cover to the Government Printer, accompanied by directions as to the newspapers in which they are to be inserted, and the number of insertions required.

The advertisements and orders, with the word "Advertising" marked on the envelope, should be sent not later than three o'clock on each day.

On receiving such directions, the Government Printer will cause the advertisements to be issued to the newspapers mentioned, and a record of the orders given in each case will be kept for comparison when the accounts are presented for payment.

But as there are certain classes of advertisements that cannot conveniently pass through the Government Printing Office, it will be necessary that the officers residing in the country, who are authorised to issue orders for advertising, should state distinctly on their orders the number of insertions required, and, when practicable, the dates on which the advertisements are to appear in the newspapers.

The accounts, with the orders attached, must be forwarded by the claimants to the officers in country districts incurring the expenditure, who will sign and transmit them to the Government Printing Office, where they are to be examined and certified. They will afterward be sent to the Departments to which they relate, that they may be signed and noted, and thence to the Treasury for payment.

Accounts in which there are no items for advertising ordered by officers in the country should be transmitted direct to the Government Printer, to be dealt with similarly to those above described.

Accounts may be furnished monthly, or, if more convenient, on the completion of any particular order.

The accounts for advertising belonging to each department must be rendered on separate vouchers, but all the items relating to any one department may be put upon the same sheet or sheets, provided more than one sheet be necessary. Accounts for advertising performed in different years must be on different vouchers.

Every account should specify the dates of insertion, the number of inches, the rate per inch, and the total amount in figures and words.

Unless the accounts are in every case accompanied by the orders they cannot be certified.

NOTICE TO NEWSPAPER PROPRIETORS AND PUBLISHERS, AND TO PRINTERS.

BY the *Printers and Newspapers Registration Statute* 1864, it is required that an affidavit, duly sworn and signed by the proprietors, and by the printer and the publisher of every newspaper, shall be deposited with the Registrar General prior to the first publication of a newspaper, and whenever in any newspaper already registered, any change is made in any of the particulars required to be stated in the affidavit. The penalty for breach of this provision is a sum of not less than £25 nor more than £100. By the same statute it is also required that the printer and the publisher of a newspaper, together with two sufficient sureties, shall, prior to the publication of the newspaper, and also upon the insolvency of a surety and notice from the Chief Secretary, or upon the withdrawal of a surety, enter into recognizances before a Judge of the Supreme Court, or the Police Magistrate of the district, for payment of any fine or penalty that may be inflicted for printing or publishing any blasphemous or seditious libel. The penalty for breach of this provision is a sum of not less than £5 nor more than £20, together with all reasonable costs of discovering and prosecuting the offence.

2. Every person who has any printing press or types for printing is required by the above-mentioned statute to give notice thereof in writing, signed by himself and attested by a witness, to the Registrar General. The penalty for breach of this provision is a sum of not less than £5 nor more than £20. And every person who prints for publication or dispersion any paper or book is required to print his name and place of abode upon the front of every such paper if it be printed upon one side only, and upon the first and last leaf of every paper or book if there be more than one such leaf. The penalty for breach of this provision is a sum of not less than £5 nor more than £20.

The above provisions of the law have been hitherto wholly or in part disobeyed by a large number of newspaper proprietors, publishers, and printers: Notice is hereby given, that after the expiration of one month from this date the law will be strictly enforced against all offenders.

At a meeting of the Council of the city of Melbourne, held in the Council Chamber in the Town Hall, Swanston street, in the said city, on the 3rd day of December, 1886, at which were present:—The Right Worshipful the Mayor, Councillor William Williams, presiding; Aldermen John Harbison, George Hughes, John Thomas Smith, and George Wragge; Councillors Samuel Amess, William Bayles, James Stewart Butters, Orlando Fenwick, Robert Flockhart, Abraham Linacre, Thomas Moubay, Alexander McBean, Thomas McPherson, Thomas Reed, Henry Sanders, Alexander Kennedy Smith, Joseph Story, and John Walker, being more than one-third of the members of the said council, it was resolved and ordered, that whereas by an Act of the Governor and Legislative Council of New South Wales, 14 Victoria, No. 20, intituled *An Act for regulating the formation, drainage, and repair of Streets, Courts, and Alleys on Private Property within the City of Melbourne*, it is amongst other things enacted that where any street, court, or alley on private property, in the city of Melbourne, shall not be or shall not have been sufficiently paved, flagged, macadamised, levelled, drained, and sewered, or otherwise completed or repaired to the satisfaction of the council of the said city, it shall be lawful for the said council at any time, and from time to time, by any order under the hand of the mayor or town clerk of the said city for the time being respectively, to order that any such street, court, or alley, or any part thereof, shall be freed from obstruction, paved, flagged, macadamised, levelled, drained, and sewered, or otherwise completed or repaired, in such manner and within such time as to the said council may appear expedient; and thereupon the owners of the tenements adjoining or abutting upon such street, court, or alley, on each side thereof, shall, in such manner and within such time as shall be expressed in such order, at their respective costs, charges, and expenses, remove all obstructions, and well and sufficiently pave, flag, macadamise, level, drain, and sewer, or otherwise complete or repair so much of the said street, court, or alley, to the centre thereof, as may be opposite to and co-extensive with their respective tenements, adjoining or abutting on such streets, courts, or alleys respectively:

And whereas by the Act of the Parliament of Victoria No. 178, intituled *An Act to further alter and amend the Laws relating to the City of Melbourne and of the Town of Geelong respectively, and to extend and apply other existing Acts thereto*, it is amongst other things enacted, that the words "tenements adjoining or abutting on such street, court, or alley," where used in the first hereinbefore-recited Act, shall be held and taken to mean all tenements or premises actually abutting upon, and accessible from, and communicating with such street, court, or alley, whether the owners or occupiers thereof have or have not a right to use or do commonly use the same: And that the word "owner," used in the said Act shall apply to and be held to include agent of an owner, but only in so far as to enable such agent to apply to the defrayal of expenses incurred in the formation, drainage, and repair of such street, court or alley, under the authority hereof, moneys of his principal, of which he shall be in the receipt or possession, accruing from tenements lawfully chargeable for such expenses:

And that the said Act for regulating the formation, drainage, and repair of streets, courts, and alleys on private property within the city of Melbourne, shall extend and apply to the entire limits of the said city:

And that the apportionment of the expenses incurred by the council of the city of Melbourne, in the formation, drainage and repair of every such street, court, or alley, on private property, shall be made proportionate to the extent of the area of the land of each of the several owners which shall be so situated as to have or be capable of obtaining access to such street, court, or alley, at the time of or in consequence of the formation or repair of such street, court, or alley:

And whereas the streets, courts, or alleys, enumerated in the schedule to the order annexed, marked A, have not been sufficiently paved, flagged, macadamised, levelled, drained, and sewered, or otherwise completed or repaired to the satisfaction of the council of the city of Melbourne:

Be it now ordered by the council of this the said city, that the streets, courts, or alleys, enumerated in the schedule to this order annexed, marked A, shall within ten days from the date of this order's coming into operation, be freed from obstruction, paved, flagged, macadamised, levelled, drained, and sewered in such manner as is expressed in the schedule to this order annexed and marked B. And it is hereby notified to the owners respectively of the tenements adjoining or abutting upon the streets, courts, or alleys, enumerated in the schedule to this order annexed, marked A, that if they or any of them shall neglect or omit to remove the obstructions, and pave, flag, macadamise, level, drain, and sewer, or otherwise complete and repair the street, court, or alley on which their respective tenements adjoin or abut, in the manner and within the time expressed in this order, then the council of the said city will remove all obstructions in the said streets, courts, or alleys, and pave, flag, macadamise, level, drain, sewer, and otherwise complete or repair the same, or such parts thereof as shall not have been so done pursuant to this order; and will thereupon ascertain, determine, and charge such respective owners with their several proportionate part of the costs, charges, and expenses thereof, according to and co-extensive with their respective tenements adjoining or abutting on said street, court, or alley, proportionate to the extent of the area of the land of each of the several owners so situated as to have or be capable of obtaining access to such street, court, or alley, at the time of or in consequence of the formation or repair of such street, court, or alley, having regard in such apportionment to the state and condition in which the pavement, flagging, macadamising, levelling, draining, and sewerage, of such streets, courts, or alleys respectively, or any part thereof, shall or may be at the time of making this order.

SCHEDULE B.
Referred to in this Order.

Manner in which the streets, courts, and alleys, enumerated in schedule A, referred to in this Order, are ordered to be freed from obstruction, paved, kerbed, flagged, macadamised, levelled, drained, and sewered.

The natural soil is to be reduced or made up, as the case may require, so that the longitudinal section of the whole street, court, or alley, shall in no part have an inclination of less than one (1) in eighty (80), and where practicable the entire length is to form one incline.

In laying on any stuff it is to be spread in layers of not more than one foot thick.

The transverse section of the street, court, or alley (where the water-channels are on the sides), is to show a roadway whose crown shall be one inch above the kerbs of the footways, and the fall from the crown to the water-channels shall not be less than one (1) in twenty-five (25).

Each street, court, or alley, shall have a bluestone pitched water-channel, either at each of its sides or in its centre, of sufficient capacity to meet the required drainage for the same, the width of said channel or channels in no instance to be less than two (2) feet.

The pitches are to be nine (9) inches wide, and from six (6) to nine (9) inches deep, and from nine (9) to fourteen (14) inches long, with upright sides set in sand, and well rammed down to such section as the city surveyor may direct.

The bottom of the channel is to be seven (7) inches below the kerbstones of footpaths.

On either side of the roadway there is to be, where practicable, a footpath not more than three (3) feet wide, and these are to be separated from the roadway by a neatly dressed bluestone kerb from two (2) to four (4) feet long, six (6) inches wide, and fifteen (15) inches deep.

The footways are to be covered with a coat of gravel three (3) inches thick, and the surface is to fall towards the channel at the rate of one (1) in ten (10).

The roadway is to be covered with a coat of clean bluestone metal, 2½-inch gauge, nine (9) inches deep in the centre, and six (6) inches deep on the sides, and this, when necessary, covered over with a coat of good loam two (2) inches thick, and rolled with corporation iron roller.

Whenever private entrances lead from the streets, courts, or alleys, they are to be paved to the full width (of building line) with bluestone pavers similar to those used in the channels.

All entrances from adjoining street shall be pitched and kerbed either with four (4) inch bluestone cubes or nine (9) inch pavers, as the city surveyor may direct, the sides being well supported with eight (8) inch stone kerbing.

The whole of the work must be done under the inspection, and subject to the approval, of the city surveyor, who is authorised to order any deviation from these general principles which the peculiarities of any case may require.

QUEENSLIFFE COUNCIL.

BYE-LAW No. 1.—TO PROVIDE FOR THE DUE MANAGEMENT OF THE AFFAIRS OF THE COUNCIL OF THE BOROUGH OF QUEENSLIFFE.

THE council of the borough of Queenscliffe do hereby make the following bye-law, that is to say:—

1. At all meetings when there is not a quorum present, or when the council shall be counted out, such circumstances, together with the names of the councillors present, shall be recorded in the minute-book.

2. The minutes of any preceding meeting, not previously confirmed, shall be read as the first business at all meetings of the council, in order to their confirmation, and no discussion shall be permitted thereon, except as to their accuracy as a record of the proceedings of the council; and upon their being confirmed, or amended and confirmed, as the case may be, shall be signed by the chairman.

3. After the signing of the minutes as aforesaid, the order of business of an ordinary meeting shall be as follow, or as near thereto as may be practicable; but for the greater convenience of the council at any particular meeting thereof, it may be altered by resolution to that effect:—

I. Reading of copies of letters sent by the authority of the council.

II. Reading letters received, and considering and ordering thereon.

III. Reception and reading of petitions and memorials.

IV. Presentation of reports of committees.

V. Payments.

VI. Ordinary business.

VII. Subjects continued from proceedings of former meetings.

VIII. Extraordinary business, and new rules and regulations.

IX. Other motions of which previous notice has been given.

X. Notices of motion.

And the order of business at a special meeting shall be the order in which such business stands in the notice thereof.

4. Every petition or memorial addressed to the council shall be in proper form, and presented by one of the members, who shall be responsible for its being respectfully worded, and shall write his name at the beginning thereof.

5. On the presentation of a petition no debate shall take place thereon until notice has been given in the usual manner; and the only question that shall be entertained on the occasion of its presentation shall be: that it be received, that it be referred to a committee, or, if thought advisable, that it be made an order of the day.

6. Reports of committees shall be read and received *pro forma*, and, if ordered by the council, shall be printed for distribution among the members; but if in the report of a committee there are distinct recommendations contained, such report shall not be adopted until the sense of the council has been taken separately, on each subject.

7. No contract involving greater liability than Five pounds shall be entered into unless notice of motion shall have been given at a previous meeting.

8. No notice entered on the notice paper shall be proceeded with, unless the member who has given such notice, or some councillor authorised by him, be present, when the business is called in order. Notices not so proceeded with shall be struck off the notice paper.

9. The members in speaking shall designate each other by their respective titles, as mayor or councillor, as the case may be.

10. Any councillor desirous of proposing a motion or amendment, or of discussing any matter under consideration, must rise and address the mayor, or other presiding chairman; and no councillor when speaking shall be interrupted, unless called to order, when he shall sit down, in which case the councillor calling to order shall be heard thereon in preference to any other speaker; and the question of order shall be disposed of before the subject is resumed, or any other subject entered upon.

11. Any councillor desirous of proposing either an original motion or amendment, must state the nature of such motion or amendment before addressing the council in support thereof.

12. No motion or amendment shall be entertained or discussed unless it be seconded. Motions and amendments not seconded shall lapse.

13. No councillor shall speak twice on the same motion or amendment except by way of explanation, or in reply upon the original motion of which he may have been the mover. Any councillor proposing a motion or amendment shall be held to have spoken on the question.

14. No councillor shall digress from the subject-matter of the question under discussion, or impute improper motives to others; and all personal reflections upon any member of the council shall be considered highly disorderly.

15. The mayor, or other presiding chairman, when called upon to decide a point of order or practice, shall state the rule or precedent applicable to the case, and his decision of what is order shall be final in each case.

16. The mayor, or other presiding chairman, shall stand up when addressing the council upon any question.

17. Any councillor who shall use any expression capable of being applied offensively to any other councillor, shall, if required by the council, withdraw such expression, and make a satisfactory apology to the council, under a penalty, in case he refuse or neglect to do so before the rising of the council, of not more than Five pounds.

18. Any councillor may require the town clerk to take down any particular words used by a councillor immediately upon the same being uttered.

19. If two or more councillors rise to speak at the same time, the mayor, or other presiding chairman, shall decide which is entitled to pre-eminence.

20. Any councillor having proposed a motion, or amendment, may withdraw the same, but if seconded shall only do so by leave of the seconder.

21. Questions may be superseded, first, by the adjournment of the council, on the motion of a councillor, "That this council do now adjourn"; second, by the previous question, viz., "That this question be now put", being proposed and negatived.

22. If the previous question be resolved in the affirmative, the original question shall be put forthwith without any amendment or debate.

23. The council may order any question to be divided.

24. So soon as the debate upon any subject shall be concluded, the mayor or other presiding chairman shall put the question to the council in a distinct and audible manner.

25. The question being put, shall be resolved in the affirmative or negative by the majority of votes by a show of hands.

26. No amendment shall be proposed in any part of a question after a later part has been amended and resolved by the council.

27. The council shall have the power of altering any question or resolution of a committee of the whole, or of vetoing the same.

28. A committee of the whole council must be appointed by resolution, "That this council do now resolve itself into a committee of the whole for the purpose of", and that take the

chair."

29. If any disorder arise in committee, the mayor or other presiding chairman of the council shall resume his seat without any question being put, and the chairman of committee shall be heard as to the disorder; and the member in fault shall be called upon for an apology, and in case of refusal shall be dealt with as provided in clause 17 of this bye-law.

30. When matters referred to a committee of the whole shall have been considered, the chairman shall report the same to the council.

31. Members of committee may speak more than once on the same subject.

SUSPENSION OF STANDING ORDERS.

32. It shall be competent for the council to suspend any of these standing orders on the motion of a councillor, and concurred in by the votes of two-thirds of the members present, but the councillor proposing the motion shall show the imperative necessity for such suspension, in order that he may introduce the subject-matter to the council.

33. Any person, not being a councillor, who shall, having been admitted to any meeting of the council, be guilty thereof of any improper or disorderly conduct, or who shall not leave when lawfully requested by the mayor or chairman so to do, may be forthwith removed, and shall be liable to a penalty not exceeding Five pounds.

34. Any councillor may, of right, demand the production of any of the documents of the council applying to the question under discussion.

35. At every meeting of the council, all motions, whether original motions or amendments, shall be reduced into writing, signed by the mover and seconder, and delivered to the chairman immediately on their being moved and seconded.

36. No second or subsequent amendment, whether upon an original proposition or on an amendment, shall be taken into consideration until the previous amendment is disposed of.

37. If an amendment be negatived then a second may be moved to the question to which the first-mentioned amendment was moved, but only one amendment shall be submitted to the council for discussion at a time.

38. No discussion shall be allowed on any motion for adjournment of the council, but if, on the question being put, the

motion be negatived, the subject then under consideration or the next on the notice paper shall be discussed, or any other that may be allowed precedence, before any subsequent motion for adjournment be made.

39. Any councillor may protest against any resolution of the council, and notice of intention to protest shall, in every case, be given forthwith on the adoption of the resolution protested against, and the protest shall specify the reason for protesting, and shall be entered, within three days, by the protesting councillor, in a book to be kept for that purpose in the Town Clerk's Office, and signed by such councillor.

40. If a debate on any motion moved and seconded be interrupted by the number of the councillors present becoming insufficient for the transaction of business, such debate may be resumed, at the point where it was so interrupted, on motion upon notice.

41. Minutes of all proceedings of committees, as well as of their reports, numbered in consecutive order, shall be entered in the committee's minute-book, and being signed by the chairman of the committee shall be presented to the council; and the town clerk, when practicable, shall attend all meetings of committees.

42. The town clerk shall convene every committee within ten days of its first appointment, or at any other time thereafter, by order of the council, or on the written order of the chairman of the committee, or of any two members of the committee.

43. No appointment to any office at the disposal of the council shall take place until seven clear days' public notice shall have been given, by advertisement in one or more newspapers circulating in the borough, inviting applications from qualified candidates for the same.

44. The salary or allowance attached to all offices at the disposal of the council shall in all cases be fixed before the advertisement inviting applications as aforesaid, and shall be specified in such advertisement.

45. No councillor or officer of the council, and no assessor or auditor of the borough shall be received as a surety for any officer appointed by the council, or for the performance of any contract with the council.

46. All the plans and specifications for any public work shall be laid before the council at least six days prior to the same being considered, and be open for inspection by any ratepayer during that time.

The common seal of the borough shall be kept in a box having two locks, of one of which locks the mayor and each councillor shall have a key, and of the other of which locks the key shall be kept by the town clerk; and the corporate seal of the borough shall not be affixed to any document unless the mayor and one other member of the council, or in the absence of the mayor, two councillors, be present.
