#### NOTICE TO MARINERS.

A Lighthouse has been erected on the Bluff, at the south side of the entrance of Port Natal, at an elevation of 292 feet above high-water, a light from which will be exhibited on the 23rd January, 1867.

The lighthouse is in latitude 29° 52′ 50″ S., and longitude

The building is an iron tower in the form of a frustrum of a cone, 31 feet high, painted white, centre of light being 70 feet above the base, exhibiting a revolving white light of the 2nd class (dioptric), attaining its greatest brilliancy once every

above the ones, exhibiting a reversity once overy minute.

It is visible in all directions, from north (round by east and south) to S. 59° W., and can be seen from a ship's deck 24 miles in clear weather.

The above light is not visible from the aliwal shoal, which is 25 miles S. 53° W. from the lighthouse; vessels should not, therefore, when coming from the southward and westward, approach the shore nearer than 4 miles, or shoal their water under 40 fathoms, using the lead freely until they make the light well out from the deck, when they may stand in until it bears N. 59° E., which bearing will keep them outside all known danger, until they are abreast of the Umlazi River (about 9) miles below the lighthouse) when they must-keep it more to the northward, as the land trends more to the eastward, giving the shore a good berth of a mile; and when the lighthouse bears E.N.E. they can hauf in to the northward for the anchorage, anchoring in \$1 to 10 fathoms, with the lighthouse bearing S.W. to S.W. \$1.8, distant one mile.

### REGULATIONS FOR ADVERTISING IN THE PUBLIC JOURNALS.

THE Government have determined that from and after the 1st of January, 1867, the duties connected with advertising in the public journals shall be performed by an Advertising Officer, and that all orders relating to advertising in the newspapers shall be issued through the Advertising Department of the Government Printing Office.

From and after the above date, therefore, Government advertisements from the different departments in Melbourne, for insertion in the newspapers, are to be forwarded under cover to the Government Printer, accompanied by directions as to the newspapers in which they are to be inserted, and the number of insertions required. of insertions required.

The advertisements and orders, with the word "Advertising" marked on the envelope, should be sent not later than three o'clock on each day.

o'clock on each day.

On receiving such directions, the Government Printer will cause the advertisements to be issued to the newspapers mentioned, and a record of the orders given in each case will be kept for comparison when the accounts are presented for payment.

But as there are certain classes of advertisements that cannot conveniently pass through the Government Printing Office, it will be necessary that the officers residing in the country, who are authorised to issue orders for advertising, should state distinctly on their orders the number of insertions required, and, when practicable, the dates on which the advertisements are to appear in the newspapers.

The accounts, with the orders attached, must be forwarded by the claimants to the officers in country districts incurring the expenditure, who will sign and transmit them to the Government Printing Office, where they are to be examined and certified. They will afterward be sent to the Departments to which they relate, that they may be signed and noted, and thence to the Treasury for payment.

Accounts in which there are no items for advertising ordered y officers in the country should be transmitted direct to the lovernment Printer, to be dealt with similarly to those above described.

Accounts may be furnished monthly, or, if more convenient, on the completion of any particular order.

The accounts for advertising belonging to each department must be rendered on separate vouchers, but all the items relating to any one department may be put upon the same sheet or sheets, provided more than one sheet be necessary. Accounts for advertising performed in different years must be on different vouchers.

Every account should specify the dates of insertion, the number of inches, the rate per inch, and the total amount in figures and words.

Unless the accounts are in every case accompanied by the orders they cannot be certified.

### NOTICE TO NEWSPAPER PROPRIETORS AND PUBLISHERS, AND TO PRINTERS.

PUBLISHERS, AND TO PRINTERS.

By the Printers and Newspapers Registration Statute 1864, it is required that an affidavit, duly sworn and signed by the proprietors, and by the printer and the publisher of every newspaper, shall be deposited with the Registrar General prior to the first publication of a newspaper, and vehenever, in any newspaper and related registered, any change is made in any of the particulars required to be stated in the affidavit. The penalty for breach of this provision is a sum of not less than £25 nor more than £100. By the same statute it is also required that two sufficient sureties, shall, prior to the publication of the newspaper, and also upon the insolvency of a surety and notice from the Chief Secretary, or upon the withdrawal of a surety, enter into recognizances before a Judge of the Supreme Court, or the Police Magistrate of the district, for payment of any fine or penalty that may be inflicted for printing or publishing any blasphemous or seditious libel. The penalty for breach of this provision is a sum of not less than £5 nor more than £20, together with all reasonable costs of discovering and prosecuting the offence.

2. Every person who has any printing press or types for printing is required by the above-mentioned statute to give notice thereof in writing, signed by himself and attested by a witness, to the Registrar General. The penalty for breach of this provision is a sum of not less than £5 nor more than £20. And every person who prints for publication or dispersion any paper or book is required to print his name and place of abode upon the front of every such paper if it be printed upon one side only, and upon the first and last leaf of every paper or book if there be more than one such leaf. The penalty for breach of this provision is a sum of not less than £5 nor more than £20.

The above provisions of the law have been hitherto wholly or in part disobeyed by a large number of newspaper proprietors, publishers, and printers: Notice is hereby given, that after the expiration of one month from this date the law will be strictly enforced against all oftenders.

Manner in which the streets, courts, and alleys, enumerated in schedule A, referred to in this Order, are ordered to be freed from obstruction, paved, kerbed, flagged, macadamised, levelled, drained, and sewered.

The natural soil is to be reduced or made up, as the case may require, so that the longitudinal section of the whole street, court, or alley, shall in no part have an inclination of less than one (1) in eighty (80), and where practicable the entire length is to form one incline.

In laying on any stuff it is to be spread in layers of not more than one foot thick.

The transverse section of the street, court, or alley (where the water-channels are on the sides), is to show a roadway whose crown shall be one inch above the kerbs of the footways, and the fall from the crown to the water-channels shall not be less than one (1) in twenty-five (25).

Each street; court, or alley, shall have a bluestone pitched water-channel, either at each of its sides or in its centre, of sufficient capacity to meet the required drainage for the same, the width of said channel or channels in no instance to be less than two (2) feet.

The pitchers to be nine (9) inches wide, and from six (6) to nine (9) inches deep, and from nine (9) to fourteen (14) inches long, with upright sides set in sand, and well rammed down to such section as the city surveyor may direct.

by the chairman.

Reports of committees shall be read and received pro formal, and, if ordered by the council, shall be printed for distribution among the members; but if in the report of a committee there are distinct recommendations contained, such report shall not be adopted until the sense of the council has been taken separately, on each subject.

17. No contract involving greater liability than Five pounds shall be entered into unless notice of motion shall have been given at a previous meeting.

180. No notice entered on the notice paper shall be proceeded with, unless the member who has given such notice, or some councillor authorised by him, be present, when the business is called in order. Notices not so proceeded with shall be struck off the notice paper.

19. The members in speaking shall designate each other by their respective titles, as mayor or councillor, as the case may

Any councillor desirous of proposing a motion or amendment, or of discussing any matter under consideration, mustrise and address the mayor, or other presiding chairman; and no councillor when speaking shall be interrupted, unless called to order, when he shall sit down, in which case the councillor calling to order shall be heard theron in preference to any other speaker; and the question of order shall be disposed of before the subject is resumed, or any other subject entered upon.

11. Any councilor desirous of proposing either an original motion or amendment, must state the nature of such motion or amendment before addressing the council in support thereof.

12. No motion or amendment shall be entertained or discussed unless it be seconded. Motions and amendments not seconded shall lapse.

13. No councillor shall speak twice on the same motion or amendment except by way of explanation, or in reply upon the original motion of which he may have been the mover. Any councillor proposing a motion or amendment shall be held to have spoken on the question.

14. No councillor shall digress from the subject-matter of the question under discussion, or impute improper motives to others; and all personal reflections upon any member of the council shall be considered highly disorderly.

15. The mayor, or other presiding chairman, when called upon to decide a point of order or practice, shall state the rule or precedent applicable to the case, and his decision of what is order shall be final in each case.

16. The mayor, or other presiding chairman, shall stand up when addressing the council under a penalty, in case he refuse or neglect to do so before the rising of the council, withdraw such expression, and make a satisfactory apology to the council, under a penalty, in case he refuse or neglect to do so before the rising of the council, of not more than Five pounds.

18. Any councillor may require the town clerk to take down any particular words used by a councillor immediately upon the same being uttered.

28. A committee of the whole council must be appointed by resolution, "That this council do now resolve itself into a committee of the whole for the purpose of take the choir"

29. If any disorder arise in committee, the mayor or other presiding chairman of the council shall resume his seat without any question being put, and the chairman of committee shall be heard as to the disorder; and the member in fault shall be called upon for an apology, and in case of refusal shall be dealt with as provided in clause 17 of this byo-law.

30. When matters referred to a committee of the whole shall have been considered, the chairman shall report the same to the council.

31. Members of committee may speak more than once on the

32. It shall be competent for the council to suspend any of these standing orders on the motion of a councillor, and concurred in by the votes of two-thirds of the members present, but the councillor proposing the motion shall show the imperative necessity for such suspension, in order that he may introduce the subject-matter to the council.

33. Any person, not being a councillor, who shall, having been admitted to any meeting of the council, be guilty thereat of any improper or disorderly conduct, or who shall not leave when lawfully requested by the mayor or chairman so to do, may be forthwith removed, and shall be liable to a penalty not exceeding Five pounds.

34. Any councillor may, of right, demand the production of any of the documents of the council applying to the question under discussion.

35. At every meeting of the council, all motions, whether original motions or amendments, shall be reduced into writing, signed by the mover and seconder, and delivered to the chairman immediately on their being moved and seconded.

36. No second or subsequent amendment, whether upon an original proposition or on an amendment, shall be taken into consideration until the previous amendment is disposed of.

37. If an amendment be negatived then a second may be moved to the question to which the first-mentioned amendment was moved, but only one amendment shall be submitted to the council for dicussion at a time.

38. No discussion shall be allowed on any motion for adjournment of the council, but if, on the question being put, the

motion be negatived, the subject then under consideration or the next on the notice paper shall be discussed, or any other that may be allowed precedence, before any subsequent motion for adjournment be made.

Any councillor may protest against any resolution of the council, and notice of intention to protest shall, in every case, be given forthwith on the adoption of the resolution protested against, and the protest shall specify the reason for protesting, and shall be entered, within three days, by the protesting councillor, in a book to be kept for that purpose in the Town Clerk's Office, and signed by such councillor.
