## GRANT FOR PUBLIC LIBRARIES.

THE Committees for the management of Mechanics' Institutes or other Public Libraries in country districts, claiming to participate in the grant for the purchase of books, are hereby informed that the distribution of the amount for 1865 will take place upon the expiration of six weeks from the date hereof.

The conditions attached to the item in the Estimates are as follow—

1. That grants be made in proportion to sums collected by private subscription or local rates during 1865.
2. That no grant exceeding £200 be paid to any one library.
3. That no grant be made to any institution in Melbourne, or more than one-sixth of the entire sum be divided amongst institutions within ten miles of it.

### SPECIAL NOTICE TO HOLDERS OF ELECTORS' RIGHTS.

IT is hereby notified that holders of Electors' Rights, issued on or before the 1st day of September, 1865, must obtain renewed rights in lieu thereof, in order to have their names placed upon the General Lists to be made up on the 1st day of September next.

Neglect of this precaution will result in the disfranchisement of the persons so neglecting.

No Elector whose name is on a Roll of Ratepaying Electors for any district is entitled to a renewed Elector's Right for such district.—*Vide* sections 61 and 62 of *The Electoral Act 1865*.

## REGULATIONS FOR PRIVATE BONDING WAREHOUSES.

THE accompanying Regulations, approved by the Governor in Council, under which private warehouses may be licensed for bonding purposes, under the 9th section of the Act 29 Victoria No. 293, are published for general information.

1. Applicants for licenses for private bonding warehouses, under the 9th section of the Act of Parliament 29 Victoria No. 293, shall apply in writing to the collector of customs at the port where the premises are situated for a license, when such collector shall cause the proper officer of customs to survey and report on the suitability of such premises for the required purposes.

2. On the receipt by the collector of a satisfactory report from the surveying officer of the premises for bonding purposes for which a license is required, a bond in the annexed form shall be entered into by the owner or occupier of such premises with two sufficient sureties in the sum of Two thousand pounds, after such sureties shall have been approved by the Commissioner of Trade and Customs.

3. The owner or occupier of any private warehouse requiring the entire services of a locker shall, on his premises being licensed as aforesaid, pay to the collector of customs the annual sum of One hundred and sixty pounds, by equal quarterly payments in advance, for the payment of the salary of such locker, or when two owners or occupiers of warehouses conjointly require the services of one locker only, an annual fee of the same amount shall be paid in such proportions in respect of each warehouse as may be directed by the Commissioner of Trade and Customs.

4. The owner or occupier of any private warehouse requiring the occasional services only of a locker shall obtain the same on making written application to the collector thereof in sufficient time to enable that officer to make the necessary arrangements for complying with such request, and the fee payable for such service shall be at the rate of One shilling and sixpence per hour, to take effect from the time of an extra officer being sent from the Custom House to relieve the locker appointed for the required service, and until the return of such extra officer.

5. A book to be called the "Private Warehouse Lockers' Time Book" shall be kept by the landing surveyor, who shall note therein the time, as specified in previous clause, during which the occasional lockers are employed at each warehouse respectively, and shall be available to the owner or occupier of any warehouse for the examination of his own account. A claim shall be rendered monthly by the collector for the services of occasional lockers, after certification by the landing surveyor that such is correct.

**THE SUBDIVISIONS OF THE SHIRE OF BEECHWORTH.**

*At the Executive Council Chamber, Melbourne, the thirtieth day of April, 1866.*

WHEREAS by *The Local Government Act 1863* it is amongst other things enacted that at any time after the first annual election or general election, as the case may be, or first appointment of members of the district board, for any original or proclaimed district thereafter sometimes called "single district," the Governor in Council, if it seem fit, may, and if he shall have received a petition to that effect signed by twenty persons liable to be rated under the said Act in respect of rateable property in the said district, shall, within three months after the receipt of the same, divide the district into two, or, if the Governor in Council shall see fit, into three separate electoral subdivisions, hereinafter called subdivisions, by such names as shall by such Order in Council be assigned to the same, and in and by such Order in Council the boundaries of the subdivisions shall be set forth; provided that no such division shall be made within three months before any day appointed for holding any election of members of the district board in or for such district; and it is also enacted that every shire shall after the proclamation thereof as such be and be deemed to be and have been such and the same district as such shire was at the time of such proclamation, and save as aforesaid and save where therein otherwise expressly provided all the provisions of the said Act relating to districts shall continue and be of full force and effect with regard to such shire and be read accordingly: And whereas by an Order of the Governor in Council made on the eighth day of January, 1866, the Shire of Beechworth was constituted: And whereas the Governor in Council has received a petition signed by not less than twenty persons liable to be rated under the said Act in respect of rateable property in the said shire, praying for the division of the said shire into three subdivisions: Now therefore His Excellency the Governor, with the advice of the Executive Council, doth by this present Order divide the Shire of Beechworth into three separate electoral subdivisions in accordance with the provisions of the said Act, by the names hereinafter assigned to the same respectively, and doth hereby set forth the boundaries of the said several subdivisions in manner following, that is to say:—

**NORTH RIDING.**—Commencing at a point on the western boundary of the Yackandandah shire, due east of Mount Pilot; thence due west to a point on the eastern boundary of the North Ovens road district; thence due south by the said boundary to the Melbourne and Sydney road; thence easterly by the said road to the southern boundary of the borough of Beechworth; thence west and north by the said boundary to the north-west angle thereof; thence east by the northern boundary of the said borough and a direct line to the western boundary of the Yackandandah shire; thence north-westerly by that boundary to the commencing point.

**WEST RIDING.**—Commencing at the Albert road, on the southern boundary of the borough of Beechworth; thence by a line bearing due south to a point at the head of the Six-mile Creek; thence by the watershed of Bowman's Forest and the Ovens River to the south-east angle of the North Ovens road district; thence north by the eastern boundary of the said road district to the Melbourne and Sydney road; thence easterly by the said road to the southern boundary of the borough of Beechworth; thence by the said boundary easterly to the commencing point.

**EAST RIDING.**—Commencing at the Albert road, on the southern boundary of the borough of Beechworth; thence by a line bearing due south to a point at the head of the Six-mile Creek; thence by the watershed of Bowman's Forest and the Ovens River to the northern boundary of the Buckland road district; thence easterly by that boundary to the western boundary of the Yackandandah shire; thence north-westerly by that boundary to a point due east of the northern boundary of the borough of Beechworth; thence west by a direct line to the north-east angle of the said borough; thence south by the eastern boundary thereof to the south-east angle of the said borough; thence west by the southern boundary of the said borough to the commencing point.

And the Honorable James Forrester Sullivan shall give the necessary directions herein accordingly.

**LEASES OF CERTAIN ALLOTMENTS OF LAND FORFEITED.**

WHEREAS by *The Amending Land Act 1865*, it is amongst other things enacted by sec. 15, that no person shall within any period of twelve months become the lessee, or sub-lessee, or assignee, either in his own name or in the name or names of any other person or persons of more than 640 acres of the lands proclaimed under that Act as therein mentioned, and no person shall become the lessee, or sub-lessee, or assignee of

any allotment who is an infant, or who is a married woman not having obtained a decree of judicial separation binding in Victoria, or who is not domiciled in Victoria, or who is in respect of the allotment for a lease of which he applies, or in respect of any part thereof, an agent or a servant of or a trustee for any other person, or who at the time of his application has entered into any agreement to permit any other person to acquire by purchase or otherwise the allotment in respect of which such application is made, or any part thereof, or the applicant's interest therein, and all land applied for under that Act shall be so applied for *bona fide* for the use and benefit of the applicant in his own proper person and not as the agent or servant or trustee of or for any other person; and allotments selected or purchased under the provisions thereinbefore contained shall be reckoned as part of the 640 acres thereinbefore mentioned. And it is by the said Act provided that if any person shall in violation of any of the provisions of that section become the lessee, or assignee, or sub-lessee of an allotment, the Governor in Council may declare the lease of such allotment to be forfeited, and upon publication in the *Government Gazette* of notice of such declaration the term created by the said lease shall cease and determine, and the right, title, and interest of the lessee and of every assignee and sub-lessee in and to such lease, and all moneys paid for rent in respect of such allotment shall be absolutely forfeited, and the allotment may be sold in fee simple or leased again in manner in the said Act provided: And whereas the leases mentioned in the first column of the schedule hereto of the allotments therein comprised and thereby demised, being land proclaimed under the provisions of the said Act, were granted at the time in manner and to the lessees therein mentioned: And whereas the persons whose names are mentioned in the second column of the schedule hereto became the assignee and lessee respectively of the said allotments, comprised in and demised by the hereinbefore mentioned leases, in violation of the provisions to the contrary of the said hereinbefore recited section in manner and for the reasons mentioned in the third column of the schedule hereto: Now therefore His Excellency the Governor, by and with the advice of the Executive Council, in exercise and execution of the power or authority in that behalf given by the said hereinbefore mentioned Act, doth hereby declare that the said leases mentioned in the said first column of the schedule hereto of the allotments therein comprised and thereby demised are forfeited.
