### SPECIAL NOTICE TO HOLDERS OF ELECTORS' RIGHTS.

IT is hereby notified that holders of Electors' Rights, issued on or before the 1st day of September, 1865, must obtain renewed rights in lieu thereof, in order to have their names placed upon the General Lists to be made up on the 1st day of September next.

Neglect of this precaution will result in the omission of the names of the persons so neglecting from the new list to be made up as aforesaid.

Every renewed right will bear the same number and will be in the like form and tenor as that in lieu of which it is issued, and will be equally available for any election that may take place before the completion of the new roll in October next.

## THE TOWN OF TIMOR.

### PROCLAMATION

By His Excellency the Honorable SIR JOHN HENRY THOMAS MANNERS SUTTON, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over the Colony of Victoria, &c., &c., &c.

WHEREAS by the *Amending Land Act* 1865, it is amongst other things enacted that the Governor in Council may from time to time, before or after the proclamation of any agricultural area, proclaim as a road or as a town or village any portion or portions of such area not selected, purchased, or leased, and not exceeding, if proclaimed as a town or village, six hundred and forty acres of the lands comprised in such area, and the lands in such town or village shall be sold by auction in the manner provided for the sale by public auction of lands not reserved for proclamation in such areas: Now therefore I, the Governor of Victoria, with the advice of the Executive Council, do hereby proclaim the land hereinafter described as a town under the designation prefixed thereto, that is to say:—

THE TOWN OF TIMOR.—Six hundred and forty acres, county of Talbot and county unnamed, parish of Bet-bet: Commencing at the south-east angle of allotment 15 of section 7A; bounded thence by the south boundary of that section and a line bearing west eighty chains; thence by lines bearing south eighty chains, east eighty chains, and north eighty chains to the point of commencement.—(66.N.10208.)

## PROCLAMATION

By His Excellency the Honorable SIR JOHN HENRY THOMAS MANNERS SUTTON, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over the Colony of Victoria, &c., &c., &c.

WHEREAS by *The Land Act 1862* it is amongst other things enacted that when any Crown land remains unsold in or within five miles of any municipal district, or upon or within five miles of any gold field, or in or within five miles of any town not contained in any municipal district, the Governor in Council may proclaim such land to be a municipal common, or a gold fields common, or a town common respectively, as the case may be: And whereas by *The Amending Land Act 1865* it is amongst other things enacted that when any Crown land remains unsold within any agricultural area of which at least one-fourth part has been selected under *The Land Act 1862*, or selected or leased under the now reciting Act, the Governor in Council may proclaim such land a farmers' common; when one-eighth part of any agricultural area has been selected under *The Land Act 1862*, or selected or leased under the now reciting Act, the Governor in Council may proclaim any unselected and unleased portion of such agricultural area, not exceeding twice the quantity so selected and leased, to be a temporary common for the use of such selectors and lessees: Now therefore I, the Governor of Victoria, with the advice of the Executive Council, do hereby proclaim the areas hereinafter mentioned to be Commons in accordance with the provisions of the above-recited Acts, that is to say:—

DARRAWAIT-GUIM TOWN COMMON.—Allotment 68 in the parish of Wallan-wallan, containing an area of 402 acres 3 roods 18 perches, is hereby proclaimed a Town Common for the use of all householders of the township of Darrawait-Guim.—(66.M.9507.)

MOORMURUG TEMPORARY COMMON.—The reserve lying between allotments 81 and 198 in the parish of Bairnsdale, and containing an area of 19 acres 2 roods 23 perches, is hereby proclaimed a Temporary Common for the use of selectors and lessees in the agricultural area of Moormurug.—(65.K.11371.)

**ADDITIONAL LIGHT AT THE ENTRANCE TO GEELONG HARBOR; ALSO NOTICE OF ALTERATIONS IN BUOYS AND BEACONS, PORT PHILLIP BAY.**

1. Notice is hereby given that the beacon on the north end of Symond's Spit has been washed away; another beacon will be placed on the same spit in a few days.

FRANKSTON JETTY.

2. The jetty at Frankston having now been extended into twelve feet water, the moorings and buoy have been removed.

BUOYS.—WEST CHANNEL.

3. As several vessels have of late got foul of, and done serious damage to, the Swan Bay and No. 12 Elbow buoys, it has been found necessary to shift the former close in shore. Masters of vessels and others navigating this channel are hereby informed, that the ascertained depth of the water, in a straight line from buoy to buoy, on both sides of the West Channel does not exceed sixteen feet.

LIGHT AT THE ENTRANCE OF THE GEELONG HARBOR.

4. With the view of facilitating the navigation of the channel into Geelong Harbor at night, a red light will, on and after the twenty-fourth day of next month, be exhibited from sunset to sunrise from a lantern placed on the first red dolphin, inshore of the light-ship.

**GEELONG HARBOR BUOYS.—REMOVAL OF THE LADY PEEL BLACK BUOY.**

5. This buoy having ceased to be of service has been removed.

SOUTH-EAST BLACK BUOY.

6. This buoy which was placed on the north-west end of sand off Bird Rock has been removed, it being no longer required.

## VOLUNTEER FORCE.

THE Governor, with the advice of the Executive Council, has approved of the accompanying Regulations, supplementary to Regulation No. 61, issued under *The Volunteer Statute of 1865* (28 Vict. No. 266):—

1. The Officer commanding the Volunteer Force is authorised to fix the rate of pay of non-commissioned officers appointed under clause 61 of the Regulations issued under *The Volunteer Statute 1865*, serving on yearly pay, provided such pay does not exceed the sums voted for them by Parliament, and to pay and classify those serving on daily wages according to the following scale, viz.:—

Non-commissioned officers of the first class not to exceed Eleven shillings (11s.) per diem.

Non-commissioned officers of the second class not to exceed Ten shillings (10s.) per diem.

Non-commissioned officers of the third class not to exceed Nine shillings (9s.) per diem.

Non-commissioned officers of the fourth class not to exceed Seven shillings (7s.) per diem.

Non-commissioned officers will be promoted or reduced from one class to another, by the officer commanding the force, at his discretion.

2. Persons serving in the Department, to whom it may not be desirable to give the rank of non-commissioned officers, such as artificers in the Military Store Department, may be classified as having the relative rank of non-commissioned officers of the first, second, third, or fourth class, and be paid accordingly.

3. Allowances to volunteer officers, in lieu of forage, and for travelling expenses, will be apportioned by the Colonel Commandant, at his discretion.

**REMOVING SEA-WEED AND SHELLS FOR MANURE.**

THE Governor in Council, on the 20th day of August, 1866, made the following additional Regulations relating to the issue of Licenses under *The Land Act 1862*, and under *The Amending Land Act 1865*, for obtaining and removing from Port Phillip Beach, beyond a distance of six (6) miles from Melbourne, and three (3) miles from Geelong, shells and sea-weed for use as manure only, viz. :—

1. The fee for every license for obtaining shells and sea-weed for manure only, shall be One (£1) per annum, payable in advance.
2. Only one carter shall be employed, and only one cart shall be used under any such license; and every carter when engaged in obtaining and removing sea-weed and shells shall exhibit the license taken out for that purpose, whenever required so to do by any Crown Lands bailiff or police constable.
3. The sea-weed and shells obtained under any such annual license must be used exclusively for manuring the land of the licensee or of his employer, neither of whom shall dispose thereof to any other person.

Tenderers are requested to describe by their numbers, as below, the mail services for which they tender, and every tender will be taken to include the entire service as called for.

Every tender must bear the *bond fide* signatures and addresses of the tenderer, and of two responsible persons willing to become bound for the fulfilment of the same in such sum as the Government may direct, not exceeding the gross amount of the contract.

Every tender must be accompanied by a bank deposit-receipt for a sum equal to twenty per cent. of the amount for which the tenderer is willing to undertake the service; the money to be lodged to the credit of the Deputy Postmaster General, and to be absolutely forfeited to the Government in case the person whose tender may be accepted shall fail to complete, within ten days of the date of notice being given of the acceptance of his tender, the usual bond and contract to the satisfaction of the Government. The notice of acceptance, if delivered at the address named in the tender, shall be deemed sufficient.

The money deposited by unsuccessful tenderers will be returned to them on application, and on their signing receipts for the respective amounts, but not otherwise.

Persons tendering are requested to state the description of the vehicle they intend to use, and the number of horses by which it is to be drawn.
