COMMONS IN AGRICULTURAL AREAS.

PROCLAMATION

By His Excellency the Honorable SIR JOHN HENRY THOMAS MANNERS SUTTON, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over the Colony of Victoria, &c., &c., &c.

WHEREAS by *The Amending Land Act 1865* it is amongst other things enacted that when any Crown land remains unsold within any agricultural area of which at least one-fourth part has been selected under *The Land Act 1862*, or selected or leased under the now reciting Act, the Governor in Council may proclaim such land a farmers' common; when one-eighth part of any agricultural area has been selected under *The Land Act 1862*, or selected or leased under the now reciting Act, the Governor in Council may proclaim any unselected and unleased portion of such agricultural area, not exceeding twice the quantity so selected and leased, to be a temporary common for the use of such selectors and lessees; And it is also enacted that the Governor in Council may from time to time increase, diminish, alter, or abolish any common theretofore or thereafter to be proclaimed or reproclaimed, and may from time to time reprop-

claim the whole or any part of any such common for any of the purposes and subject to the provisions of *The Land Act 1862*, and the now reciting Act: Now therefore I, the Governor of Victoria, with the advice of the Executive Council, do hereby proclaim, abolish, or alter (as the case may be) the commons hereinafter mentioned, in accordance with the provisions of the above-recited Act, that is to say:—

CALLAWADDA AGRICULTURAL AREA COMMON.—The temporary common for the use of selectors and lessees in the agricultural area of Callawadda, described in a Proclamation bearing date the 30th day of July, 1866, is hereby abolished, and in lieu thereof the allotments of land hereinafter enumerated, and comprising an area of 3786 acres 1 rood 4 perches, are hereby proclaimed a Farmers' Common for the use of the selectors and lessees in the aforesaid agricultural area, viz.:—Allotments 124, 125, 126, 127, 128, 129, 130, 131, 132, 133, 134, 135, 136, 137, 138, 139, 140, 141, 142, 143, 144, 145, 146, 147, 148, 149, 150, 151, 152, 153, 154, 155, 156, 157, 158, 159, 160, and 161, all in the parish of Callawadda.—(66.M.17236)

YALLA-Y-POORA AGRICULTURAL AREA COMMON.—The allotments of land hereinafter enumerated, and comprising an area of 371 acres 3 roods and 9 perches, are hereby proclaimed a temporary common for the use of selectors and lessees in the agricultural area of Yalla-y-Poora, viz. allotments 252, 253, and 254 in the parish of Ballyrogan.—(67.P.820)

PROCLAMATION

By His Excellency the Honorable SIR JOHN HENRY THOMAS MANNERS SUTTON, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over the Colony of Victoria, &c., &c., &c.

WHEREAS by *The Land Act 1862* it is amongst other things enacted, that when any Crown land remains unsold in or within five miles of any municipal district, or upon or within five miles of any gold field, or in or within five miles of any town not contained in any municipal district, or within any agricultural area of which at least one-fourth part has been selected, the Governor in Council may proclaim such land to be a municipal common, or a gold-fields common, or a town common, or a farmers' common respectively, as the case may be: And whereas by *The Amending Land Act 1865* it is amongst other things enacted, that the Governor in Council may from time to time increase, diminish, alter or abolish any common theretofore or thereafter to be proclaimed or reproclaimed, and may from time to time repropclaim the whole or any part of any such common for any of the purposes and subject to the provisions of *The Land Act 1862* and the now reciting Act: Now therefore I, the Governor of Victoria, with the advice of the Executive Council, do hereby proclaim, increase, or alter (as the case may be), the commons hereinafter mentioned in accordance with the provisions of the above-recited Acts, that is to say:—

BEAUFORT TOWN COMMON.—The unappropriated Crown lands situated within the boundaries of the township of Beau-

fort are hereby proclaimed a Town Common for the use of all householders of that township. Area, 270 acres, more or less.—(67.0.573.)

BUNINYONG FARMERS' COMMON.—The Buninyong Farmers' Common, described in a Proclamation bearing date the 25th day of February, 1861, is hereby increased by adding thereto 275 acres, more or less, being the unappropriated Crown lands within the boundaries described as follow, viz.: Commencing at the south-west angle of the existing common, the said angle being a point on the left bank of the River Leigh; thence by the south boundary of that common, bearing east one hundred and forty chains, more or less, to the west boundary of the Buninyong near Clarendon Farmers' Common; thence by the said boundary of that common, bearing south thirty-five chains, more or less, to the south-west angle thereof; thence by a line bearing west ninety-two chains, more or less, to the aforesaid river; and thence by that river, bearing north-westerly, to the point of commencement.—(66.M.17760.)

CHEPSTOW TOWN COMMON.—The unappropriated Crown lands situate within the boundaries of the township of Chepstow, are hereby proclaimed a town common for the use of all householders of that township. Area, 620 acres, more or less.—(67.0.573.)

LINTON'S, BROWN'S, SPRINGDALLAH, HAPPY VALLEY, LUCKY WOMAN'S, AND ITALIAN GULLY GOLD-FIELD COMMON.—The boundaries of the land added to the Linton's, Brown's, Springdallah, Happy Valley, Lucky Woman's, and Italian Gully Gold-field Common, by a Proclamation bearing date the 16th April, 1866, are hereby altered so as to conform with the following description, viz.: Commencing at the north-east angle of the Italian Gully Gold-field Common, as proclaimed on the 11th March, 1861; thence by lines bearing respectively east sixty-three chains, south three miles, and south-westerly sixty-five chains, more or less, to the south-east angle of the Italian Gully Gold-field Common aforesaid; and thence by the east boundary thereof bearing north to the point of commencement.—(66.M.10497.)

WORKS ON MAIN ROADS.

THE Governor, with the advice of the Executive Council, in exercise of the power conferred by *The Local Government Act* 1863, has, by Orders severally made on the 4th day of February, 1867, directed that the undermentioned Shire Councils shall, within the times by the said respective Orders appointed, execute the works on Main Roads hereinafter named and described, as provided by the 230th section of the said Act, according to plans deposited with the Board of Land and Works, that is to say:—

The Council of the Shire of Ararat shall, within twelve months from the 4th of February aforesaid, drain, form and metal one mile and eighteen chains of the Ballarat to Ararat Main road.

The Council of the Shire of Glenelg shall, within twelve months from the 4th of February aforesaid, drain, form, and metal thirty-nine chains of the Main Digby to Casterton road.

The Council of the Shire of Glenelg shall, within twelve months from the 4th of February aforesaid, drain, form, and metal forty-two chains and fifty links of the Hamilton to Casterton Main road.
