## COMMONS IN AGRICULTURAL AREAS.

## PROCLAMATION

By His Excellency the Honorable SIR JOHN HENRY THOMAS MANNERS SUTTON, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over the Colony of Victoria, &c., &c., &c.

WHEREAS by *The Amending Land Act 1865* it is amongst other things enacted that when any Crown land remains unsold within any agricultural area of which at least one-fourth part has been selected under *The Land Act 1862*, or selected or leased under the now reciting Act, the Governor in Council may proclaim such land a farmers' common; when one-eighth part of any agricultural area has been selected under *The Land Act 1862*, or selected or leased under the now reciting Act, the Governor in Council may proclaim any unselected and unleased portion of such agricultural area, not exceeding twice the quantity so selected and leased, to be a temporary common for the use of such selectors and lessees; and it is also enacted that the Governor in Council may from time to time increase, diminish, alter, or abolish any common theretofore or thereafter to be proclaimed or reproclaimed, and may from time to time re-proclaim the whole or any part of any such common for any of the purposes and subject to the provisions of *The Land Act 1862*, and the now reciting Act: Now therefore I, the Governor of Victoria, with the advice of the Executive Council, do hereby increase or diminish (as the case may be) the commons hereinafter mentioned, in accordance with the provisions of the above-recited Act, that is to say:-

CALLAWADDA AGRICULTURAL AREA COMMON.—The Farmers' Common for the use of selectors and lessees in the agricultural area of Callawadda, described in a Proclamation bearing date the 4th day of February, 1867, is hereby diminished by deducting therefrom allotment 129, in the parish of Callawadda, containing 40 acres 24 perches.—(67.P.2272.)

HAINESFORD AGRICULTURAL AREA COMMON.—The temporary common for the use of selectors and lessees in the agricultural area of Hainesford, described in a Proclamation bearing date the 11th day of February, 1867, is hereby increased by adding thereto allotments 84a and 84b, in the parish of Vitevite, containing 191 acres 16 perches, subject to the condition that the said selectors and lessees shall, in proportion to the area held by each, compensate the lessee of the Borriyallock South Run for the well sunk on allotment 84a aforesaid; the amount of compensation to be ascertained by valuation.—(67.O.1052.)

## THE BEECHWORTH AND GIPPS LAND MINING DISTRICTS AND DIVISIONS THEREOF.

At the Executive Council Chamber, Melbourne, the twelfth day of March, 1867.

IN pursuance of the provisions contained in the forty-sixth section of *The Mining Statute 1865*, and by virtue of the authority thereby conferred, His Excellency the Governor, with the advice of the Executive Council, doth by this present Order alter the limits and boundaries of the Beechworth Mining District and the Omeo Division thereof, and also the limits and boundaries of the Gipps Land Mining District and the Kobana Division thereof, as defined respectively in Orders in Council severally made on the seventeenth day of December, 1866; and doth define the limits and boundaries of the said districts and of the said divisions thereof to be henceforth those hereinafter described, that is to say:-

THE BEECHWORTH MINING DISTRICT.—Commencing at the junction of the Goulburn River and River Murray; thence by the River Murray in a general direction south-easterly to its source in the Main Dividing Range at Forest Hill; thence by a line north-westerly to the peak forming the north-east termination of the Gibbo Range; thence by the Gibbo Range south-westerly about fifteen miles to Mount Gibbo; thence by a line south-westerly crossing the Mitta-mitta River to Mount Cooper; thence by the range dividing the head-waters of Wombat Creek and Snowy Creek southerly to Mount Wills; thence north-westerly by the Great Bogong Range to Mount Nelson; thence southerly by the Great Bogong Range to Mount Smyth on the Main Dividing Range; thence by the Main Dividing Range in a general direction south-westerly to its junction with the Great Dividing Range; thence by the Great Dividing Range north-westerly to the sources of the Jerusalem River; thence by that river northerly to its junction with the Goulburn River; and thence by the Goulburn River in a general direction north-westerly to its junction with the River Murray, the commencing point aforesaid.

**THE OMRO DIVISION OF THE BEECHWORTH MINING DISTRICT.**—Commencing at the junction of the River Mitta-mitta and the River Murray; thence south-easterly by the River Mitta-mitta to Sandy Creek; thence by a line east of the dividing range forming the eastern water-shed of said creek; thence southerly by the range forming the eastern water-shed of Sandy Creek, and by the range forming the western and south-western water-shed of the Mitta-mitta River to the Great Bogong Range; thence south-easterly by the Great Bogong Range to Mount Wills; thence northerly by the range dividing the head-waters of the Wombat Creek and Snowy Creek to Mount Cooper; thence by a line north-easterly crossing the Mitta-mitta River to Mount Gibbo; thence by the Gibbo Range north-easterly about fifteen miles to the peak forming its north-east termination; thence by a line south-easterly to Forest Hill at the sources of the River Murray; and thence by the River Murray in a general direction northerly and westerly to its junction with the River Mitta-mitta, the commencing point aforesaid.

**THE GIPPS LAND MINING DISTRICT.**—Commencing on the sea-coast at Cape Patterson; thence northerly by the eastern boundary of the county of Mornington to the township of Buneep; thence by the Main Gipps Land road easterly to the Main Dividing Range; thence by the Main Dividing Range in a general direction north-easterly to Mount Smyth; thence northerly by the Great Bogong Range to Mount Nelson; thence easterly by the Great Bogong Range to Mount Wills; thence northerly by the range dividing the head-waters of the Wombat Creek and Snowy Creek to Mount Cooper; thence by a line north-easterly crossing the Mitta-mitta River to Mount Gibbo; thence by the Gibbo Range north-easterly about fifteen miles to the peak forming its north-east termination; thence by a line south-easterly to Forest Hill, at the sources of the River Murray; thence by a line south-easterly to Cape Howe; and thence by the sea-coast in a general direction south-westerly to Cape Patterson, the commencing point aforesaid.

**THE KOHANA DIVISION OF THE GIPPS LAND MINING DISTRICT.**—Commencing on the sea-coast at Cape Howe; thence by the sea-coast in a general direction south-westerly to the entrance of the lakes; thence by the northern and western shores of Lake King to a point south of the south-eastern angle of the township of Sarsfield; thence westerly by the range forming the southern water-shed of the Mitchell River to a point about fifteen miles east of Mount Angus; thence by a line north-westerly to Mount Wellington; thence by a line north-westerly to Mount Shillinglaw on the Main Dividing Range; thence by the Main Dividing Range in a general direction north-easterly to Mount Smyth; thence northerly by the Great Bogong Range to Mount Nelson; thence easterly by the Great Bogong Range to Mount Wills; thence northerly by the range dividing the head-waters of the Wombat Creek and Snowy Creek to Mount Cooper; thence by a line north-easterly crossing the Mitta-mitta River to Mount Gibbo; thence by the Gibbo Range north-easterly about fifteen miles to the peak forming its north-east termination; thence by a line south-easterly to Forest Hill, at the sources of the River Murray; and thence by a line south-easterly to Cape Howe, the commencing point aforesaid.

And the Honorable John Macgregor, Her Majesty's Minister of Mines for Victoria, shall give the necessary directions herein accordingly.

And Mr. Walker will act as Mining Registrar for the area which is hereinafter described as follows, namely:—Commencing at a point on the sea-coast due south of the township of Seacombe; thence by a line northerly to the outlet of Lake Wellington; thence by the eastern and northern shores of Lake Wellington to the River Avon; thence by that river westerly five miles; thence by a line and the range dividing the waters of the rivers Avon and Perry northerly to a point on the range dividing the waters of the Valentia Creek and the River Perry due east of Mount Useful; thence by a line north-easterly to the junction of the Mitchell and Wentworth rivers; thence by a line due east to the range dividing the waters of the Wentworth River and Prospect Creek; thence northerly by that range passing over Notch Hill to Mount Baldhead; thence by a line easterly to the junction of Watts Creek and the Thomson River; thence by a line south-easterly to the junction of Murindate Creek and the Snowy River; thence southerly by that river to the sea-coast; and thence by the sea-coast south-westerly to a point due south of the township of Seacombe, the commencing point aforesaid.

###### Mr. CHARLES ROBERT GEOGHEGAN

will act as Mining Registrar for the area which is hereinafter described, namely:—Commencing at the township of Buneep; thence by the Main Gipps Land road easterly to the Main Dividing Range; thence by a line north-easterly to a point nine miles due south of the Baw-baw Mountains; thence by a line due north to a point due west of the township of Seaton; thence by a line due east to the township of Seaton; thence by a line easterly to the township of Stratford; thence by a line due east to a point on the range dividing the waters of the rivers Avon and Perry; thence by a line southerly to a point on the River Avon five miles from its mouth; thence by the northern and eastern shores of Lake Wellington to its outlet; thence by a line southerly to a point on the sea-coast due south of the township of Seacombe; thence by the sea-coast in a general direction south-westerly to Cape Patterson; and thence northerly by the eastern boundary of the county of Mornington to the township of Buneep, the commencing point aforesaid.

###### Mr. JOHN SAMUEL PATTERSON

will act as Mining Registrar for the area hereinafter described as follows, namely:—Commencing at the township of Buneep; thence by a line bearing north sixty degrees west to a point on the Main Dividing Range; thence by the Main Dividing Range northerly to a point due west of Mount Useful; thence by a line due east to a point on the western bank of the Aberfeldy River; thence by the Aberfeldy River to its junction with Donnelly's Creek; thence by a line easterly to a point on the range dividing the waters of the Thomson and McAllister rivers due east of the head of Stringer's Creek; thence southerly by that range to the township of Seaton; thence by a line due west to a point due south of the Baw-baw Mountains; and thence by a line due north to the Baw-baw Mountains, the commencing point aforesaid.

###### Mr. JAMES TRAVIS

waters of the Wonnangatta and McAllister rivers in a north-westerly direction, passing over Mount Tamboritha to Mount Shillinglaw, on the Main Dividing Range; thence by the Main Dividing Range in a general direction north-easterly to the sources of the Mitta-mitta river south of Mount Parslow; thence by a line southerly to Mount Baldhead; thence southerly by the range dividing the waters of the Wentworth River, Nicholson River, and Prospect Creek, passing over Notch Hill to a point due east of the junction of the Wentworth and Mitchell rivers; thence by a line due west to the junction of the Wentworth and Mitchell rivers; and thence by a line south-westerly to a point on the range dividing the waters of the Mitchell River and the River Avon, the commencing point aforesaid.

**MR. ROBERT HOLDEN STONE**

will act as Mining Surveyor as well for the Buckland Division of the Mining District of Beechworth as for the area which is hereinafter described as follows, namely:—Commencing at Mount Smyth, on the Main Dividing Range; thence by the Main Dividing Range in a general direction north-easterly to Forest Hill at the sources of the River Murray; thence by a line north-westerly to the peak forming the north-east termination of the Gibbo Range; thence by the Gibbo Range south-westerly about fifteen miles to Mount Gibbo; thence by a line south-westerly crossing the Mitta-mitta River to Mount Cooper; thence by the range separating the head-waters of the Wombat Creek and Snowy Creek southerly to Mount Wills; thence by the Great Bogong Range north-westerly to Mount Nelson; and thence by the Great Bogong Range southerly to Mount Smyth, the commencing point aforesaid.
