## AN ELECTORAL ROLL DECLARED VALID.

**W**HEREAS by *The Electoral Act 1865* it is amongst other things enacted that where any accidental or unavoidable impediment, misfeasance, or omission shall have happened in the preparation or transmission or printing of any general roll or supplementary roll or ordinary electoral roll or roll of rate-paying electors, the Governor in Council may take all such measures as may be necessary for removing such impediment or rectifying such misfeasance or omission, or may declare any such roll valid as to and notwithstanding such impediment, misfeasance, or omission; and every such Order in Council shall state specifically the nature of the impediment, misfeasance, or omission, and shall be forthwith published in the *Government Gazette*; And whereas the Supplementary Roll for the Gordon division of the Electoral District of Grenville was revised by the Bench at Buninyong instead of by that at Gordon: Now therefore His Excellency the Governor, with the advice of the Executive Council, doth by this present Order, in pursuance of the 68th section of the said Act, declare valid the said Supplementary Roll for the Gordon division of the Electoral District of Grenville, so revised as aforesaid.

And the Honorable James McCulloch, Her Majesty's Chief Secretary for Victoria, shall give the necessary directions herein accordingly.

## ATTEMPTS TO BURN O'CONNOR'S BOARDING-HOUSE AT BALLARAT.

ONE HUNDRED POUNDS REWARD.

**W**HEREAS about Four o'clock in the morning of Wednesday, the 17th of April last, a fire occurred in the dining-room of the boarding-house kept by Owen O'Connor, Nos. 33 and 34, Lydiard street, Ballarat, but was readily subdued without serious damage: And whereas about an hour subsequently another fire broke out on another part of the same building, but was readily extinguished: And whereas at Half-past Eleven o'clock on the night of Tuesday, the 23rd of April aforesaid, another fire occurred in a bedroom on the same premises: And whereas at inquests held to investigate the origin of the said fires, verdicts were returned of wilful incendiarism against some person or persons unknown: And whereas the Victoria Fire and Marine Insurance Company (at whose office the said premises were insured) have by their agent offered a Reward of Fifty pounds for information issuing in the conviction of the person or persons guilty of the attempts to burn the above-mentioned premises: Notice is hereby given that a Reward of Fifty pounds (supplemental to that offered by the Insurance Company) will be paid by the Government for such information as will lead to the conviction of the person or persons guilty of the said three attempts to burn the said premises.

## CONTROL OF CERTAIN RESERVED LANDS.

## SCHEDULE NO. 2.—THE PARTICULARS OF AUTHORITY TO BE EXERCISED BY THE TRUSTEES OF THE RESERVES SPECIFIED IN SCHEDULE NO. 1 HEREWITH.

1. The Trustees of the reserve specified in the annexed Schedule No. 1 are authorized to expend, in such manner as they may deem most conducive to the improvement of the reserves, such money as may be from time to time allotted to them for that purpose.

2. To sell dead wood and unsightly live trees thereon, and use proceeds of such sale in the planting on the reserves of non-indigenous trees of good kinds.

3. To frame rules (subject to subsequent confirmation by Board of Land and Works under its seal) for regulating admission of the public into these reserves, and for protection of indigenous and non-indigenous trees therein.
