UNITED COMMON.

PROCLAMATION

By His Excellency the Honorable SIR JOHN HENRY THOMAS MANNERS SUTTON, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over the Colony of Victoria, &c., &c., &c.

WHEREAS by *The Land Act 1862* it is amongst other things enacted, that where there are two or more neighboring commons the Governor in Council may proclaim that the same shall be a common under the name of "The United Town and Gold-field [or, as the case may be] Common of" for the benefit of all persons entitled to commonage on either: Now therefore I, the Governor of Victoria, with the advice of the Executive Council, do hereby proclaim the neighboring commons hereinafter mentioned to be a United Common, under the name prefixed thereto, that is to say:—

GLENGRANT AND TARNAGULLA UNITED FARMERS' COMMON.—The Marong Farmers' Common, described in a Proclamation bearing date the 4th day of March, 1861; the Woodstock and Tarnagulla Farmers' Common, described in a Proclamation bearing date the 4th day of March, 1861, and increased by two several Proclamations bearing date respectively the 20th day of July, 1863, and the 1st day of October, 1866; the United Farmers' Common of Lockwood, Ravenswood, Shelbourne, and Bradford, described in a Proclamation bearing date the 15th day of September, 1862; the Farmers' Common for the use of selectors and lessees in the agricultural area of Tarnagulla, and the Farmers' Common for the use of selectors and lessees in the agricultural area of Glengrant, respectively described in a Proclamation bearing date the 17th day of June, 1867, are hereby united and proclaimed under the name of the Glengrant and Tarnagulla United Farmers' Common, and the said United Common shall be for the benefit of all persons entitled to commonage on any of the above-mentioned commons —(67.P.9091.)

MOYHU AGRICULTURAL AREA COMMON.

PROCLAMATION

By His Excellency the Honorable SIR JOHN HENRY THOMAS MANNERS SUTTON, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over the Colony of Victoria, &c., &c., &c.

WHEREAS by *The Amending Land Act 1865* it is amongst other things enacted, that when any Crown land remains unsold within any agricultural area of which at least one-fourth part has been selected under *The Land Act 1862*, or selected or leased under the now reciting Act, the Governor in Council may proclaim such land a farmers' common; when one-eighth part of any agricultural area has been selected under *The Land Act 1862*, or selected or leased under the now reciting Act, the Governor in Council may proclaim any unselected and unleased portion of such agricultural area, not exceeding twice the quantity so selected and leased, to be a temporary common for

the use of such selectors and lessees; Now therefore I, the Governor of Victoria, with the advice of the Executive Council, do hereby proclaim the farmers' common hereinafter mentioned, in accordance with the provisions of the above-recited Act, that is to say:—

MOYHU AGRICULTURAL AREA COMMON.—The portion of land comprised within the boundaries hereinafter described, together with the allotments of land hereinafter enumerated, shall be and constitute a farmers' common for the use of selectors and lessees in the agricultural area of Moyhu, viz.: Commencing at the north-west angle of allotment 1 of section 15, in the parish of Moyhu, the said angle being a point on the King River; bounded thence by that allotment bearing east ninety-five chains, more or less, to the north-west angle of section 10; thence by the west boundary of section 9, bearing north seventy-nine chains fifty links, to the north-west angle of allotment 1 of that section; thence by a road bearing west forty-three chains, more or less, to the aforesaid river; thence by that river bearing northerly to the junction therewith of a branch thereof, the said branch forming part of the eastern boundary of allotment 2 of section 20; thence by that branch and part of the eastern boundary of allotment 2 of section 21, bearing southerly to an ana-branch of the aforesaid river; thence by that ana-branch bearing southerly to its junction with the aforesaid river; and thence by that river bearing southerly to the point of commencement; as shown on the plan deposited at the Crown Lands Office, Melbourne.

Sections 1 and 2; allotments 1, 3, 4, 5 and 6 of section 3; allotments 1, 1a, 2a, 3 and 4 of section 4; allotments 1, 2, 2a, 3, and 3a of section 5; allotment 3a of section 6; sections 8 and 9; and allotments 6 and 7 of section 10; all in the parish of Moyhu. Area of common 5,800 acres, more or less, as shown on the plan deposited at the Crown Lands Office, Melbourne.—(67.P.8747.)

SUPPOSED MURDER OF JAMES WARNER, ALIAS BRASSEY, AT FRANKLINFORD.

TWO HUNDRED POUNDS REWARD.—FREE PARDON TO AN ACCOMPLICE.

WHEREAS James Warner, alias Brassey, who is described below, has been missing since the morning of Sunday, the 16th of June last, under suspicious circumstances, from the neighborhood of Franklinton, in the Castlemaine district: And whereas he is ascertained to have spent the night preceding his disappearance drinking in the house of one Minogue, at Franklinton: And whereas in a previous notice, dated the 3rd instant, a Reward of Twenty-five pounds was offered for the discovery of his remains, if deceased: And whereas there is a strong probability of his having been murdered: Notice is hereby given that a Reward of Two hundred pounds will be paid by the Government for such information as will lead to the conviction of the person or persons guilty of murdering the said James Warner, alias Brassey.

The Governor will also, in the name and on behalf of Her Majesty, grant a Free Pardon to any person implicated in this supposed murder (not being the actual murderer) who will give the required information.

James Warner, alias Brassey, English, probably from Staffordshire, aged 50, five feet nine inches in height, stout, and robust-built, dark-brown hair and whiskers, the latter all round the chin, blue eyes, straight nose, long full face, rather good looking, slightly stooping gait, a pugilist, and known as such about Ballarat: He wore an old torn and dirty Crimean shirt over Scotch twilled shirt, old moleskin trousers, old slouched drab billycock hat, and Blucher boots.

From 9 o'clock in the morning of the 16th June last, until the 23th of the same month, the dog of the missing man remained about Minogue's premises howling, and is supposed to have been killed.

Tenderers are requested to describe by their numbers, as below, the mail services for which they tender, and every tender will be taken to include the entire service as called for.

Every tender must bear the *bond fide* signatures and addresses of the tenderer, and of two responsible persons willing to become bound for the fulfilment of the same in such sum as the Government may direct, not exceeding the gross amount of the contract.

Every tender must be accompanied by a bank deposit-receipt for a sum equal to twenty per cent. of the amount for which the tenderer is willing to undertake the service; the money to be lodged to the credit of the Deputy Postmaster-General, and to be absolutely forfeited to the Government in case the person whose tender may be accepted shall fail to complete, within ten days of the date of notice being given of the acceptance of his tender, the usual bond and contract to the satisfaction of the Government. The notice of acceptance, if delivered at the address named in the tender, shall be deemed sufficient.

The money deposited by unsuccessful tenderers will be returned to them on application, and on their signing receipts for the respective amounts, but not otherwise.

Persons tendering are requested to state the description of the vehicle they intend to use, and the number of horses by which it is to be drawn.




