NAVIGATION OF TORRES STRAITS.

The information in this Notice is to be carefully considered, to be noted in the Sailing Directions, and compared with the chart when the ship is navigating the parts to which it refers.

NOTICE 2.

THE following additional information, having reference to the navigation of the Inner route to Torres Strait, and corrections for the charts of the east coast of Australia, has been received from Commander George S. Nares, of H.M.S. *Salamander*, 1867:—

SHEET XVI.—MAGNETIC ISLAND TO DOUBLE POINT.

The Zebra Shoal, and the shoals marked "E.D." (or existence doubtful), and "P.D." (or position doubtful), in its neighbourhood, have been carefully looked for in fine clear weather without success.

The discolored water, which is very prevalent in this part of the Inner route, has been, it is believed, frequently mistaken for reefs.

Northward of Brooke islands a current sets to the northward with varying strength, dependent on that of the S.E. trade wind.

Southward of the islands the tides are regular, the flood setting to the southward.

SHEET XVII.—DOUBLE POINT TO CAPE TRIBULATION.

A vessel coming from the N.W. in misty weather, which is very prevalent on the whole of the coast, is liable to mistake the point west of Cape Grafton for the real cape.

This point is therefore now named False Cape, and the hill, 1,371 feet high, immediately S.W. of Cape Grafton peak, Grant hill.

The Trepang fishers frequenting this part of the coast have lately reported a harbour a few miles northward of Double point, but it was not examined by Commander Nares. Commander Simpson, R.N., who assisted in the survey of this coast, in H.M.S. *Rattlesnake*, states that there was only one fathom water on the bar.

The current running to the northward towards Green island reef and the Trinity opening is very dangerous, and requires to be guarded against in misty weather or at night. Green island and the vegetated sand-bank N.W. of it are good marks by day.

SHEET XVIII.—CAPE TRIBULATION TO CAPE FLATTERY.

The peak of Monkhouse point open eastward of Mount Cook leads clear of C. and D. reefs.

The *Salamander* frequently passed close to the shoal marked "P.D. 1855," between E. and Turtle reefs, and the shoal marked "E.D." east of Conical rock, both the commander and navigating officer being at the masthead, without any appearance of a reef being seen.

SHEET XIX.—CAPE FLATTERY TO CAPE SIDMOUTH.

Vessels proceeding by the route between No. 1 reef (dry) and Lookout point, should, in order to clear the shoal north of Cape Flattery and the foul ground south of No. 1 reef, keep Capes Bedford and Flattery in one until High rock is seen between South Direction island and Rocky islets (wooded); then steer west until the Two isles (low and wooded) touch Cape Flattery; then N.W. for Lookout point, passing about a mile from the point, or midway between the point and sand-bank.

No. 54.—MAY 5, 1868.—1.

Round hill kept on with "End of Range" westward of it clears the shoal ground on the north side of Lookout point: when Lookout peak is seen between the two peaks of Cape Flattery, keep it so, and this mark will lead up to the Howick group.

There appears to be a good channel between No. 1 sand-bank and No. II. reef (covered), but it requires to be examined. No. II. reef, which formerly appeared on the charts, does not exist.

The sand-bank on No. 1 reef shifts; it usually shows well above water, but it may occasionally be covered at high tide.

All the sand-banks on the reefs in the Inner route that are not vegetated are liable to shift; therefore complete dependence cannot be placed on them as sea marks. They are sometimes seen well above high-water, and on again passing in a month's time, the sand having been distributed over the reef, the bank is scarcely seen, even at low water.

The sand-patch on the coast inside Lookout point is not readily distinguished from a number of similar ones, except when seen from the northward.

The neighbourhood of the Megera rock, whose exact position is doubtful, and the shoal marked "E.D." south of L. reef, has not been examined.

The rock reported off Barrow point has been searched for without success. Commander Nares believes in its existence, having confidence in the judgment of Captain Edwards, of the ship *Woodlark*, who reported it.

The high rock between Cape Melville and the Channel rock is now named the Boulder rock. It is about 30 feet high, and should not be mistaken by strangers for the Channel rocks north of it.

A special look-out was kept for a newly reported rock between Clack island and Cape Flinders, whilst passing the locality at low-water spring tides on a fine day. Three patches of discolored water were seen S.W. of Clack reef, looking so like reefs that a boat was sent to examine the neighbourhood, but no shallow water could be found.

The *Salamander* has so frequently passed close to the spot indicated, that Commander Nares considers the reef does not exist.

The night course from Cape Flinders round Princess Charlotte bay requires revision. Instead of turning abruptly N.W. $\frac{1}{2}$ N., as given in the chart, it is recommended to keep in 7 fathoms water, altering course as requisite, and the lead will guide the ship directly towards No. 1 islet—low and wooded. This track has been tried several times by the *Salamander*, and never found to fail.

The sets of the tide in the northern part of Princess Charlotte bay are irregular, and require care. Near the Claremont group the flood tide sets south, ebb to the N.E.

The shoal mentioned in the Australia Directory, Vol. II., page 187, and said to have been seen W. by S. $\frac{1}{2}$ S. $\frac{3}{4}$ miles from N. sand-bank, was not seen from the *Salamander*.

SHEET XX.—CAPE SIDMOUTH TO CAPE GRENVILLE.

The shoal marked "E.D." between the Dugdale and U. reef, was not seen from the *Salamander*, but a patch of reef extends north from the sand-banks on U. reef, or else the sand has shifted further south.

The beacon on Y. reef was standing when the *Salamander* passed it in July, 1867. The sand on the reef only shows at low water.

Mr. Bowman of the brig *Caroline* reports a rock on the following bearings:—Restoration island, W. $\frac{1}{2}$ N., and Sandy isle, N. by W.

A single low mangrove bush marks the south-east extreme of the Piper islands reef, and is a good mark on entering the passage, except at high-water spring tides, when it must be covered.

Allowance should be made for a strong current setting N.W. towards the Home islands. A sailing vessel should keep well to windward after passing M. reef.

SHEET XXI.—CAPE GREENVILLE TO BOOBY ISLAND.

Commander Nares recommends that the track north of Cockburn reef should be continued to the eastward of the $\frac{1}{2}$ reef, the vegetated sand-bank on the north-west end of which is a good mark.

The north extreme of the Cockburn reef is very badly defined as seen from the deck or aloft, and therefore extremely dangerous. The wreck of the *Sir A. Campbell* has long disappeared. Another wreck is on the reef 2 miles further south; strangers might easily mistake this for the one marked on the chart, and haul up too soon.

As this new wreck will soon be broken up, it is recommended that it should not be marked on the chart, and that the wreck of the *Sir A. Campbell* be expunged.

There is foul ground close to the north-west end of Z reef. The two sand-banks in latitude $10^{\circ} 57' S.$, longitude $143^{\circ} 9' E.$, have a clear passage of $1\frac{1}{2}$ miles between them; but there appear to be some inaccuracies in the chart in this neighbourhood. The sand-bank marked in the chart about 2 miles east of them is placed too far west; it has two small sand-banks to the northward of it, but their positions were not determined.

The Outer barrier reef between the Olinda and Pandora entrances are inaccurately delineated on the chart. There is no continuous reef between the two entrances, but a number of detached patches overlapping each other, which at a short distance at sea would appear continuous.

There is apparently deep water over the projecting reef in latitude $11^{\circ} 20' S.$ and longitude $142^{\circ} 4' E.$; but the tide race was very heavy on it as the *Salomander* passed to leeward.

The Pandora entrance is well defined and easily found, as the continuous reef from the southward ends abruptly at a vegetated sand-bank. The instructions in the sailing directions for entering cannot be improved.

The Olinda entrance is the northernmost opening in the Barrier reefs near Raine island passage; it is well marked by the continuous reef north of it, but this entrance cannot be recommended unless ships are very far to leeward. In entering, the reefs on the north side of the entrance should be kept close on board on the starboard hand; with a good look-out from the mast-head a ship can safely enter any time before noon, after which the sun will be too far ahead. The sand-bank five miles north of Raine island is on a detached reef, with a passage on each side of it, but coral mushroom heads are numerous in the neighbourhood.

The line of heavy breakers marked on the chart north of Raine island are reefs; the *Salomander* passed close to leeward of them.

The light in the Great detached reef has good anchorage in 8 fathoms water, but the coral mushroom heads are numerous and require special care to avoid them. There are a greater number of patches and mushroom heads on the west edge of this reef, bordering the 103-fathom line of soundings than are marked on the charts.

The Middle bank—Blackwood channel—are a collection of small patches, with apparently deep-water channels between them.

The two easternmost sand-banks are small, and are covered at half-tide. The westernmost bank is the largest; the 3-fathom patch S.W. of this sand-bank has deep water round it, and is dangerous, being near the line of route. Shallow water was seen half-way between this patch and the Tynemouth rock, which latter is correctly placed.

A patch of discoloured water, apparently a reef, was passed, bearing N.E. $\frac{1}{2}$ N. from the North Hardy island.

The sand-banks on the east extreme of Cockburn reef were dry at low water neaps. The shoal patches to the northward were indistinctly seen.

On passing the north extreme of Cockburn reef it was observed from aloft to be very badly defined, and consequently indistinct; it is therefore a bad turning point.

A clear passage was found east of $\frac{1}{2}$ reef, the sand-bank at its north-west end being vegetated, is a good mark; but the passage requires further sounding. There is also apparently a clear passage south of $\frac{1}{2}$ reef and bank, between it and the smaller sand-bank. Special care is required in proceeding either from the Ashmore or Middle bank, until clear of the Cockburn reef. If a passage south of Sir Charles Hardy islands were found to exist, which is probable, it would be most valuable.

Outer Barrier Reef.—The Raine island beacon being whitened by long exposure to the weather is very indistinct, and difficult to make out in hazy weather.

The Jardine river, in latitude $10^{\circ} 55' S.$, longitude $142^{\circ} 13' E.$, has at low tide fresh water close within the east side of the entrance, when boats can fill from alongside. There is good anchorage in 6 fathoms within 200 yards of the sand spit running off the east side of the entrance, with the end of the spit bearing from South to S.W. Mootee headland, about 200 feet high, being the west extreme of the high land which extends to the S.W. from Cape York, is very conspicuous. The entrance to the river is 23 miles west of the headland. There are no shoals south of a line from Barn island to the Jardine river; the coast may be safely approached, but between Mootee head and the river the 3-fathom line extends three-quarters of a mile from the shore. The sands inside the river shift with the tide, but there is no bar outside.*

The Jardine river rises on the east coast near Padding Pan hill. It is subject to heavy floods during the N.W. monsoon (December to March), but when visited in the S.E. monsoon in 1866 it had an average depth of four feet above the tidal influence. Boats can only enter at half-tide, as at low-water the sand washing down by the stream forms numerous shifting bars, with not more than one foot water on them, for 3 miles from the entrance.

WINDS AND WEATHER EXPERIENCED IN H.M. SHIP SALAMANDER DURING SEVEN VOYAGES IN THE INNER ROUTE BETWEEN SYDNEY AND CAPE YORK.

Between Sydney and Brisbane, within 30 miles of the coast, the winds are local, the belts extending north and south for about 100 miles.

The remarks at pages 233-4 of Vol. 2. Australia Directory, 1864, were found correct.

From latitude $25^{\circ} 30' S.$ to $21^{\circ} S.$, strong S.E. winds, with misty weather and a heavy sea, blow for a period of two or three weeks, and are followed by calms and light easterly winds, with very fine clear weather for about the same time. With the barometer above 30.00 inches, S.E. winds may be expected, and when it rises to 30.20 inches, a strong breeze will set in from the same quarter for some days, usually accompanied by a bank of clearly defined white lumpy clouds with a misty horizon.

From lat. $21^{\circ} S.$ to $18^{\circ} 30' S.$ is a finer region, with south-easterly and northerly winds alternating.

From lat. $18^{\circ} 30' S.$ to $10^{\circ} S.$ a strong S.E. trade generally blows, except from December to March, when the winds are sometimes light and variable, with rain squalls as Cape York is approached.

The N.W. monsoon does not blow with any strength on the east coast, south of Cape York; but continuous rain may be expected in the neighbourhood of the cape from the middle of December to the end of March. In that season there is less rain and stronger N.W. winds at Darnley island.

The remark that the current to the southward of Moreton bay sets to the northward in winter was not found to be correct.

A falling barometer, with dirty weather from the S.E., is the precursor of a circular storm travelling from the N.E. The wind commences at S.E. and will shift to the East and N.E., when the weather will clear up and be followed by a fine N.W. wind off the land. One of these storms was experienced in the neighbourhood of Port Denison on the 3rd and 4th March, 1867, doing much damage. Another storm passed north of Brisbane on 27th and 28th April, 1867, when the barometer fell from 29.90 in. to 29.80 in. in four hours, wind increasing from E.S.E., with very thick squally weather; it continued to fall for sixteen hours, when it was 29.27 in., blowing a very heavy gale from the eastward; the gale then shifted to north, and the barometer commenced rising; for sixteen hours it blew from the north in squalls, force 2 to 7, after which the gale passed off, leaving the barometer standing at about 29.70 in., with fine weather, and wind blowing from the N.W.

These latter observations were made whilst the ship was anchored under the lee of Morton island, Brisbane.

PROCLAMATION

By His Excellency the Honorable SIR JOHN HENRY THOMAS MANNERS SUTTON, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over the Colony of Victoria, &c., &c., &c.

WHEREAS by *The Land Act 1862* it is amongst other things enacted, that when any Crown land remains unsold in or within five miles of any municipal district, or upon or within five miles of any gold-field, or in or within five miles of any town not contained in any municipal district, or within any agricultural area of which at least one-fourth part has been selected, the Governor in Council may proclaim such land to be a municipal common, or a gold-fields common, or a town common, or a farmers' common respectively, as the case may be: And whereas by *The Amending Land Act 1865* it is amongst other things enacted, that the Governor in Council may from time to time increase, diminish, alter, or abolish any common theretofore or thereafter to be proclaimed or re-proclaimed, and may from time to time re-proclaim the whole or any part of any such common for any of the purposes and subject to the provisions of *The Land Act 1862* and the now reciting Act: Now therefore I, the Governor of Victoria, with the advice of the Executive Council, do hereby increase or proclaim (as the case may be) certain commons as hereinafter mentioned, in accordance with the provisions of the above-recited Acts, that is to say:—

MERTON TOWN COMMON.—County of Anglessey, parish of Merton, being allotments 1, 2, 7 A, 8, 23, 24, and 25, the piece of land lying between the aforesaid allotments 1 and 2, and all the unappropriated Crown lands within the town of Merton, comprising an area of one thousand two hundred acres, more or less shall be and constitute a Town Common for the use of all householders of that town.—(63.11.3909)

MORRISON'S GOLD-FIELD COMMON.—The Morrison's Gold, field Common described in a Proclamation bearing date the 5th day of January, 1864, is hereby increased by adding thereto the unappropriated Crown lands comprised within the boundaries hereinafter described, viz:—Commencing at the south-west angle of the land licensed under the 42nd section of *The Amending Land Act 1865*, in the parish of Borneo, to J. Chamberlain; thence by a road bearing N. 9° 43' W. three hundred and fifty chains; and thence by lines bearing respectively N. 80° 17' E. eighty chains, S. 9° 43' E. three hundred and fifty chains, and S. 80° 17' W. eighty chains to the point of com-

menement; as shown on the plan deposited at the Crown Lands Office, Melbourne. Area available for extension of commonage, 2540 acres.—(67.0.14257.)

PROCLAMATION

By His Excellency, the Honorable SIR JOHN HENRY THOMAS MANNERS SUTTON, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over the Colony of Victoria, &c., &c., &c.

WHEREAS by *The Amending Land Act 1865* it is amongst other things enacted, that when any Crown land remains unsold within any agricultural area of which at least one-fourth part has been selected under *The Land Act 1862*, or selected or leased under the now reciting Act, the Governor in Council may proclaim such land a farmers' common; when one-eighth part of any agricultural area has been selected under *The Land Act 1862*, or selected or leased under the now reciting Act, the Governor in Council may proclaim any unselected and unleased portion of such agricultural area, not exceeding twice the quantity so selected and leased, to be a temporary common for the use of such selectors and lessees: Now therefore I, the Governor of Victoria, with the advice of the Executive Council, do hereby proclaim a Temporary Common for the use of selectors and lessees in the agricultural area hereinafter mentioned, in accordance with the provisions of the above-recited Act, that is to say:—

BUNGANAIL TEMPORARY COMMON.—The allotments of land hereinafter named, comprising an area of two thousand three hundred and ninety acres, more or less, shall be and constitute a temporary common for the use of lessees and selectors in the Agricultural area of Bunganaill, viz: Parish of Bunganaill, allotments 5 A, 5 B, 6, 7, 8, 9, 20, 21, 22, 23, 23 A, 23 B, 32, 32 A, 32 B, 33, 33 A, 33 B, 33 C, 35, 35 A, 35 B, 39 A, 39 B, 47, and 48.—(67.P.14577.)

WHEREAS by *The Amending Land Act 1865* it is amongst other things enacted, that the Governor in Council may from time to time, before or after the proclamation of any agricultural area, proclaim as a road or as a town or village any portion or portions of such area not selected, purchased, or leased, and not exceeding, if proclaimed as a town or village, six hundred and forty acres of the lands comprised in such area; and the lands in such town or village shall be sold by auction in the manner provided for the sale by public auction of lands not reserved for proclamation in such area: Now therefore I, the Governor of Victoria, with the advice of the Executive Council, do hereby proclaim the land hereinafter described as a town, that is to say:—

TOWN OF TRENTHAM.—Four hundred and eighty acres, counties of Talbot and Dalhousie, parish of Trentham: Commencing at the north angle of section 6, in the town of Trentham; bounded thence by a line bearing north three chains to the north side of the road forming the south boundary of portion 23, in the parish of Trentham; and thence by lines bearing respectively west eighty chains, south sixty chains, east eighty chains, and north 57 chains, to the point of commencement.—(63.11.713)
