#### BANK HOLIDAYS AT DIVERS PLACES.

PROCLAMATION

By His Excellency The Most Honorable George Augustus Constantine, Marquis of Normanby, Earl of Mulgrave, Viscount Normanby, and Baron Mulgrave, of Mulgrave, all in the county of York, in the Peerage of the United Kingdom; and Baron Mulgrave of New Ross, in the County of Wexford, in the Peerage of Ireland; a Member of Her Majesty's Most Honorable Privy Council; Knight Grand Cross of the Most Distinguished Order of Saint Michael and St. George; Governor and Commander-in-Chief in and over the Colony of Victoria and its Dependencies, &c., &c.

In pursuance of the provisions contained in the fifth section of The Bank Holidays Act 1873, I, the Governor of Victoria, do by this my Proclamation appoint

WEDNESDAY THE 18TH OF FEBRUARY INSTANT a special day to be observed as a Bank Holiday at Geelong;

THURSDAY THE 19TH OF FEBRUARY INSTANT

to be observed as Bank Half-holidays at Ballan, Egerton, and Gordon, from the hour of Twelve noon.

### CERTAIN ROLLS OF RATEPAYING ELECTORS RECTIFIED.

At the Executive Council Chamber, Melbourne, the seventeenth day of February 1880. PRESENT:
His Excellency the Governor.

Sir Bryan O'Loghlen Mr. Patterson.

WHEREAS by The Electoral Act 1865 it was amongst other things enacted that where any accidental or unavoidable impediment, misfeasance, or omission should have happened in the preparation or transmission or printing of any general roll or supplementary roll or ordinary electoral roll or roll of ratepaying electors, the Governor in Council might take all such measures as might be necessary for removing such impediment or rectifying such misfeasance or omission, or might declare any such roll valid as to and notwithstanding such impediment, misfeasance, or omission: and every such Order in Council should state specifically the nature of the impediment, misfeasance, or omission; and should be forthwith published in the Government Gazette: Now therefore He Excellency the Governor, with the advice of the Executive Council, under and by virtue of the power in him vested by the section of the said Act, doth by this present order direct that the Rolls of Ratepaying Electors for the several divisions of the Districts named in the subjoined schedule be rectified by including therein the names of the Ratepaying Electors as set forth in the said schedule notwithstanding the accidental omission on the part of the Municipal Officers therein named to furnish the respective Electoral Registrars with Lists containing such names within the time fixed by The Electoral Act Amendment Act 1876 for that purpose, viz.: purpose, viz. :-

## ROLL OF RATEPAYING ELECTORS RECTIFIED.

At the Executive Council Chamber, Melbourne, the seventeenth day of February 1880. PRESENT:

WHEREAS by The Electoral Act 1865 it is amongst other things enacted that where any accidental or unavoidable impediment, misfeasance, or omission shall have happened in the preparation or transmission or printing of any general roll or supplementary roll; or ordinary electoral roll or roll of ratepaying electors, the Governor in Council may take all such measures as may be necessary, for removing such impediment or rectifying such misfeasance or omission, or may declare any such roll valid as to and notwithstanding such impediment, misfeasance, or omission, and every such Order in Council shall state specifically the nature of the impediment, misfeasance, or omission, and shall be forthwith published in the Government Gazette: And whereas the name of William C. Smith has been erroneously entered on the Roll of Ratepaying Electors for the Ballarat West Proper Division of the Electoral District of Ballarat West as William G. Smith (No. 2968): Now therefore His Excellency the Government with the advice of the Executive Council, under and by virtue of the power in him vested by the 68th section of the Act No. 279, doth hereby direct that the error in the Roll of Ratepaying Electors for the Ballarat West Proper Division of the Electoral District of Ballarat West aforesaid be rectified by substituting the name of William C. Smith for that of William G. Smith on the said Roll.

And the Honorable Graham Berry, Her Majesty's Chief Secretary for Victoria, shall give the necessary directions herein accordingly.
