LEGISLATIVE ASSEMBLY.

SANDRIDGE ELECTION.-PETITION.

HEREBY notify that there was presented to me, on Friday the 20th day of August instant, a Petition of which the following is a true copy.

To the Honorable the Speaker of the Legislative Assembly.

The Petition of John Winthrop Hackett, of 14 Temple Court, barrister-at-law,

RESPECTFULLY SHEWETH-

- 1. That on the fourteenth day of July last an election was held for a Member to serve in the Legislative Assembly for the district of Sandridge in the present Parliament.
- 2. That your Petitioner and John Madden, Doctor of Laws, were the sole candidates at the said election.
- 3. That the Returning Officer declared that the said John Madden had received the majority of votes at the said election, and returned the said John Madden as duly elected.
- 4. That the said John Madden was, by himself, his agents and partisans, guilty of bribery before, during, and after the said election, and that divers other persons, acting on his behalf, were similarly guilty.
- 5. That the said John Madden was, by himself, his agents and partisans, guilty of treating before, during, and after the said election; and that divers other persons, acting on his behalf, were similarly guilty.
- 6. That the said John Madden was, by himself, his agents and partisans, guilty of undue influence and of intimidation; and that divers other persons, acting on his behalf, were similarly guilty of undue influence and intimidation before, during, and after the said election.
- 7. That before, during, and after the said election, the said John Madden was, by himself, his agents and partisans, guilty, and divers other persons acting on his behalf were also guilty, of illegal practices, in violation of the provisions of "The Electoral Act 1865."

Your Petitioner therefore prays-

- 1. That it may be determined that the said John Madden was not duly elected or returned, and that the said John Winthrop Hackett was duly elected and ought to have been returned, or that the said election was void.
- 2. That your Petitioner may have such further and other relief as the justice of the case requires.

And your Petitioner will ever pray.
