By His Excellency Sir Henry Brougham Looh, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over the Colony of Victoria and its Dependencies, &c., &c., &c.

In pursuance of the provisions contained in the eighty-eighth section of The Public Service Act 1833, and in the fifth section of The Bank Holidays Act 1873, I, the Governor of Victoria, with the advice of the Executive Council, do by this my Proclamation appoint

TUESDAY THE 18TH DAY OF OCTOBER INSTANT to be observed as a Public and Bank Holiday within the Shire of Numurkah, on account of races at Shepparton;

WEDNESDAY THE 19TH DAY OF OCTOBER INSTANT to be observed as a Public and Bank Holiday at Sale, and within the Shire of Maffra;

THURSDAY THE 20TH DAY OF OCTOBER INSTANT to be observed as a Public and Bank Holiday within the Shire of Rutherglen; and as a Public and Bank Half-Holiday at Geelong, from the hour of Twelve o'clock noon;

TUESDAY THE 25TH DAY OF OCTOBER INSTANT to be observed as a Public and Bank Holiday at Warrnambool, and within the Borough of Port Fairy;

WEDNESDAY THE 26TH DAY OF OCTOBER INSTANT to be observed as a Public and Bank Holiday within the Borough
