PUBLIC AND BANK HOLIDAYS.

PROCLAMATION

By His Excellency Sir Heney Brougham Looh, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over the Colony of Victoria and its Dependencies, &c., &c., &c.

IN pursuance of the provisions contained in the eighty-eighth section of The Public Service Act 1883, and in the fifth section of The Bank Holidays Act 1873, I, the Governor of Victoria, with the advice of the Executive Council, do by this my Proclamation appoint

THURSDAY THE 24TH DAY OF NOVEMBER INSTANT

to be observed as a Public and Bank Holiday at Rosedale and within the Shires of Maffra, Narracan, and Traralgon;

FRIDAY THE 25TH DAY OF NOVEMBER INSTANT

to be observed as a Public and Bank Holiday within the Shire of Alexandra; and as a Public and Bank Half-Holiday at Ballarat, from the hour of Twelve o'clock noon;

Wednesday the 30th day of November instant *

to be observed as a Public and Bank Holiday at Euroa and Violet Town; FRIDAY THE 2ND DAY OF DROEMBER NEXT *

a special day to be observed as a Bank Holiday at Scarsdale, and within the Shire of Creswick; and as a Public and Bank Half-Holiday at Ballarat, from the hour of Twelve o'clock noon;

TUESDAY THE 6TH AND WEDNESDAY THE 7TH DAYS OF DECEMBER NEXT *

to be observed as Public and Bank Half-Holidays at Horsham and Jung Jung, from the hour of Twelve o'clock noon; and as Public and Bank Holidays at Warracknabeal;

SATURDAY THE 10TH DAY OF DECEMBER NEXT

to be observed as a Public and Bank Holiday within the Shire of Colac.
