THE Governor of Victoria, do hereby declare that I have this day assented, in Her Majesty's name, to the Bill passed by the Parliament of Victoria, the title whereof is hereinafter set forth, that is to say:—

"An Act to further amend the Law relating to Gaols and to persons confined therein."

WHEREAS by a Proclamation under the hand of the Governor and the seal of the colony bearing date the first day of August One thousand eight hundred and eighty-seven, and issued in pursuance of The Public Health Statute 1865, it was notified that all the Ports in the Northern Territory of the Province of South Australia were infected with Small-pox, and that it was probable that such disease might be brought from the said ports to Victoria: And whereas the circumstances which led to the issue of such Proclamation have ceased to exist: Now therefore I, the Governor of Victoria, with the advice of the Executive Council, do hereby revoke the said Proclamation.

By His Excellency Sir Henry Brougham Loch, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander in-Chief in and over the Colony of Victoria and its Dependencies, &c., &c. &c.

W HEREAS by The Public Service Act 1883 it was amongst other things enacted that the Governor in Council might, by Proclamation in the Government Gazette, appoint, in addition to certain specified days, any other day or days to be kept as Public Holidays: And whereas by The Bonk Holidays Act 1873 it was amongst other things enacted that the Governor might from time to time, as he might think fit by Proclamation, appoint a special day to be observed as a Bank Holiday either throughout Victoria or in any part thereof: And whereas by a Proclamation under the hand of the Governor and seal of the colony, bearing date the twenty-sixth day of September One thousand eight hundred and eighty-seven, and made in pursuance of the said Acts, the Governor, with the advice of the Executive Council, did proclaim certain days to be kept as Public and Bank Holidays: And whereas it is expedient to revoke in part the said Proclamation: Now therefore I, the Covernor of Victoria, by and with the advice of the Executive Council thereof, do hereby revoke the said Proclamation bearing date the twenty-sixth day of September One thousand eight hundred and eighty-seven, so far only as the same relates to Thursday the sixth day of October instant being observed as a Public and Bank Holiday within the Borough of Port Fairy, and in lieu thereof do hereby appoint

WEDNESDAY THE 5TH DAY OF OCTOBER INSTANT to be observed as a Public and Bank Holiday within the Borough of Port Fairy.

HORSES MALICIOUSLY POISONED AT FOSTER.

HORSES MALICIOUSLY POISONED AT FOSTER.

TWENTY-FIVE POUNDS REWARD.

WHEREAS on the night of Friday the 26th August last, a horse, the property of Mr. Joseph Perrin, was poisoned with strychnine in a stable at Foster, a large quantity of the poison having been mixed with some chaff which was in the manger: And whereas two days after this occurrence, viz., on Sunday the 28th August, two horses belonging to Mr. Sidney Slade were put in the same stable, and having eaten some of the poisoned chaff which was still in the manger, shortly afterwards died: Notice is hereby given that a Reward of Twenty-five Pounds will be paid by the Government for such information as will lead to the conviction of the person or persons by whom the said horses were poisoned.
