PROCLAMATION

By His Excellency Sir Henry Brougham Loch, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over the Colony of Victoria and its Dependencies, &c., &c.

IN pursuance of the provisions contained in the eighty-eighth section of The Public Service Act 1883, and in the fifth section of the Bank Holidays Act 1873, I, the Governor of Victoria, with the advice of the Executive Council, do by this Proclamation

WEDNESDAY THE 6TH DAY OF MARCH INSTANT

to be observed as a Public Holiday within the Shire of Rodney;

TUESDAY THE 12TH DAY OF MARCH INSTANT

a special day to be observed as a Bank Holiday at Heidelberg and Pyramid Hill;

WEDNESDAY THE 13TH DAY OF MARCH INSTANT

to be observed as a Public Holiday at Ballarat, Ballarat East, and Dunolly, and as a Bank Holiday at Ballarat, Dunolly, and Lancefield; THURSDAY THE 14TH DAY OF MARCH INSTANT

to be observed as a Public Holiday within the Shire of Rosedale, and as a Bank Holiday at Romsey and Rosedale;

MONDAY THE 18TH DAY OF MARCH INSTANT

to be observed as a Public Holiday within the Parishes of Inglewood, Kurting, and Salisbury West, the Shire of Kilmore, and the Boroughs of Inglewood and Wangaratta; and as a Bank Holiday at Bridgewater, Inglewood, Kilmore, Kyneton, Morino, and Wangaratta;

TUESDAY THE 19TH DAY OF MARCH INSTANT

* special day to be observed as a Bank Holiday at Cobram;

WEDNESDAY THE 20TH DAY OF MARCH INSTANT to be observed as a Public Holiday within the Shire of Gisborne,* and as a Bank Holiday at Gisborne and Newstead.
