FURTHER PROROGUING THE PARLIAMENT OF VICTORIA.

PROCLAMATION

By His Excellency the Right Honorable John Adrian Louis, Earl of Hopetoun, Viscount Aithrie, and Baron Hope, in the Peerage of Scotland: Baron Hopetoun of Hopetoun, and Baron Niddry of Niddry Castle, in the Peerage of the United Kingdom; Kuight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George; Governor and Commander-in-Chief in and over the Colony of Victoria and its Dependencies, &c., &c.

WHEREAS by The Constitution Act it was amongst other things enacted that it should be lawful for the Governor to fix such places within Victoria and, subject to the limitation therein contained, such times for holding the first and every other Session of the Council and Assembly, and to vary and alter the same respectively in such manner as he might think fit; and also from time to time to prorogue the said Council and Assembly, and to dissolve the said Assembly, by Proclamation or otherwise, whenever he should deem it expedient: And whereas the said Council and Assembly, called "The Parliament of Victoria," stand prorogued until Thursday, the thirtieth day of April, 1891, and it is expedient to further prorogue the same: Now therefore I, the Governor of Victoria, in exercise of the power conferred by the said Act, do by this my Proclamation further prorogue the said Parliament of Victoria from Thursday, the thirtieth day of April, 1891, until Saturday, the thirtieth day of May now next remains.

Given under my Hand and the Seal of the Colony, at Melbourne, this twenty-second day of April, in the year of our Lord One thousand eight hundred and ninety-one, and in the fifty-fourth year of Her Majesty's reign.

IN pursuance of the provisions contained in the Public Service Act 1890 (54 Vict. No. 1133, Part VI., section 135) and in the Banks and Currency Act 1890 (54 Vict. No. 1164, Part III., section 20), I, the Governor of Victoria, with the advice of the Executive Council, do by this my Proclamation appoint

WEDNESDAY, THE 29TH, AND THURSDAY, THE 30TH DAYS OF APRIL INSTANT,

to be observed as Public Half-Holidays, from the hour of Twelve o'clock noon on each day, at Warrnambool;

WEDNESDAY, THE 6TH DAY OF MAY NEXT,

to be observed as a Public Holiday throughout the Borough of St. Arnaud, and as a Bank Holiday at Casterton, Merino, Sandford, and St. Arnaud; WEDNESDAY, THE 13TH DAY OF MAY NEXT,

to be observed as a Public Holiday throughout the Shire of Chiltern.
