# PUBLIC AND BANK HOLIDAYS.

#### PROCLAMATION

By His Excellency the Right Honorable John Adrian Louis, Earl of Hopetoun, Viscount Aithrie, and Baron Hope, in the Peerage of Scotland; Baron Hopetoun of Hopetoun, and Baron Niddry of Niddry Castle, in the Peerage of the United Kingdom; Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George; Governor and Commander-in-Chief in and over the Colony of Victoria and its Dependencies, &c., &c. &c.

IN pursuance of the provisions contained in the Public Service Act 1890 (54 Vict. No. 1133, Part VI., section 135) and in the Banks and Currency Act 1890 (54 Vict. No. 1164, Part III., section 20, I, the Governor of Victoria, with the advice of the Executive Council, do by this my Proclamation appoint the days and dates hereunder mentioned to be observed as Public Holidays or Bank Holidays (as the case may be) at the places respectively specified, viz.:—

Tuesday, the 18th day of October instant,

to be observed as a Public Holiday throughout the Borough of Talbot and the Shires of Avoca and Tullaroop, and as a Bank Holiday at Avoca;

WEDNESDAY, THE 19TH, THURSDAY, THE 20TH, AND FRIDAY, THE 21ST \* DAYS OF OCTOBER INSTANT,

to be observed as Public Half-Holidays, from the hour of Twelve o'clock noon on each day, at Warrnambool;

WEDNESDAY, THE 19TH, AND WEDNESDAY, THE 26TH DAYS OF OCTOBER INSTANT, AND WEDNESDAY, THE 2ND DAY OF NOVEMBER NEXT,

to be observed as Public Holidays.throughout the Shire of Lawloit;

THURSDAY, THE 20TH DAY OF OCTOBER INSTANT,

to be observed as a Public Holiday throughout the Shire of Chiltern;

WEDNESDAY, THE 26TH DAY OF OCTOBER INSTANT,

to be observed as a Public Holiday throughout the Borough of Creswick, and as a Bank Holiday at Mornington and Newstead;

WEDNESDAY, THE 26TH DAY OF OCTOBER INSTANT, AND FRIDAY, THE 11TH DAY OF NOVEMBER NEXT,

to be observed as Public Holidays throughout the Shire of Creswick;

THURSDAY, THE 27TH DAY OF OCTOBER INSTANT,

to be observed as a Bank Holiday at Geelong;

FRIDAY, THE 28TH DAY OF OCTOBER INSTANT,

to be observed as a Public Holiday throughout the Shire of Bannockburn and at Korumburra;

TUESDAY, THE 1ST DAY OF NOVEMBER NEXT,

to be observed as a Public Holiday and a Bank Holiday throughout Victoria;

FRIDAY, THE 4TH DAY OF NOVEMBER NEXT,

to be observed as a Public Holiday throughout the Koetong Riding of the Shire of Towong;

WEDNESDAY, THE 9TH DAY OF NOVEMBER NEXT,

to be observed as a Bank Holiday throughout Victoria;

THURSDAY, THE 10TH DAY OF NOVEMBER NEXT,

to be observed as a Public Holiday throughout the Shire of Hampden.
