PROCLAMATION

By His Excellency the Right Honorable John Adrian Louis, Earl of Hopetoun, Viscount Althrie, and Baron Hope, in the Peerage of Scotland; Baron Hopetoun of Hopetoun, and Baron Niddry of Niddry Castle, in the Peerage of the United Kingdom: Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George; Governor and Commander-in-Chief in and over the Colony of Victoria and its Dependencies, &c., &c.

WHEREAS by the Constitution Statute it was amongst other things enacted that the provisions of the Act of the fourteenth year of Her Majesty, chapter fifty-nine, and of the Act of the fifth and sixth years of Her Majesty, chapter seventy-six, For the Gorenment of Now South Wales and Von Diemen's Land, which relate to the giving and withholding of Her Majesty's assent to Bills, and the reservation of Bills for the signification of Her Majesty's pleasure thereon, and the instructions to be conveyed to governors for their guidance in relation to the matters aforesaid, and the disallowance of Bills by Her Majesty, should apply to Bills to be passed by the Legislative Council and Assembly constituted under the Constitution Act of Victoria and the now reciting Statute, and by any other legislative body or bodies which may at any time hereatter be substituted for the present Legislative Council and Assembly: And whereas the Bill hereinafter mentioned was reserved for the signification of Her Majesty's pleasure thereon: And whereas be an Order of the Queen in Council made on the twenty-sixth day of June, One thousand eight hundred and ninety-three, a copy whereof is hereto appended, Her Majesty has been pleased to assent to the No. 107.—August 16, 1893.—1. said Bill: Now therefore I, the Governor of Victoria, in pursuance of the provisions of the aforesaid Acts, do by this my Proclamation signify that the Bill intituled

"An Act Providing for the Reduction for the Financial
Year ending on the thirtieth day of June One thousand
eight hundred and ninety-three of the Salaries and
Reimbursements payable to Responsible Ministers
Members of the Legislative Assembly and certain
Public Officers,"

which was reserved for the signification of Her Majesty's pleasure thereon upon the seventh day of December, in the year. One thousand eight hundred and ninety-two, has been laid before Her Majesty in Council, and that Her Majesty has been pleased to assent to the same.

Given under my Hand and the Seal of the Colony, at Melbourne, this fourteenth day of August, in the year of our Lord One thousand eight hundred and ninety-three, and in the fifty-seventh year of Her Majesty's reign.

GOD SAVE THE QUEEN!

At the Court at Windsor, the twenty-sixth day of June, 1893. PRESENT :

The Queen's Most Excellent Majesty. Lord Steward Marquess of Ripon Lord Playfair.

Whereas by an Act passed in the fifth and sixth years of Hor Majesty's reign, entitled An Act for the Government of New South Wales and Van Diemen's Land, it is amongst other things enacted that no Bill which shall be reserved for the signification of Her Majesty's pleasure thereon shall have any force or authority within the Colony of New South Wales until the Governor of the said Colony shall signify either by speech or message to the Legislative Council of the said Colony or by Proclamation as therein aforesaid that such Bill has been laid before Her Majesty in Council, and that Her Majesty has been pleased to assent to the same:

And whereas by another Act passed in the thirteenth and fourteenth years of Her Majesty's reign, entitled An Act for the better Government of Her Majesty's Australian Colonics, it was provided among other things that the provisions of the

said former Act concerning the reservation of Bills for the signification of Her Majesty's pleasure thereon should apply to and be in force in the Colony of Victoria:

And whereas on the 7th day of December, 1892, the Governor of the said Colony of Victoria reserved a certain Bill passed by the Legislative Conneil and Legislative Assembly of the said Colony, entitled An Act Providing for the Reduction for the Financial Year ending on the thirtich day of June Onethousand eight hundred and ninety-three of the Salaries and Reimbursements payable to Responsible Ministers Members of the Legislative Assembly and certain Public Officers, for the signification of Her Majesty's pleasure thoseon:

And whereas the said Bill so reserved as aforesaid has been
