#### PUBLIC AND BANK HOLIDAYS.

### PROCLAMATION

By His Excellency the Honorable John Madden, LL.D., the Chief Justice of the Supreme Court of the Colony of Victoria, and Administrator of the Government of the said Colony, &c., &c., &c.

IN pursuance of the provisions contained in the Public Service Act 1890 (54 Vict. No. 1133, Part VI., section 135) and in the Banks and Currency Act 1890 (54 Vict. No. 1164, Part III., section 20), I, the Administrator of the Government of Victoria, with the advice of the Executive Council, do by this my Proclamation appoint the days and dates bereunder mentioned to be observed as Public Holidays or Bank Holidays (as the case may be) at the places respectively specified, viz.:—

FRIDAY, THE 17TH DAY OF FERRUARY INSTANT, to be observed as a Public Holiday throughout the Shires of Borung\* and Heidelberg;

Tuesday, the 21st day of February instant, to be observed as a Public Holiday throughout the Borough of Horsham\* and the Central Riding of the Shire of St. Arnaud,\* and as a Bank Holiday at St. James;

Wednesday, The 22nd day of February Instant,
to be observed as a Public Holiday and a Bank Holiday throughout the Borough of Rutherglen, as a Public Holiday throughout
the Shires of Kyneton and Phillip Island, and as a Bank Holiday at Loch and Talbot;

THURSDAY, THE 23RD DAY OF FEBRUARY INSTANT, to be observed as a Public Holiday throughout the Shires of Avon and Ballan, and as a Bank Holiday at Blackwood and Stratford; FRIDAY, THE 24TH DAY OF FEBRUARY INSTANT,

to be observed as a Bank Holiday at Birchip; TUESDAY, THE 28TH DAY OF FEBRUARY INSTANT,

to be observed as a Bank Holiday at Nhill;

Wednesday, the 1st day of March next, to be observed as a Public Holiday\* and Bank Holiday at Violet Town, as a Public Holiday throughout the City of Richmond and the North Riding of Shire of Euros,\* and as a Bank Holiday throughout the Borough of St. Arnaud and at Tatura;

THURSDAY, THE 2ND DAY OF MARCH NEXT, to be observed as a Public Holiday throughout the Shires of Buln Buln and Rosedale\*;

FRIDAY, THE 3RD DAY OF MARCH NEXT,

to be observed as a Bank Holiday at Poowong;

WEDNESDAY, THE 8TH DAY OF MARCH NEXT, to be observed as a Public Holiday throughout the Shire of Swan Hill\*, and as a Bank Holiday at Kerang and Natimuk;

THURSDAY, THE 9TH DAY OF MARCH NEXT, to be observed as a Public Holiday throughout the North-West Riding of the Shire of Tungamah\*;

FRIDAY, THE 10TH DAY OF MARCH NEXT, to be observed as a Public Holiday throughout the United Shire of Beechworth, and the Shire of Bright;

THURSDAY, THE 16TH DAY OF MARCH NEXT, to be observed as a Public Holiday throughout the Shires of Bairnsdale, Colac\*, and Tambo, and as a Bank Holiday throughout the Shires of Gisborne and Lancofield;

FRIDAY, THE 17TH DAY OF MARCH NEXT,
to be observed as a Public Holiday throughout the Borough of Majorca and the Shires of Tungamah and Tullaroop, and as a Bank
Holiday at Benalla, Kyneton, Merino, and Tatura;

Thursday, The 23rd day of March Next,
to be observed as a Public Holiday throughout the North Riding of the Shire of Ripon, and as a Bank Holiday at Beaufort.
