PUBLIC AND BANK HOLIDAYS.

PROCLAMATION

By His Excellency the Honorable John Madden, LL.D., the Chief Justice of the Supreme Court of the Colony of Victoria, and Administrator of the Government of the said Colony, &c., &c., &c.

**I**N pursuance of the provisions contained in the *Public Service Act 1890* (54 Vict. No. 1133, Part VI., section 135) and in the *Banks and Currency Act 1890* (54 Vict. No. 1164, Part III., section 20), I, the Administrator of the Government of Victoria, with the advice of the Executive Council, do by this my Proclamation appoint the days and dates hereunder mentioned to be observed as Public Holidays or Bank Holidays (as the case may be) at the places respectively specified, viz. :—

WEDNESDAY, THE 15TH DAY OF MARCH INSTANT,

to be observed as a Public Holiday throughout the Shire of Mildura, the Western Riding of the Shire of Waranga, and the West Riding of the Shire of Gordon ;

THURSDAY, THE 16TH DAY OF MARCH INSTANT,

to be observed as a Public Holiday throughout the Shire of Lancefield ;

FRIDAY, THE 17TH DAY OF MARCH INSTANT,

to be observed as a Public Holiday throughout the Boroughs of Sale and St. Arnaud, and the Shires of Alberton, Borung, Bulla, Maffra,\* Mansfield, Numurkah,\* Romsey,\* Rosedale, Shepparton,\* Traralgon, and the East Riding of the Shire of Dimboola, the East Riding of the Shire of Gordon,\* the Central Riding of the Shire of Waranga,\* and the North and North-East Ridings of the Shire of Wimmera ; and as a Bank Holiday at Broadford, Koroit, Koroit, Nagambie, Nhill, Pyramid Hill, Seymour, Sheep Hills, Telford, Tungamah, Wangaratta, Warracknabeal, and Yarram Yarram ;

MONDAY, THE 20TH DAY OF MARCH INSTANT,

to be observed as a Bank Holiday at Jamieson and Port Albert ;

WEDNESDAY, THE 22ND DAY OF MARCH INSTANT,

to be observed as a Public Holiday throughout the Shires of Bulla, Eltham, and Heidelberg ; and as a Bank Holiday at Daylesford and Trentham ;

THURSDAY, THE 23RD DAY OF MARCH INSTANT,

to be observed as a Public Holiday throughout the Borough of Sale\* and the Shires of Gisborne\* and Traralgon ; and as a Bank Holiday at Gisborne, Hamilton, Moc, and Morwell ;

FRIDAY, THE 24TH DAY OF MARCH INSTANT,

to be observed as a Public Holiday throughout the Shire of Rutherglen\* ; and as a Bank Holiday at Kingston and Smeaton ;

WEDNESDAY, THE 29TH DAY OF MARCH INSTANT,

to be observed as a Bank Holiday at Majorca ;
