SHIRE OF SWAN HILL RE-SUBDIVIDED.

At the Executive Council Chamber, Melbourne, the twenty-second day of May, 1894. PRESENT:

WHEREAS by the Local Government Acts it is amongst other things enacted that, subject to the provisions of the said Acts, the Governor in Council may from time to time make Orders to subdivide or re-subdivide any municipal district into any number of subdivisions not exceeding eight, and to determine and alter, within the limits prescribed by the said Acts, the number of councillors assigned to any municipality; and that every such Order shall be published in the Government Gazette, and shall take effect as from the day of such publication: And whereas a petition purporting to be signed by more than one-fourth of the ratepayers whose names are inscribed on the municipal roll of the Shire of Swan Hill has been presented to the Governor in Council, the substance and prayer of which petition were published in the Government Gazette of the 16th day of March, 1894, and no counter petition received: Now therefore His Excellency the Governor, with the advice of the Executive Council, doth by this present Order abolish all previous subdivisions of the Shire of Swan Hill aforesaid, and, in compliance with the prayer of the petition hereinbefore mentioned, doth hereby re-subdivide the said shire into four mentioned, doth hereby re-subdivide the said shire into four separate ridings, the names and boundaries of which shall be those severally hereunder set forth and described, and doth hereby further order that a council consisting of twelve members be elected accordingly.

NORTH-EAST RIDING.

Commencing at a point on the River Loddon opposite the south-west angle of the parish of Kerang; thence easterly, south-easterly, and northerly by the southern and eastern boundaries of that parish to the south boundary of the parish of Gannawarra; thence easterly and northerly by the southern and eastern boundaries of that parish to the south-east angle of the parish of Murrabit; thence northerly by the eastern boundary of the last-named parish to the shire boundary; thence following the shire boundary north-westerly to its junction with the Loddon River; thence following the said river southerly to the commencing point.

SOUTH-EAST RIDING.

Commencing at a point on the Loddon River opposite the south-west angle of the parish of Kerang; thence casterly, south-easterly, and northerly by the southern boundaries of that parish to the south boundaries of the parish of Gannawarra; thence easterly and northerly by the southern and castern boundaries of that parish to the south-east angle of the parish of Murrabit; thence northerly by the eastern boundary of the last-named.

parish to the eastern boundary of the shire; thence following the shire boundary south-easterly, southerly, and westerly to its junction with the Loddon River; thence following said river northerly to the commencing point.

Commencing at a point on the Loddon River where it is intersected by the south boundary of the township of Kerang; thence westerly by a road to the south angle of allotment 2, section B, parish of Meran; thence west by a road to the Avoca River; thence northerly and westerly along the south boundary of the parish of Bael Bael to the south-east angle of the parish of Korrak Korrak; thence west by a road, being the south boundary of the parish last named, to the north-west angle of mallee allotment 57A, parish of Budgerum West; thence north by a road to the north-east angle of mallee allotment 55c, parish of Cannie; thence west by the north boundaries of the parish of Cannie and part of the parish of Tittybong to the western boundary of the shire; thence following the shire boundary southerly, easterly, northerly, and easterly to the River Loddon; and thence northerly by that river to the commencing point.

Wherever the line so described as aforesaid runs beside or along

WHEREAS by the Local Government Acts it is amongst other things enacted that, subject to the provisions of the said Acts, the Governor in Council may from time to time make O'telers to sever any portion of Victoria forming part of a municipal district from such municipal district, and annex the same to any other municipal district with which the portion so severed forms one continuous area, and from time to time make any apportionment of property rights and liabilities, and give any directions as to any matters and things that may be necessary to do justice as between the municipalities concerned; and that every such Order shall be published in the Government Gazette, and shall take effect as from the day of such publication: And whereas the powers conferred upon the Governor by the said Acts are now exercised upon a petition signed by a majority of the ratepayers of the South Riding of the Shire of Lowan, notices of such petition having been published in the manner prescribed in the said Acts: Now therefore His Excellency the Governor, with the advice of the Executive Council, and in compliance with the prayer of the petition hereinbefore mentioned, doth by this present Order sever from the Shire of Lowan the portion described in such petition, being the South Riding of the said shire, and doth annex the portion severed from such shire to the Shire of Kowree as a separate riding, to be called the North Riding; and with the advice aforesaid doth hereby re-define the loundaries of the said Shire of Kowree as hereby enlarged and of the North Riding; thereof, in the manner set forth horeunder, that is to say:—

Council, the substance and prayer of which petition were published in the Government Gazette of the 27th day of April, 1894, and no counter petition received: Now therefore His Excellency the Governor, with the advice of the Executive Council, doth by this present Order, in compliance with the prayer of the petition hereinbefore mentioned, abolish the subdivisions existing in the said Shire of Coburg, and doth order that the said shire shall be an undivided municipality with a council consisting of nine members.

OUTLYING DISTRICT ANNEXED TO THE SHIRE OF HOWQUA.

W HEREAS by the Local Government Acts it is amongst other things enacted that subject to the provisions of the said Acts, the Governor in Council may from time to time make orders to annex an outlying district forming with the municipal district of some municipality one continuous area to such municipal district, and to determine and alter within the limits prescribed by the said Acts the number of councillors assigned to any municipality, and that every such Order shall be published in the Government Gazette, and shall take effect as from the day of such publication: And whereas by the Wood's Point Municipal Act 1893 it is amongst other things enacted that the municipal district of Wood's Point, the boundaries of which are set forth in the Second Schedule to the Local Government Act 1890, shall be an outlying district within the meaning of the Local Government Acts, and on and after the commoncement of the said Wood's Point Municipal Act 1893 shall be deemed to be a portion of Victoria no part of which is comprised in any municipal district, and that with regard to such district the power exercisable by the Governor in Council to annex an outlying district may be so exercised by him whether or not a petition has been presented in pursuance of the Local Government Acts for the exercise thereof, and whether or not the council or inhabitants or ratepayers of

any municipal district to which any such annexation is made object to the exercise of such power: Now therefore His Excellency the Governor, with the advice of the Executive Council, doth by this present Order annex the outlying district lately forming the Borough of Wood's Point to the Shire of Howqua as a separate riding, to be designated the Wood's Point Riding of the said shire, and doth hereby re-define the boundaries of the said Shire of Howqua as increased, and of the Wood's Point Riding thereof in the manner set forth hereunder, and doth further order that the Wood's Point Riding of the said shire be represented in the council of the municipality by three members:—

HOWQUA SHIRE ENLARGED AND RE-DEFINED.

Howqua Shire Enlarged and Re-defined.

Commencing at the Bald Hill, north-west of Wood's Point; thence west by the north boundaries of pastoral blocks Q1 and P1, county of Wonangatta, to the 146th meridian of east longitude; thence south by that meridian to the north boundary of the county of Buln Buln; thence easterly by that boundary to the summit of Mount Baw Baw; thence northerly by a direct line to the south-west angle of the old municipal district of the Borough of Wood's Point; thence east and north by the south and east boundaries of the said old Municipal District of Wood's Point to the north-east angle thereof; thence south-easterly by a direct line to the summit of Mount Howitt; thence westerly to the source of the Howqua River; thence further westerly by that river to the Goulburn River; thence south-easterly by the latter river to the east boundary of pastoral block B; thence south by that boundary, part of the east boundary of block V, and a line to the summit of the range forming the watershed between the Goulburn and Big Rivers; and thence southerly by that range to the commencing point.

Wherever the line so described runs beside or along a river, creek, or road, whether such is specifically mentioned or not, the centre of such river, creek, or road shall be the boundary line.

WOOD'S POINT RIDING.

Commencing at a point one mile due north (true meridan) from the centre of the Wood's Point bridge over the left branch near its junction with the right branch on the Goulburn River; thence east eighty chains; thence south one hundred and sixty chains; thence west one hundred and sixty chains; thence north one hundred and sixty chains; thence again east eighty chains to the commencing point.

And the Honorable William Telford Webb, Her Majesty's Commissioner of Public Works for Victoria, shall give the necessary directions herein accordingly.
