PROCLAMATION

By His Excellency the Right Honorable Thomas, Baron Brassey, Knight Commander of the Most Honorable Order of the Bath;
Governor and Commander-in-Chief in and over the Colony of Victoria and its Dependencies, &c., &c., &c.

TN pursuance of the provisions contained in the Public Service Act 1890 (54 Vict. No. 1133, Part VI., section 135), and in the Banks and Currency Act 1890 (54 Vict. No. 1164, Part III., section 20), I, the Governor of Victoria, with the advice of the Executive Council, do by this my Proclamation appoint the days and dates hereunder mentioned to be observed as Public Holidays or Bank Holidays (as the case may be) at the places respectively specified, viz.:—

WEDNESDAY, THE 19TH DAY OF FEBRUARY INSTANT,

as a Public Holiday throughout the Taradale Riding of the United Shire of Metcalfe;

THURSDAY, THE 20TH DAY OF FEBRUARY INSTANT,

as a Public Holiday throughout the Shire of Wimmera*;

FRIDAY, THE 21ST DAY OF FEBRUARY INSTANT,

as a Public Half-Holiday, from the hour of Twelve o'clock noon, throughout the Mokoan, Central, and Tatong Ridings of the Shire of Benalla*;

MONDAY, THE 24TH DAY OF FEBRUARY INSTANT,

as a Public Holiday and Bank Holiday throughout the Shire of Lillydale;

WEDNESDAY, THE 26TH DAY OF FEBRUARY INSTANT,

as a Bank Holiday throughout the Borough of St. Arnaud and at Drouin and Talbot;

WEDNESDAY, THE 26TH* DAY OF FEBRUARY INSTANT, AND TUESDAY, THE 17TH DAY OF MARCH NEXT,

as Public Holidays throughout the Shire of Talbot;

Wednesday, the 26th day of February instant, and Thursday, the 19th day of March next, as Public Holidays throughout the Shire of Phillip Island;

THURSDAY, THE 27TH DAY OF FEBRUARY INSTANT,

as a Public Holiday throughout the Shire of Winchelsea;

SATURDAY, THE 29TH DAY OF FEBRUARY INSTANT,

as a Bank Holiday at Katamatite;

Wennesday, the 4th day of March next, as a Public Holiday throughout the City of Ballaarat, and the Shires of Alberton and Orbost, and the North and West Ridings of the Shire of Huntly, and as a Bank Holiday at Richmond;

WEDNESDAY, THE 4TH*, AND TUESDAY, THE 17TH, DAYS OF MARCH NEXT,

as Public Holidays throughout the Shire of Seymour;

as a Public Half-Holiday, from the hour of Twelve o'clock noon, throughout the City of Ballaarat, and as a Bank Holiday at Corryong;

Licensing Act 1890.

TIME FOR HOLDING A LICENSING COURT EXTENDED.

At the Executive Council Chamber, Melbourne, the nineteenth day of February, 1896.

WHEREAS by the Licensing Act 1890 (54 Vict. No. 1111, section 85) it is enacted that the Licensing Court for each Licensing District shall, in the month of December in every year, hold an annual sitting of the Court at the place appointed, of which annual sitting one month's previous notice shall be given in the Government Gazette: Provided that the Governor in Council may, by an Order in Council, extend the time for the holding of such Court by a period not exceeding two months from the thirty-first day of December: Now therefore His Excellency the Governor, by and with the advice of the Executive Council, doth by this present Order extend the time for holding the Annual Sittings of the Licensing Court appointed to be held in the month of December, 1895, at Warragul, by a period not exceeding two months from the thirty-first day of December, 1895.

And the Honorable Henry Cuthbert, Her Majesty's Solicitor-General for Victoria, shall give the necessary directions herein accordingly.
