PUBLIC AND BANK HOLIDAYS.

PROCLAMATION

By His Excellency the Right Honorable Thomas, Baron Brassey, Knight Commander of the Most Honorable Order of the Bath; Governor and Commander-in-Chief in and over the Colony of Victoria and its Dependencies, &c., &c., &c.

IN pursuance of the provisions contained in the Public Service Act 1839 (54 Vict. No. 1133, Part VI., section 135), and in the Banks and Currency Act 1830 (54 Vict. No. 1164, Part III., section 20), I, the Governor of Victoria, with the advice of the Executive Council, do by this my Proclamation appoint the days and dates hereunder mentioned to be observed as Public Holidays or Bank Holidays (as the case may be) at the places respectively specified, viz.:—

MONDAY, THE 9TH DAY OF MARCH INSTANT,

as a Public Holiday throughout the Town of Brighton;

TUESDAY, THE 10TH DAY OF MARCH INSTANT,

as a Public Holiday throughout the Shires of Bacchus Marsh and Ballan;

WEDNESDAY, THE 11TH DAY OF MARCH INSTANT,

as a Public Holiday throughout the Town of Geelong and the Borough of Talbot, and as a Bank Holiday at Northcote THURSDAY, THE 12TH DAY OF MARCH INSTANT.

as a Public Holiday throughout the Shires of Cranbourne and Maffra*;

FRIDAY, THE 13TH DAY OF MARCH INSTANT,

as a Public Holiday throughout the Borough of Wangaratta and the Shire of North Ovens;

TUESDAY, THE 17TH DAY OF MARCH INSTANT,

as a Public Holiday throughout the Town of Ballarat East,* the Borough of Rutherglen,* the Shires of Bungaree, Buninyong, Kara Kara, Rodney, and Warragul, and as a Bank Holiday throughout the Borough of Rutherglen, and the Shire of Yarrawonga, and at Foster, Horsham, Koroit, Leongatha, Mirboo North, Seymour, Tungamah, and Warragul;

WEDNESDAY, THE 18TH DAY OF MARCH INSTANT,

as a Public Holiday throughout the Borough of Wangaratta, and the Shire of North Ovens, and as a Bank Holiday at Newstead; THURSDAY, THE 19TH DAY OF MARCH INSTANT,

as a Public Holiday throughout the Borough of Sale and Shires of Avon and Maffra;

WEDNESDAY, THE 25TH DAY OF MARCH INSTANT,

as a Public Holiday throughout the Shires of Avoca* and Rodney, and the Bellarine and Paywit Ridings of the Shire of Bellarine*; THURSDAY, THE 26TH DAY OF MARCH INSTANT,

as a Public Holiday throughout the Shires of Avoca* and Tambo, and the North Riding of the Shire of Ripen, and as a Bank Holiday at Beaufort.

PROCLAMATION

By His Excellency the Right Honorable Thomas, Baron Brassey, Knight Commander of the Most Honorable Order of the Bath;
Governor and Commander in Chief in and over the Colony of Victoria and its Dependencies, &c., &c., &c.

THE Governor of Victoria, do hereby declare that I have this day assented, in Her Majesty's name, to the Bills passed by the Parliament of Victoria, the titles whereof are hereinafter set forth, that is to say:—

"An Act to enable Seed to be advanced on certain terms to Cultivators of Land."

"An Act to authorize Advances to Municipalities for the purchase of Wire Netting."

"An Act to authorize the Exchange of certain Land in the Parish of Nunawading between the Board of Land and Works the Nunawading Shire Council and the Education Department and for other purposes."

"An Act to Suppress Betting in Streets and for other purposes."

"An Act to sanction the expenditure of Moneys available under Loan Acts for Railways and other purposes and to prevent the further issue of Moneys under the authority of certain Railway Loan Application Acts."

"An Act to revoke the Permanent Reservation of certain Crown Land in the parish of Boort."

"An Act to further amend the Law relating to the Victorian Railways."

"An Act to encourage the Establishment of the Sugar Beet Industry in Victoria."

Factories and Shops Act 1890.

IN compliance with an application in writing under the provisions of section 30 of the Factories and Shops Act 1890 (54 Vict. No. 1991), and after due inquiry, I, the Chief Secretary of Victoria, being the responsible Minister of the Crown for the time being administering the said Act, do hereby suspend the operation of the first clause of section 30 of the said Act in the

MANTLE FACTORY OF MESSES. H. L. BURRELL, WATKINSON, AND COMPANY, AT BURKITT'S BUILDINGS, FLINDERS-LANE, MELBOURNE, for a period of four weeks from the 6th March, 1896, upon the following express conditions, that is to say:--

That no person or persons shall employ in the said factory more than thirty-seven females for more than forty-eight hours in any one week, and that the said thirty-seven females shall not be employed for more than fifty-seven hours in any one week, nor for more than eleven hours in any one day, in preparing or manufacturing articles for trade or sale.
 That each female so employed shall receive not less than Fifteen shillings per week for each week during which she works overtime, and, in addition, each wage worker shall be paid for such overtime at the rate of time and a half, and each piece-worker shall be paid Threepence per hour for overtime in addition to ordinary earnings by piece-work.
 That each female so employed shall receive Sixpence for tea money each evening she works overtime.
 That none of such females shall be so employed for more than forty-eight hours in any one week without their consent.
 That a copy of this Order be kept conspicuously and continually posted in such factory for the information of all concerned.
