#### PUBLIC AND BANK HOLIDAYS.

### PROCLAMATION

By His Excellency the Right Honorable Thomas, Baron Brassey, Knight Commander of the Most Honorable Order of the Bath; Governor and Commander in Chief in and over the Colony of Victoria and its Dependencies, &c., &c., &c.

IN pursuance of the provisions contained in the Banks and Currency Act 1820 (54 Vict. No. 1164, Part III., section 20), I, the Governor of Victoria, with the advice of the Executive Council, do by this my Proclamation revoke so much of the Proclamation made on the 6th day of March, 1896, as relates to the appointment of Wednesday, the 18th day of March instant, a special day to be observed as a Bank Holiday at Nowstead; and, in pursuance of the provisions of the Public Service Act 1890 (54 Vict. No. 1133, Part VI., section 136) and of the Act aforesaid, I do hereby appoint the days and dates hereunder mentioned to be observed as a Public Holidays or Bank Holidays (as the case may be) at the places respectively specified, viz.:—

TUSDAY, THE ITH DAY OF MARCH INSTANT, as a Public Holiday throughout the City of Ballacrat, the Towns of Geelong and Warrnambool,\* the Borough of Koroit,\* the Shires of Ballacrat, Beechworth (United), Birchip, Marong, St. Arnaud, and Yea,\* and the North Riding of the Shire of Arapiles, and as a Bank Holiday at Donald, Heyfield, Longwood, Natimuk, Sheep Hills, St. Arnaud, Strathmerton, Terang, Warracknabeal, Wodonga, and Wunghnu;

WEDNESDAY, THE 18TH DAY OF MARCH INSTANT, as a Public Holiday throughout the Shires of Huntly\* and Oxley, and the Central and Western Ridings of the Shire of Waranga;\* as a Public Half-holiday, from the hour of Twelve o'clock noon, throughout the City of Footscray; and as a Bank Holiday at Wangaratta;

FRIDAY, THE 20TH DAY OF MARCH INSTANT, as a Bank Holiday at Romsey;

WEDNESDAY, THE 25TH DAY OF MARCH INSTANT, as a Public Holiday throughout the City of Hawthorn, the Borough of Echuca,\* and the Shire of McIvor,\* and as a Bank Holiday at Maryborough;

WEDNESDAY, THE 25TH, AND THUESDAY, THE 26TH, DAYS OF MARCH INSTANT, as Public Holidays throughout the Boroughs of Majorca, \* Maryborough, \* and Talbot; \* and as Public Half-Holidays, from the hour of Twelve o'clock noon on each day, throughout the Shire of Tullaroop; \*

WEDNESDAY, THE 25TH, AND THURSDAY, THE 26TH, DAYS OF MARCH INSTANT, AND WEDNESDAY, THE 1ST DAY OF APRIL

as Public Holidays throughout the Shire of Bet Bet;\*

THURSDAY, THE 26TH DAY OF MARCH INSTANT, as a Public Holiday throughout the Shire of Bairnsdale, and as a Bank Holiday at Bairnsdale and Beeac;

FRIDAY, THE 27TH DAY OF MARCH INSTANT, Bank Holiday at Chiltern;

FRIDAY, THE 27TH, AND SATURDAY, THE 28TH, DAYS OF MARCH INSTANT, as Public Holidays throughout the Shire of Chiltern;\*

Wednesday, the 1st day of April Next, as a Public Holiday throughout the Shire of Pyalong;

TUESDAY, THE 7TH DAY OF APRIL NEXT, as a Public Holiday and a Bank Holiday throughout Victoria.

## EXTENSION OF TIME FOR MAKING ASSESSMENTS OF INCOMES.

At the Government Offices, Melbourne, the sixteenth day of March, 1896.

PRESENT:

His Excellency the Governor.

Mr. Turner

Mr. Best.

WHEREAS by the Income Tax Act 1895 (58 Vict. No. 1374), it is amongst other things provided that if any act, matter, or thing prescribed by or under the said Act to be made or done at or within a fixed time cannot be or is not so made or done, the Governor in Council may by Order from time to time appoint a further or other time for making or doing the same, whether the time or any such further or other time within which the same ought to have been done has or has not elapsed or expired: And whereas the assessments of incomes for the first period for which assessments are prescribed to be made cannot be made on or before the 31st day of March, 1896, as prescribed in the Regulations made pursuant to the said Act, and dated the 10th day of February, 1896: Now, therefore, His Excellency the Governor of Victoria, with the advice of the Executive Council thereof, doth hereby appoint that all assessments of incomes for the year ended the 31st day of December, 1895, which shall not be made on or before the 31st day of March, 1896, shall be made on or before the 30th day of April, 1896, and that the tax payable on such assessments shall be paid on or before the 15th day of May, 1896.
