EXTENSION OF TIME FOR MAKING ASSESSMENTS OF INCOMES, FOR THE YEAR COMMENCING 1st JANUARY, 1899.

At the Executive Council Chamber, Melbourne, the twenty-second day of May, 1899.

W HEREAS by the Income Tax Act 1895 (58 Vict. No. 1374), it is amongst other things enacted that if any act, matter, or thing prescribed by or under the said Act to be made
