REGULATION OF HAIRDRESSERS' AND BARBERS' SHOPS IN THE METROPOLITAN DISTRICT.

At the Executive Council Chamber, Melbourne, the second day of October, 1899.

WHEREAS by the Factories and Shops Acts it is enacted that the Governor in Council may make regulations to have effect in and throughout the whole of the Metropolitan District as defined in the Factories and Shops Act 1896 for, amongst other things, permitting shops of any particular class not included in the Fourth Schedule to the Factories and Shops Act 1890, on obtaining a licence to keep open after the hours mentioned in the said Factories and Shops Acts, and during such hours as shall be specified in such licence, provided a petition shall have been previously addressed to the Governor in Council and forwarded to the Minister, signed by a majority of all the shopkeepers of any particular class other than those mentioned in the said Fourth Schedule keeping shops of the classes or class of shops to be affected within such Metropolitan District: And whereas a petition has been so addressed and forwarded praying that a regulation be made allowing all hairdressers' and barbers' shops within the said Metropolitan District to be kept open until Eight o'clock on the evening of Monday, Tuesday, Thursday, and Friday, and until Eleven o'clock on the evening of Saturday in each and every week, and permitting such shops to remain open until Eleven o'clock on the evening of the ay immediately preceding any public holiday: And Whereas such petition has been signed by a majority of all the shopkeepers of the particular class to be affected within the said Metropolitan District: Now therefore His Excellency the Governor of Victoria, with the advice of the Executive Council thereof, doth hereby make the following Regulation (that is to say):—

It shall be lawful for the shop of any hairdresser and barber within the Metropolitan District constituted by section 36 of the Factories and Shops Act 1856 to keep open on the evenings of Monday, Tuesday, Thursday, and Friday in each week from Seven o'clock until Eight o'clock, and on the evening of Saturday in each week from Ten o'clock until Eleven o'clock, and to keep open from Ten o'clock until Eleven o'clock, and to keep open from Ten o'clock until Eleven o'clock on the svening of the day immediately preceding any public holiday, on obtaining a licence to keep open during such hours from the Chief Inspector of Factories.

And the Honorable Alexander James Peacock, Her Majesty's Chief Secretary for Victoria, shall give the necessary directions herein accordingly.

HALF-HOLIDAY FOR HAIRDRESSERS' AND BARBERS' SHOPS IN THE METROPOLITAN DISTRICT.

WHEREAS by the Factories and Shops Acts it is enacted that the Governor in Council may make regulations to have effect in and throughout the whole of the Metropolitan District as defined in the Factories and Shops of any particular class other than those mentioned in the Fourth Schedule to the Factories and Shops Act 1896 for, amongst other than those mentioned in the Fourth Schedule to the Factories and Shops Act 1896 for one afternoon in each week, provided that a petition therefor shall have been previously addressed to the Governor in Council, and forwarded to the Minister, signed by a majority of all the shopkeepers, or of all the shopkeepers of any particular class, other than those mentioned in the Fourth Schedule to the Factories and Shops Act 1890 aforesaid, keeping shops of the classes or class of shops to be affected within such Metropolitan District: And whereas a petition has been so addressed and forwarded praying that a regulation be made for the closing on Wednesday in each week from the hour of One o'clock in the afternoon of all hiardressers' and barbers' shops within the said Metropolitan District, provided that any such shops shall not be required to be closed on well shops shall not be required to be closed on of clock in the afternoon: And whereas such petition has been signed by a majority of all the shopkeepers of the particular class to be affected within the Metropolitan District. Now therefore His Excellency the Governor of Victoria, with the advice of the Execultive Council thereof, doth hereby make the following Regulation, that is to say:—

All hairdressers' and barbers' shops within the Metropolitan

Shops Act 1896 shall be closed on Wednesday in each
week, from the hour of One o'clock in the atternoon, provided that any such shop shall not be required to be closed
on Wednesday in any week in which a public holiday
occurs if such shop be closed on such public holiday from
the hour of One o'clock in the afternoon.

WHEREAS by the Factories and Shops Acts it is enacted that the Governor in Council may make regulations to have effect within any specified municipal district, or any specified part of such district other than those mentioned in the Fourth Schedule to the Factories and Shops Acts, provided a petition shall have been previously addressed to the Governor in Council, and forwarded to the Minister, certified to by the municipal clerk as having been signed by a majority of the shop-keepers keeping shops of such class within such district: And whereas petitions have been so addressed and forwarded praying that a regulation be made requiring that all drapers' shops, and watchmakers' shops (being shops not included in the Fourth Schedule to the Factories and Shops Act 1890 aforesaid), in the municipal district of the Shire of Bacchus Marsh, shall be closed on the evenings of Monday, Tuesday, Thursday, and Friday, at Six o'clock in each and every week during the months of May, June, July, and August: And whereas such petitions have been certified to by the municipal clerk of the said district as having been signed by a majority of each of the classes of shopkeepers to be affected within the said district: Now therefore His Excellency the Governor of Victoria, with the advice of the Executive Council thereof, doth hereby make the following Regulation, that is to say:—

All drapers' shops, grocers' shops, saddlers' shops, and watchmakers' shops, within the municipal district of the

All drapers' shops, grocers' shops, saddlers' shops, and watchmakers' shops within the municipal district of the Shire of Bacchus Marsh shall be closed on the evenings of Monday, Tuesday, Thursday, and Friday at Six o'clock in each and every week during the months of May, June, July, and August in each year.

PROVISIONS RELATING TO SHOPS EXTENDED TO THE TOWNSHIP OF WHITTLESEA.

WHEREAS by the Factories and Shops Acts it is amongst other things enacted that the Governor in Council may from time to time and at any time make an Order extending the provisions of the said Acts which relate to shops to any particular class of shops, or to the whole of the shops in the whole or any specified part of any shire, if the majority of the shopkeepers

keeping shops of that particular class or of the whole of the shop-keepers (as the case may be) in the locality to be affected have petitioned for such extension: And whereas a majority of the whole of the shopkeepers keeping shops within the township of Whittlesea in the municipal district of the Shire of Whittlesea have petitioned the Governor in Council to make an Order extending the provisions aforesaid to the whole of the shops within the said township, and the municipal clerk of the said shire has certified to that effect as provided in the said Acts: Now therefore His Excellency the Governor of Victoria, with the advice of the Executive Council thereof, doth by this Order extend the provisions of the Factories and Shops Acts which relate to shops to the whole of the shops within the township of Whittlesea in the said municipal district of the Shire of Whittlesea.

REGISTRATION OF BIRTHS DEATHS AND MARRIAGES ACTS.—ADDITIONAL REGULATION.

WHEREAS by the Registration of Births Deaths and Marriages act 1890 it is enacted that the Governor in Council may from time to time frame rules and regulations for the more effectually carrying out of the provisions of that Act, and whereas it is also enacted by the said Act that it shall not be lawful to register the birth of any child, unless such child has been born at sea, after the expiration of twelve months following the birth of such child except in accordance with the rules and regulations under the said Act: And whereas by an Order of the Governor in Council, made under the provisions aforesaid, and bearing date the 20th day of February, 1894, regulations were made regarding the registration of the birth of any child after the expiration of twelve months following the birth of such child: Now therefore His Excellency the Governor, with the advice of the Executive Council, doth hereby make the following additional regulation regarding such registration (that is to say):—

# Regulation.

Notwithstanding anything in the regulations made under the Registration of Births Deaths and Marriages Act 1890, where a Judge of the Supreme Court, or of the County Court, has authorized the registration of a birth, it shall not be necessary for application for the registration of such birth to be made in the form and with the declaration and certificates prescribed in such regulations, and the Government Statist, on receipt of the anthority or order of the Judge, shall authorize the Registrar in writing to register such birth on paying a fee of Ten shillings (10s.).

The Registrar shall enter on the register form the words—
"This registration is made by the written authority of the Government Statist, under the authority of a Judge of the Supreme Court or of the County Court (as the case may be), and in accordance with the rules and regulations made under the Registration of Births Deaths and Marriages Act 1890.
