PUBLIC AND BANK HOLIDAYS.

PROCLAMATION

By His Excellency the Honorable Sir John Madden, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Lieutenant-Governor of the Colony of Victoria and its Dependencies, &c., &c., &c.

IN pursuance of the provisions contained in Part VI. of the Public Service Act 1890 (54 Vict. No. 1133), in Part III. of the Banks and Currency Act 1890 (54 Vict. No. 1164), and in the Public and Bank Holidays Act 1897 (61 Vict. No. 1584), I, the Lieutenant-Governor of Victoria, with the advice of the Executive Council thereof, do by this my Proclamation appoint the days and dates bereunder mentioned to be observed as Public Holidays or Bank Holidays (as the case may be) at the places respectively mentioned, viz.:—

WEDNESDAT, THE 24TH DAY OF OCTOBER INSTANT, as a Public Heliday throughout the Borough of Majorca and the Shire of Kerang, and as a Bank Half-Heliday, from the hour of Twelve o'clock noon, at Moorcopna;

FRIDAY, THE 26TH DAY OF OGTOBER INSTANT, as a Bank Half-Holiday, from the hour of Twelve o'clock noon, at Seymour;

FRIDAY, THE 2ND DAY OF NOVEMBER NEXT, as a Public Holiday throughout the Borough of Clunes; and as a Bank Half-Holiday, from the hour of Twelve o'clock noon, at Clunes;

TUESDAY, THE 6TH DAY OF NOVEMBER NEXT,* as a Public Holiday and a Bank Holiday throughout Victoria;

WEDNESDAY, THE 7TH DAY OF NOVEMBER NEXT, as a Public Holiday throughout the Shire of Strathfieldsaye;

FRIDAY, THE 9TH DAY OF NOVEMBER NEXT, as a Bank Half-Holiday, from the hour of Twelve o'clock noon, at Allendale, Creswick, Dunolly, Kingston, and Smeaton;

FRIDAY, THE 16TH DAY OF NOVEMBER NEXT, as a Public Holiday throughout the Shire of Buninyong;

THURSDAY, THE 22ND DAY OF NOVEMBER NEXT, as a Public Holiday throughout the Shire of Colac.
