PROCLAMATION

By His Excellency the Honorable Sir John Madden, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Lieutenant Governor of the Colony of Vic-toria and its Dependencies, &c., &c., &c.

THE Lieutenant-Governor of Victoria, with the advice of the Executive Council thereof, do by this my Proclamation revoke the Proclamation made under my Hand and the Seal of the Colony in pursuance of the provisions contained in Part VI. of the Public Service Act 1890 (54 Vict. No. 1133), and in the Public and Bank Holidays Act 1897 (61 Vict. No. 1534), and bearing date the 8th day of February, 1900, so far only as the same relates to the appointment of Wednesday, the 7th day of March, 1900, to be observed as a Public Holiday throughout the Town of Port Melbourne, and in pursuance of the provisions aforesaid and of those contained in Part III. of the Banks and Currency Act 1890 (54 Vict. No. 1164), do hereby appoint the days and dates hereunder mentioned to be observed as Public Holidays or Bank Holidays (as the case may be) at the places respectively specified, viz.:—

THURSDAY, THE 1ST DAY OF MARCH NEXT, as a Public Holiday throughout the Borough of Port Fairy;

WEDNESDAY, THE 7TH DAY OF MARCH NEXT, as a Public Holiday throughout the Shire of Maldon, and as a Bank Haif-Holiday, from the hour of Twelve o'clock noon, at Boort;

Wednesday, the 14th day of March next, as a Public Holiday throughout the Towns of Northcote and Port Melbourne, and the Shires of Kerang * and Warragul, and as a Bank Half-Holiday, from the hour of Twelve o'clock noon, at Kyabram;

Wednesday, the 14th, and Monday, the 19th, days of March next, as Public Holidays throughout the Shire of Castle Donnington*;

THURSDAY, THE 15TH DAY OF MARCH NEXT, as a Public Holiday throughout the Borough of Hamilton;

FRIDAY, THE 167H DAY OF MARCH NEXT, as a Public Holiday throughout the City of Ballanat,* the Borough of Subastopol, the Shires of Birchip, Charlton, and Yackandandah, and the United Shire of Beechworth;

SATURDAY, THE 17TH DAY OF MARCH NEXT, as a Public Holiday throughout the Shires of Colac and Morwell;

MONDAY, THE 19TH DAY OF MARCH NEXT, as a Public Holiday throughout the Shires of Glenelg and Kilmore, and as a Bank Half-Holiday, from the hour of Twelve o'clock noon, at Swan Hill. at Swan Hill;
