PUBLIC AND BANK HOLIDAYS.

PROCLAMATION

By His Excellency the Honorable Sir John Madden, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Lieutenant-Governor of the State of Victoria and its Dependencies, in the Commonwealth of Aus-

TN pursuance of the provisions contained in Part VI. of the Public Service Act 1890 (54 Vict. No. 1133), in Part III. of the Banks and Currency Act 1890 (54 Vict. No. 1164), and in the Public and Bank Holidays Act 1897 (61 Vict. No. 1534), I, the Lieutenant-Governor of the State of Victoria, in the Commonwealth of Australia, with the advice of the Executive Council of the said State, do by this my Proclamation appoint the days and dates hereunder mentioned to be observed as Public Holidays or Bank Holidays (as the case may be) at the places respectively mentioned, viz. —

WEDNESDAY, THE 6TH DAY OF FEBRUARY INSTANT, as a Public Holiday throughout the Shire of Phillip Island and Woolamai, and the Devenish and Mokoan Ridings of the Shire of Benalla;*

WEDNESDAY, THE 6TH DAY OF FEBRUARY INSTANT, as a Public
Holiday, and THURSDAY, THE 7TH DAY OF FEBRUARY INSTANT,
as a Public Half-Holiday, from the hour of Twelve o'clock
noon, throughout the Shire of Alberton;

WEDNESDAY, THE 6TH, AND THURSDAY, THE 7TH DAYS OF FEBRUARY INSTANT, as Public Half-Holidays, from the hour of Twelve o'clock noon on each day, throughout the Borough of Ararat; *

THURSDAY, THE 7TH DAY OF FEBRUARY INSTANT, as a Public Holiday throughout the City of St. Kilda and the Shire of Yea;

MONDAY, THE 11TH DAY OF FEBRUARY INSTANT, as a Public Holiday and as a Bank Holiday throughout Victoria;

TURSDAY, THE 12th DAY OF FERRUARY INSTANT, as a Public Holiday throughout the Shires of Borung, Bulla, Karkarooc, Lancefield, and Romsey; and as a Bank Holiday at Romsey;

WEDNESDAY, THE 13TH DAY OF FEBRUARY INSTANT, as a Bank Half-Holiday, from the hour of Twelve o'clock noon, at Shepparton;

Tuesday, the 19th day of February instant, as a Public Holiday throughout the City of Footscray;
Thursday, the 21st day of February instant, as a Public Holiday throughout the Shire of Moorabbin, and as a Bank Holiday at Cheltenham;

FRIDAY, THE 22ND DAY OF FEBRUARY INSTANT, as a Public Holiday throughout the Borough of Echuca;*
WEDNESDAY, THE 27TH DAY OF FEBRUARY INSTANT, as a Public Holiday throughout the Taradale and West Ridings of the United Shire of Metcalfe; and as a Bank Half-Holiday, from the hour of Twelve o'clock noon, at Dimboola and Jeparit.
