The Factories and Shops Acts. REGULATION OF BAKERS' SHOPS IN THE BOROUGH OF MALVERN.

At the Executive Council Chamber, Melbourne, the twenty-sixth day of March, 1901,

WHEREAS by the Factories and Shops Acts it is enacted that the Governor in Council may make regulations to have effect within any specified municipal district or any specified part of such district for, amongst other things, permitting shops of any particular class not included in the Fourth Schedule to the Factories and Shops Acts, provided a petition shall have been previously addressed to the Governor in Council and forwarded to the Minister, certified to by the municipal clerk as having been signed by a majority of the shopkeepers keeping shops of such class within such district: And whereas a petition has been so addressed and forwarded praying that in the municipal district of the Borough of Malvern all bakers' shops (such shops being shops not included in the Fourth Schedule to the Factories and Shops Act 1890 aforesaid) may be permitted to keep open until Nine o'clock in the evening on Monday, Tuesday, Wednesday, Thursday, and Friday, and until Eleven o'clock in the evening on Saturday in each week: And whereas such petition has been certified to by the municipal clerk of the said district as having been signed by a majority

of the shopkeepers keeping shops of such class within the said district: Now therefore His Excellency the Lieutenaut-Governor of the State of Victoria, with the advice of the Executive Council thereof, doth hereby make the following Regulation, that is to

It shall be lawful for the shop of any baker within the municipal district of the Borough of Malvern to keep open on the evenings of Monday, Thesday, Wednesday, Thursday, and Friday from Seven o'clock until Nine o'clock, and from Ten o'clock until Eleven o'clock on the evening of Saturday in each week.

And the Honorable Alexander James Peacock, His Majesty's Minister of Labour for the State of Victoria aforesaid, shall give the necessary directions herein accordingly.

WHEREAS by the Factories and Shops Acts it is amongst other things enacted that the Governor in Council may from time to time and at any time make an Order extending the provisions of the said Acts which relate to shops to any particular class of shops, or to the whole of the shops in the whole or any specified part of any shire, if the majority of the shopkeepers keeping shops of that particular class or of the whole of the shopkeepers (as the case may be) in the locality to be affected have petitioned for such extension: And whereas a majority of the whole of the shopkeepers keeping shops in the Township of Seymour within the Municipal District of the Shire of Seymour have petitioned the Lieutenant-Governor in Council to make an Order extending the provisions aforesaid to the whole of the shops in the said part of the said shire, and the numicipal clerk of the said shire has certified to that effect as provided in the said Acts: Now therefore His Excellency the Lieutenant-Governor of the State of Victoria, with the advice of the Executive Council thereof, doth by this Order extend the provisions of the Factories and Shops Acts which relate to shops to the whole of the shops in the Township of Seymour within the Municipal District of the Shire of Seymour aforesaid.

Wilereas under the provisions of the Factories and Shops Acts a Special Board has been appointed to determine the lowest prices or rates which may be paid to any person or persons or classes of persons employed in wholly or partly preparing or manufacturing shirts, shirt-fronts, pyjamas, and collars and cuffs of every description: And whereas under the said Factories and Shops Acts it is amongst other things enacted that where any person or persons or classes of persons is or are employed by any employer in preparing or manufacturing articles the lowest prices or rates of payment for preparing or manufacturing, which have been determined by a Special Board, then if so directed by the Governor in Council any Special Board shall also determine the lowest prices or rates of payment which may be paid by any employer to such person or persons or classes of persons for wholly or partly preparing or manufacturing, either inside or outside a factory or work-room, any particular articles whatsoever: And whereas the Shirt Board has fixed the lowest prices or rates which may be paid to any person or persons or classes of persons employed in wholly or partly preparing or manufacturing shirts, shirt-fronts, pyjamas, and collars and cuffs of every description: And whereas such persons are in one or more factories or work-rooms also employed in wholly or partly preparing or manufacturing men's underpants except knitted goods: Now therefore His Exceellency the Lieutenant-Governor of the State of Victoria, with the advice of the Executive Council thereof, doth hereby direct that the Shirt Board shall also, in the manner prescribed in section 15 of the Factories and Shops Act 1800, determine the lowest prices or rates of payment which may be paid by any employer to any person or

persons or classes of persons employed in wholly or partly preparing or manufacturing, either inside or outside a factory or work-room, all classes of men's underpants, except knitted goods goods.

And the Honorable Alexander James Peacock, His Majosty's Minister of Labour for the State of Victoria aforesaid, shall give the necessary directions herein accordingly.

### RE-ELECTION OF A CLOTHING BOARD.

NDER the Regulations made pursuant to the Factories and Shops Acts, the Under-Secretary is the returning officer at elections of Special Boards; and "every candidate as a representative of employers on any Special Board shall be nominated, in writing, by ten electors (three representatives of the employers shall be nominated as representatives of makers of ready-made clothing, and two representatives of the employers shall be nominated as representatives of employers on any Special Board shall be nominated as representatives of employers on any Special Board shall be nominated, in writing, by twenty-five Special Board shall be nominated, in writing, by twenty-five electors; provided that a nomination by not less than one-fifth of the whole number of employers or of employe's (as the case may be) on the electors' roll prepared by the Chief Inspector of Factories shall be sufficient, and every nomination shall contain the written consent of the candidate to his nomination, and shall be delivered or posted to the returning officer so as to reach him before Four o'clock on the day of nomination."

In the event of the number of persons nominated either as representatives of employers or as representatives of employes exceeding five (the number to be elected in each case), the day for taking the poll (by voting-papers) will be Monday, the 29th day of April, 1901.

· Forms for nomination may be obtained on application to the Chief Inspector of Factories, Melbourne.

The envelope containing the nomination should be marked "Nomination Paper, Special Board," and be addressed to—

and must be delivered or posted so as to reach me before Four o'clock on Friday, the 12th day of April, 1901.
