FIXING THE TIME FOR HOLDING THE SECOND SESSION OF THE EIGHTEENTH PARLIAMENT OF VICTORIA.

PROCLAMATION

By His Excellency the Honorable Sir John Madden, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Lieutenant-Governor of the State of Victoria and its Dependencies, in the Commonwealth of Australia.

WHEREAS by The Constitution Act it was amongst other things enacted that it should be lawful for the Governor to fix such places within Victoria, and, subject to the limitation therein contained, such times for holding the first and every other Session of the Council and Assembly, and to vary and alter the same respectively in such manner as he might think fit; and also from time to time to prorogue the said Council d No. 65.—June 4, 1901.—1.

Assembly, and to dissolve the said Assembly, by Proclamation or otherwise, whenever he should deem it expedient: And whereas the said Council and Assembly, called "The Parliament of Victoria" stand prorogued until Tuesday, the 18th day of June, 1901, and it is expedient to fix the time for holding the next Session thereof: Now therefore I, the Lieutenant-Governor of the State of Victoria, in the Commonwealth of Australia, in exercise of the power conferred by the said Act, do by this my Proclamation fix Tuesday, the 18th day of June, 1901, aforesaid, as the time for the commencent and holding of the next Session of the said Council and Assembly, called the Parliament of Victoria, for the despatch of business, at the hour of Two o'clock in the afternoon, in the State Parliament Houses, situate in the Carlton Gardens, in the City of Melbourne: And the Homorable the Members of the Legislative Assembly are hereby required to give their attendance a' the said time and place accordingly.

Given under my Hand and the Seal of the State of Victoria, at Melbourne, this fourth day of June, in the year of our Lord One thousand nine hundred and one, and in the first year of His Majesty's reign.
