WHEREAS by the operation of the Factories and Shops Acts the term of office of the ten members of the Shirt Board, five of whom were representatives of employers and five of employe's, expired on the 31st day of July, 1900: And whereas by Regulations made pursuant to the Factories and Shops Acts it is provided that the Governor in Council may, by Order published in the Government Guettle, appoint a day on or before which nominations of candidates for election on any Special Board shall be received by the Returning Officer and a day for the election: Now therefore His Excellency the Lieutenant-Governor of the State of Victoria, with the advice of the Executive Council thereof, doth by this Order appoint Friday, the 28th day of June, 1901, to be the day on or before which nominations of candidates for election as representatives of employers and also as represent

RE-APPOINTMENT OF A SHIRT BOARD.

NDER the Regulations made pursuant to the Factories and Shops Acts, the Under Secretary is the Factories and Shops Acts, the Under Secretary is the returning officer at elections of Special Boards; and "every candidate as a representative of employers on any Special Board shall be nominated, No. 76.-June 18, 1901.-1.

in writing, by ten electors, and every candidate as a representative of employés on any Special Board shall be nominated, in writing, by twenty-five electors: provided that a nomination by not less than one-fifth of the whole number of employers or of employes (as the case may be) on the electors' roll prepared by the Chief Inspector of Factories shall be sufficient; and every nomination shall contain the written consent of the candidate to his nomination, and shall be delivered or posted to the returning officer so as to reach him before Four o'clock on the day of nomination."

The number of electors on the roll working outside a factory or work-room being greater than one-fifth of the whole number of electors on the roll for the election of the Shirt Board who are employés, electors working outside a factory or work-room will be entitled to nominate candidates, and to vote for and elect one member of such Special Board, but will not be entitled to nominate or vote for any person as a representative of persons working inside a factory or work-room; and electors working in a registered factory or work-room will not be entitled to vote for any person nominated for election as a special representative of persons working outside a registered factory or work-room.

The electors working inside a factory or work-room will be

The electors working inside a factory or work-room will be entitled to nominate candidates, and to vote for and elect four members of such Special Board.

In the event of the number of persons nominated either as representatives of employers or as representatives of employers so for taking the boll (by voting-papers) will be Friday, the 12th day of July, 1901.

Factories and Shops Acts. REGULATION FOR TOBACCONISTS' SHOPS IN THE TOWN OF BRIGHTON.

At the Executive Council Chamber, Melbourne, the seventeenth day of June, 1901.

WHEREAS by the Factories and Shops Acts it is enacted that the Governor in Council may make regulations to have effect within any specified municipal district or any specified part of such district for amongst other things-limiting the hours generally or on a particular day in the week during which shops mentioned in the Fourth Schedule to the Factories and

Shops Act 1890 within such district may be kept open, provided a petition shall have been previously addressed to the Governor in Council and forwarded to the Minister, certified to by the municipal clerk as having been signed by a majority of all the shopkeepers keeping shops of the class within such municipal district to be affected thereby: And whereas a petition has been so addressed and forwarded praying that a regulation be made limiting in the municipal district of the Town of Brighton the hours during which tobacconists' shops being shops mention ed in the Fourth Schedule to the Factories and Shops Act 1890 aforesaid) may be kept open by directing that they shall be 'closed from the hour of One o'clock in the afternoon on Wednesday, and from the hour of Nine o'clock in the afternoon on Wednesday, and from the hour of Nine o'clock in the evening on Monday, Tuesday, Thursday, and Friday in each and every week: And whereas such petition has been certified to by the municipal clerk of the said town as having been signed by a majority of the shopkeepers keeping shops of the class to be affected thereby: Now therefore His Excellency the Lieutemant-Governor of the State of Victoria, with the advice of the Executive Council thereof, doth by this Order make the following Regulation, that is to say:—

All tobacconists' shops in the municipal district of the Town

W HEREAS under the provisions of the Factories and Shops Acts a Special Board was appointed on the 20th day of December, 1900, to fix the lowest prices or rates which may be paid to any person or persons, or classes of persons, employed in the process, trade, or business of manufacturing harness, saddery, and whip thongs: And whereas under the Factories and Shops Acts it is amongst other things provided that a Special Board in fixing the lowest prices or rates which may be paid to any person or persons, or classes of persons, employed in any process, trade, or business usually or frequently carried on in a factory or work-room, shall take into consideration the rature, kind, and class of the work, and the age and the sex of the workers, and any matter which may from time to time be prescribed: Now therefore His Excellency the Lieutenant-Governor of the State of Victoria, with the advice of the Executive Council thereof, doth by this Order make the following Regulation, that is to say:—

The Saddlery Board when fixing the lowest prices or rates

The Saddlery Board when fixing the lowest prices or rates which may be paid to any person or persons, or classes of persons, shall take into consideration the quantity or amount of work to be done for any lowest prices or rates fixed by such Special Board.

And the Honorable Alexander James Peacock, His Majesty's Minister of Labour for the State of Victoria, shall give the necessary directions herein accordingly.
