PROCLAMATION

By His Excellency the Honorable Sir John Madden, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Lieutenant-Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia.

IN pursuance of the provisions contained in Part III. of the *Banks and Currency Act 1890* (54 Vict. No. 1164), and in the *Public and Bank Holidays Act 1897* (61 Vict. No. 1534), and by virtue of the authority conferred by Letters Patent under the Great Seal of the United Kingdom, dated 29th October, 1900, relating, amongst other things, to the exercise of powers during the temporary absence of the Governor of the State, I, the Lieutenant-Governor of the State of Victoria in the Commonwealth of Australia, do by this my Proclamation appoint the days and dates named here-under special days to be observed as Bank Half-Holidays, from the hour of Twelve o'clock noon on each day, at the places respectively mentioned, that is to say:—
