**PROCLAMATION**

By His Excellency Sir George Sydenham Clarke, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George; Fellow of the Royal Society; Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

IN pursuance of the provisions contained in Part III. of the *Banks and Currency Act 1850* (54 Vict. No. 1164), and in the *Public and Bank Holidays Act 1897* (61 Vict. No. 1534), I, the Governor of the State of Victoria in the Commonwealth of Australia, do by this my Proclamation appoint the days and dates named hereunder special days to be observed as Bank Half-Holidays, from the hour of Twelve o'clock noon on each day, at the places respectively mentioned, that is to say:—

TUESDAY, THE 6TH DAY OF MAY, 1902, at Casterton; and  
WEDNESDAY, THE 7TH DAY OF MAY, 1902, at Rochester.
