Factories and Shops Acts.

DETERMINATION OF THE CLOTHING BOARD.

IN accordance with the provisions of the Factories and Shops Acts, the Special Board appointed to determine the lowest prices or rates which may be paid to any person for wholly or partly preparing or manufacturing, either inside or outside a factory or work-room, the following articles of Men's and Boys' Clothing or Wearing Apparel, namely, Coats (including Overcoats and Cloaks of every description), Vests, Trousers, Jackets, and Knickerbockers, except Indiarubber Waterproof Garments, has made the following Determination, namely:—

1. That the clauses relating to the number of female apprentices or improvers who may be employed, on pages 4292 and 4309 of the Board's Determination, dated the 18th day of November, 1901, be cancelled and annulled.

2. That the number of female apprentices or improvers who may be employed in any factory or work-room in the Clothing Trade shall be as follows:—

Two apprentices or improvers to every three females employed inside a factory or work-room, and being paid not less than 3s. 4d. per day of eight hours, or piece-work rate, provided that the said females be so employed in the said factory or work-room continuously for nine successive months, except in the case of any person or persons commencing business, when the provision respecting the employment of such females shall not be enforced.

3. That the above Determination shall come into force from and after the 16th day of June, 1902.
