Printed forms of application may be obtained at any post office, or the application may be in writing.

If applicant is the holder of an elector's right, such right must be attached to application.

Any Elector who intends to vote through the post must apply at once, as no Postal Ballot-paper will be supplied unless the Returning Officer receives application therefor sufficiently early to admit of Postal Ballot-paper being sent to and returned by such Elector so as to reach the Returning Officer before closing of Poll of Poll,

Caution.—Any person wilfully making a false statement in an application is liable on conviction to two years' imprisonment.
