#### PUBLIC AND BANK HOLIDAYS.

#### PROCLAMATION

By His Excellency Sir George Sydenham Clarke, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George; Fellow of the Royal Society; Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c.

IN pursuance of the provisions contained in Part VI. of the Public Service Act 1890 (54 Vict. No. 1133), in Part III. of the Banks and Currency Act 1890 (54 Vict. No. 1164), and in the Public and Bank Holidays Act 1897 (61 Vict. No. 1534), I, the Governor of the State of Victoria in the Commonwealth of Australia, with the advice of the Executive Council of the said State, do by this my Proclamation appoint the days and dates hereunder mentioned to be observed as Public Holidays or Bank Holidays (as the case may be) at the places respectively specified, viz.:—

WEDNESDAY, THE 25TH DAY OF FEBRUARY, 1903, as a Public Holiday throughout the United Shire of Mount Alexander, the Shires of Kyneton, Newstead, Romsey, Strathfieldsaye, and Yea, as a Bank Holiday at Newstead and Traralgon, and as a Bank Half-Holiday, from the hour of Twelve o'clock noon, at Romsey;

THURSDAY, THE 26TH DAY OF FEBRUARY 1903, as a Public Holiday throughout the Towns of Northcote and Port Melbourne, the Borough of Flemington and Konsington, the Shires of Bairnsdale,\* Moorabbin, and Winchelsea, and as a Bank Holiday at Cheltenham;

Wednesday, the 4th day of March, 1903, as a Public Holiday throughout the City of Hawthorn, the Shires of Avoca, Kerang, Lillydale, Mirboo, Rodney, and Shepparton, the Tatong Riding of the Shire of Benalla, and the North Riding of the Shire of Euroa, and as a Bank Half-Holiday, from the hour of Twelve o'clock noon, at Shepparton.

Thursday, the 5th day of March, 1903, as a Public Holiday throughout the Shire of Lillydale, and as a Bank Half-Holiday, from the hour of Twelve o'clock noon, at Rosedale;

- FRIDAY, THE 6TH DAY OF MARCH, 1903, as a Bank Half-Holiday, from the hour of Twelve o'clock noon, at Pyramid Hill;

FRIDAY, THE 13TH DAY OF MARCH, 1903, as a Public Half-Holiday, from the hour of Twelve o'clock noon, throughout the Shire of Doncaster;

Tuesday, the 17th day of March, 1903, as a Public Holiday throughout the Borough of St. Arnaud, the United Shire of Beechworth, the Shires of Bacchus Marsh, Benalla, Castle Donnington,\* Kara Kara, Maldon, and McIvor, the South-East Riding of the Shire of Kersng, and the South Riding of the Shire of Korong, and as a Bank Half-Holiday, from the hour of Twelve o'clock noon, at Benalla, Heyfield, Pyramid Hill, Swan Hill, and St. Arnaud;

WEDNESDAY, THE 18TH DAY OF MARCH, 1903, as a Public Holiday throughout the City of Richmond, the Borough of Talbot, and the Shires of Alberton, Donald, Dundas, Frankston and Hastings, Mount Rouse, Portland, Shepparton,\* and Tullaroop;

THURSDAY, THE 19TH DAY OF MARCH, 1903, as a Public Holiday throughout the Shires of Avon and Maffra.

#### ANGLESEY ELECTORAL DISTIOT.

ANGLESSY ELECTORAL DISTICT.

A N Election of a Member of the Legislative Assembly is about to be held in the above-mentioned Electoral District, and any Elector thereof who appears from the rolls to reside in such District, and who resides at least five miles from the nearest polling booth at which he is entitled to vote, or who has reason to believe that on the polling day he will not be within five miles of the nearest polling booth at which he is entitled to vote, or that on account of ill-health or infirmity he will be prevented from voting personally thereat, who desires to vote through the post office at such Election may, on posting an application to the Returning Officer, obtain a Postal Ballot-paper enabling him to vote through the post at such Election.

Printed forms of application may be obtained at any post office, or the application may be in writing.

If applicant is the holder of an elector's right, such right must be attached to application.

Any Elector who intends to vote through the post must apply at once, as no Postal Ballot-paper will be supplied unless the Returning Officer receives application therefor sufficiently early to admit of Postal Ballot-paper being sent to and returned by such Elector so as to reach the Returning Officer before closing of Poll

Caution.—Any person wilfully making a false statement in an application is liable on conviction to two years' imprisonment.
