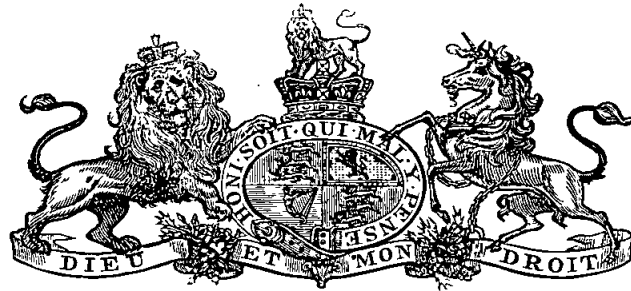

BANK HALF-HOLIDAYS.—PROCLAMATION PARTLY REVOKED AND BANK HALF-HOLIDAYS APPOINTED.

PROCLAMATION

By His Excellency Sir George Sydenham Clarke, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George; Fellow of the Royal Society; Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

IN pursuance of the provisions contained in Part III. of the *Banks and Currency Act 1890* (54 Vict. No. 1164), and in the *Public and Bank Holidays Act 1897* (61 Vict. No. 1534), I, the Governor of the State of Victoria in the Commonwealth of Australia, do hereby revoke (in part) the Proclamation made under my Hand and the Seal of the State, bearing date the nineteenth day of February, 1903, so far only as the same relates to the appointment of Tuesday, the 17th day of March, 1903, as a Bank Half-Holiday, from the hour of Twelve o'clock noon, at Swan Hill; and I do also by this my Proclamation appoint the days and dates named hereunder special days to be observed as Bank Half-Holidays, from the hour of Twelve o'clock noon on each day, at the places respectively mentioned, that is to say:—

WEDNESDAY, THE 11TH DAY OF MARCH, 1903, at Carisbrook, Loch, and Maryborough;

TUESDAY, THE 17TH DAY OF MARCH, 1903, at Apsley, Bacchus Marsh, Kyneton, and Morwell;

WEDNESDAY, THE 18TH DAY OF MARCH, 1903, at Carisbrook, Hamilton, Kilmore, and Maryborough;

THURSDAY, THE 19TH DAY OF MARCH, 1903, at Coldden;

WEDNESDAY, THE 25TH DAY OF MARCH, 1903, at Beaufort.
