By His Excellency Sir George Sydenham Clarke, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George; Fellow of the Royal Society; Governor of the State of Victoria and its Dependencies in the Common-wealth of Australia, &c., &c., &c.

WHEREAS The Parliament of Victoria stands prorogued until Tuesday, the twenty-first day of July, 1903: Now I, the Governor of the State of Victoria in the Commonwealth of Australia, do by this my Proclamation further prorogue the said Parliament of Victoria until Tuesday, the eighteenth day of August, 1903.

Given under my Hand and the Seal of the State of Victoria aforesaid, at Melbourne, this fourteenth day of July, in the year of our Lord One thousand nine hundred and three, and in the third year of His Majesty's reign.
