KONONGWOOTONG SOUTH ESTATE.

REQUISITION AS TO THE TAKING OF LAND COMPULSORILY UNDER THE CLOSER SETTLEMENT ACT 1904 (NO. 1962).

WHEREAS on the ninth day of September, 1907, the Clerk of the Parliaments certified that, in pursuance of the above-mentioned Act, the Legislative Council and the Legislative Assembly have agreed to a resolution affirming that it is desirable to take compulsorily the whole of the land comprised in what is known as the Konongwootong South Estate, containing an area of 10,038 acres, in the State of Victoria, described in the Schedule hereunder, owned by The Perpetual Executors and Trustees Association of Australia Limited, of 51 Queen-street, Melbourne, and Frank Suetonius Officer, Esquire, of Melbourne, as trustees of the late Archibald Johnson: And whereas the Honorable John Emanuel Mackey, Minister of Lands, has directed the Lands Purchase and Management Board to acquire the said land compulsorily: Notice is hereby given that, in pursuance of such resolution and authorization, the said Board, on behalf of His Majesty, will take compulsorily, under the provisions of the *Closer Settlement Act 1904*, the land as aforesaid, and the owners of the said land and also every other person having an estate or interest therein, are hereby required to serve their respective claims for compensation on the Lands Purchase and Management Board at the Public Offices, Melbourne, in the form and manner and within the period provided by the said Act.
