DISCHARGING MEMBERS OF THE LEGISLATIVE COUNCIL FROM ATTENDANCE AND DISSOLVING THE LEGISLATIVE ASSEMBLY.

By His Excellency Sir Thomas David Gibson Carmichael, Baronet, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

W HEREAS the Legislative Council and the Legislative Assembly, called "The Parliament of Victoria," stand prorogued until Tuesday, the 15th day of December, 1908: And whereas it is expedient to dissolve the Legislative Assembly: Now I, the Governor of the State of Victoria in the Commonwealth of Australia, in exercise of the power in me vested in this behalf, do by this my Proclamation discharge the Honorable the Members of the Legislative Council from their meeting and attendance by this my Proclamation discharge the Honorable the Members of the Legislative Assembly, which is hereby dissolved on Tuesday, the 15th day of December, 1908, aforesaid; and I do dissolve the Legislative Assembly, which is hereby dissolved accordingly: And I do hereby declare that I have this day given Order that Writs be issued in due form, and according to law, for the election of Members to be duly returned to serve in the Legislative Assembly.

Given under my Hand and the Seal of the State of Victoria aforesaid, at Melbourne, this seventh day of December, in the year of our Lord One thousand nine hundred and eight, and in the eighth year of His Majesty's reign.
