No. 1432), it is among other things provided that the Governor in Council, by Proclamation in the Government Gazette, may, either absolutely or subject to any regulations, prohibit the importation, introduction, or bringing into Victoria of any tree, plant, or vegetable which is, in the opinion of the Governor in Council, likely to introduce any disease or insect into Victoria: And whereas, in the opinion of the Governor in Council, the introduction of potatoes from the State of Tasmania is likely to introduce disease into Victoria: Now therefore I, the Governor of the State of Victoria in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this my Proclamation prohibit the importation, introduction, or, bringing into Victoria of potatoes from the State of Tasmania.
