#### PUBLIC HOLIDAYS.

#### PROCLAMATION

By His Excellency Sir Thomas David Gibson Carmichael, Baronet, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George; Governor of the State of Victoria and its Dependencies in the Com-monwealth of Australia, &c., &c., &c.

In pursuance of the provisions contained in Part VI. of the Public Service Act 1890 (54 Vict. No. 1133), I, the Governor of the State of Victoria in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this my Proclamation appoint the days and dates hereunder mentioned to be observed as Public Holidays or Public Half-Holidays (as the case may be) at the places respectively specified, viz.:—

WEDNESDAY, THE 17TH DAY OF FEBRUARY, 1909, throughout the Shire of East Loddon;

Tuesday, the 23RD day of February, 1909, throughout the Shire of Whittlesea;

WEDNESDAY, THE 24TH DAY OF FEBRUARY, 1909, throughout the Shire of Waranga, the East Riding of the Shire of Dunmunkle, and the East Riding of the Shire of Goulburn;

WEDNESDAY, THE 3RD DAY OF MARCH, 1909, within the Borough of Hamilton, throughout the Shires of Buln Buln, Strathfieldsaye, and the North Riding of the Shire of Eitham, and from the hour of Twelve o'clock noon, throughout the Shire of Bunneckburn;
