Factories and Shops Acts.

DETERMINATION OF THE LIFT BOARD.

IN accordance with the provisions of the Factories and Shops Acts, the Special Board appointed to determine the lowest prices or rates which may be paid to any person or persons or classes of persons employed in the process, trade, business, or occupation of Lift Attendant has made the following Determi-

(1) That previous Determinations of this Board are hereby amended, and such amendments shall come into force, and be operative on and after the fourth day of November, 1912.

The Determination and amendments are printed hereunder.

2. That the lowest rates of wages to be paid to the following persons shall be-

(a) Lift Attendants who are employed in lifts in hotels,

clubs, coffee palaces, restaurants, or hospitals ... 40s. per week of 58 hours (b) All other Lift Attendants 42s. per week of 50 hours

APPRENTICES.

NUMBER.

3. That the number of apprentices who may be employed within any factory or shop or place shall be one apprentice to two or fraction of two adults receiving the minimum wage.

IMPROVERS.

NUMBER.

4. That the number of improvers who may be employed within any factory or shop or place shall be one improver to two adults receiving the minimum wage.

That the lowest rates of payment payable to apprentices or im overs shall be-

Apprentices or improvers employed in lifts in hotels, clubs, coffee palaces, restaurants, and

For the 1st year's experience 25s. per week of 58 hours For the 2nd year's experience ... 27s. ēd. For the 3rd year's experience ...

and thereafter the minimum wage.

Apprentices or improvers employed in lifts other than those in hotels, clubs, coffee palaces restaurants, and hospitals :-

For the 1st year's experience ... 25s. per week of 50 hours For the 2nd year's experience ... **3**0s. For the 3rd year's experience 35s.

and thereafter the minimum wage.

TIME OF BEGINNING AND ENDING WORK.

5. That the time of beginning and ending work in any lift other than those in hotels, clubs, coffee palaces, restaurants, and hospitals shall be—

Time of Beginning.
8 a.m.

1.15 p.m. on Saturdays or the other working day of the week on which the half-holiday is locally observed.

10.15 p.m. on the customary late trading night, or

night previous to a public holiday.
7 p.m. on all other days.

OVERTIME.

- 6. That the following rates shall be paid for work done during the times specified hereunder, viz. :-
 - (a) Lift Attendants employed in hotels, clubs, coffee palaces, restaurants, and hospitals:—

For work done in excess of the maximum number of time and a half.

(b) All other Lift Attendants:-

For work done in excess of the maximum number of hours fixed for a week's work or for work done outside the hours specified in Clause 5 as the times of beginning and ending work on any day

Time and a half.

SPECIAL RATES FOR SUNDAYS AND PUBLIC HOLIDAYS.

7. That the special rates of payment to Lift Attendants for all work done in connexion with a lift on the undermentioned public holidays shall be as follows:—

(a) Lift Attendants employed in lifts in hotels, clubs, coffee palaces, restaurants, and hospitals:—

Good Friday,
Easter Monday,
New Year's Day,
Eight Hours Day,
King's Birthday,
Christmas Day, and
Boxing Day,

or such other day as may be observed as a public holiday in lieu thereof,

(b) All other Lift Attendants:-

Sundays, Good Friday, Christmas Day,

Double time.

26th January, Easter Monday, Eight Hours Day, King's Birthday, Boxing Day, New Year's Day,

or such other day as may be observed as a public holiday in lieu thereof,

Time and a half.
