REQULATION No. 20.

A Regulation of the City of Malvern, numbered 20, made under the first section of Part 5 of 13th Schedule to the Local Government Act 1903, in force in the city by virtue of a By-law of the above-named city, numbered 37, for regulating the height, thickness, construction, and materials of the party walls of buildings adjoining each other and of the external walls of buildings and of chimneys and the materials for and mode of enclosing same.

In pursuance of the Local Government Act 1903, the Mayor, Councillors, and Citizens of the City of Malvern make the Regulation following.—

1. The whole of this Regulation shall apply to and have force and effect throughout the said City of Malvern with respect to all buildings which are constructed or creeted within 100 feet of the building line of the streets mentioned in the Schedule hereto.

2. No building, the external walls of which are of other materials than stone or brick, shall be built in any of the streets specified in the Schedule hereto nor for a distance of 50 feet on either side of such streets.
