## PROCLAMATION

HEREAS The Parliament of Victoria stands prorogued until Tue-day, the fifth day of May, 1914: Now I, the Governor of the State of Victoria in the Commonwealth of Australia, do by this my Proclamation further prorogue the said Parliament of Victoria until Tucsday, the second day of June, 1914.
