PROCLAMATION

By His Excellency the Honorable Sir Arthur Lyulph Stauley, Knight Commander of the Most
Distinguished Order of Saint Michael and Saint George; Governor of the State of Victoria and
its Dependencies in the Commonwealth of Australia, &c., &c.

HEREAS The Parliament of Victoria stands adjourned until Tuesday, the twelfth day of January, 1915: Now I, the Governor of the State of Victoria in the Commonwealth of Australia, do by this my Proclamation prorogue the said Parliament of Victoria until Tuesday, the ninth day of February, 1915.

Given under my Hand and the Seal of the State of Victoria aforesaid, at Melbourne, this sixth day of January, in the year of our Lord One thousand nine hundred and fifteen, and in the fifth year of the reign of His Majesty King George V.
