By His Excellency the Honorable Sir Arthur Lyulph Stanley, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George; Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

In pursuance of the provisions contained in Part III. of the Banks and Currency Act 1915 (6 Geo. V. No. 2618), I, the Governor of the State of Victoria in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this my Proclamation appoint the days and dates named hereunder special days to be observed as a Bank Holiday or Bank Half-Holidays (as the case may be), at the places respectively mentioned, that is to say:—

THURSDAY, THE 22ND DAY OF NOVEMBER, 1917, at Mans-

WEDNESDAY, THE 12TH DAY OF DECEMBER, 1917, at Warragul.
