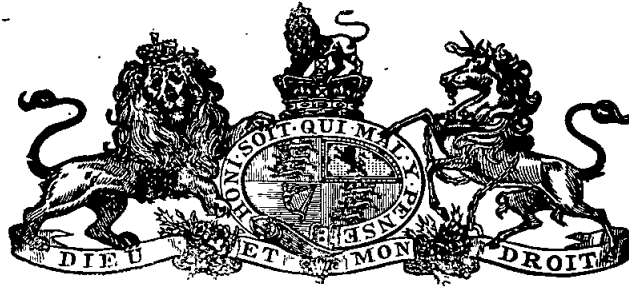

Factories and Shops Acts.

## DETERMINATION OF THE CHEMISTS' SHOPS BOARD.

**NOTE.**—This Determination on the 1st July, 1918, applied to the following parts of Victoria, viz.:—The Metropolitan District as defined in the Factories and Shops Acts, the Cities of Ballarat, Bendigo, Geelong, and Warrnambool; the Town of Ballarat East; and the Boroughs of Eaglehawk, Geelong West, Newtown and Chilwell, and Sebastopol.

**I**N accordance with the provisions of the Factories and Shops Acts, the Special Board appointed to determine the lowest prices or rates which may be paid to any persons employed in a shop dispensing, compounding, or selling medicines, drugs, or medicinal preparations has made the following Determination, namely:—

(1) That this Determination shall be operative on and after the 1st day of July, 1918.

(3) OVERTIME.—Any employee who in any week works for any time in excess of 51 hours shall be paid for such extra time at the rate of time and a half.

(4) SPECIAL RATES.—Time and a half shall be the rate payable for all work done on New Year's Day, 26th January (Foundation Day), Good Friday, Easter Monday, 21st April (Eight Hours Day), 3rd June (King's Birthday), Christmas Day, or Boxing Day; but if any other day be by Act of Parliament or Proclamation substituted for any of the above-named holidays, the special rate shall be payable only for work done on the day so substituted.
