11. Tea Money.—An allowance, to procure a meal, of One shilling and sixpence may be paid to officers who are required to work after office hours, provided that no payment shall be made unless an officer works after Five o'clock p.m. for at least two hours in addition to the interval of one hour taken for tea.

Such payment may, however, be made to Warders who are required to remain continuously on duty at the Law Courts later than half-past Seven o'clock p.m.

Officers in charge are to carefully watch that no abuse of this Regulation is permitted.

REGULATIONS FOR THE CARE, PROTECTION, AND MANAGEMENT  
OF THE SNOWDEN GARDENS.

WHEREAS by an Order of the Governor in Council made pursuant to sub-section B of section 4 of the *Prince's Bridge Approach Act 1900* (No. 1681) the lands described in the Second Schedule to the said Act and known as "Snowden Gardens (hereinafter referred to as "the Gardens")" were vested in the Corporation of the Mayor, Aldermen, Councillors, and Citizens of the City of Melbourne as sites for ornamental reserves and for no other purpose whatsoever And whereas by the same Order the Council for the time being of the Corporation were appointed to be the Trustees of such lands And whereas by section 182 of the *Land Act 1915* power is given to the said Council as therein stated to make Rules and Regulations for the care protection and management of the said lands and for the preservation of good order and decency therein. Now therefore the Council of the City of Melbourne (hereinafter referred to as "the Council") in pursuance of the power conferred as aforesaid doth hereby make the Regulations following:—

REGULATIONS.

1. No person in a state of intoxication, or who is disorderly or is not decorously dressed, shall enter or remain in the Gardens, and no person shall commit therein any nuisance or any indecent or offensive act.
2. No person shall interfere with, remove, damage, or destroy the seats, trees, shrubs, grass, flowers, statuary, fountains, fish, or any property in the Gardens, or throw stones or other missiles or light fires therein, or leave in the Gardens any bottles, fruit-peel, paper, cast-off clothing, litter, or refuse of any kind.
3. No person shall climb on or jump over the seats or fences in or around the Gardens, or lie on the seats or grass, or stick bills on the fences, gates, seats, trees, posts or other structures, or cut names, letters, or marks on the trees, seats, gates, posts, or fences or other structures, or otherwise deface the same or write thereon.
4. No person shall bring into the Gardens any dog, unless held by a chain or cord, and all goats or poultry found therein shall be liable to be destroyed.
5. No person, except workmen employed in the Gardens, shall enter any plots therein which may be enclosed for plantations or for other purposes.
6. No assemblies for fêtes, picnics, or concerts, or for the purpose of public worship, preaching or public speaking of any kind, or meetings of a like character, shall take place in the Gardens, without the permission in writing of the Council first obtained.
7. No person, unless authorized by the Council in writing, shall offer or expose for sale in the Gardens any article, fruit, or merchandise.
8. No person shall bring or allow to remain in the Gardens any horses, cattle, sheep, pigs, goats, fowls, or other animals.
9. No person except those in the employ of or authorized by the Council in writing shall bring into or use in the Gardens any cart, truck, bicycle, motor car, motor cycle, wheelbarrow, or other vehicle of any description whatsoever.
10. No person shall make or cause to be made any violent outcry, noise, disturbance, or sound, or shall play upon any musical or noisy instrument, or sing or harangue in the Gardens.
11. No person shall give out or distribute any hand-bills, placards, notices, advertisements, books, pamphlets, or papers in the Gardens, or shall litter the same by scattering or throwing down hand-bills, placards, notices, advertisements, books, pamphlets, or papers.

12. No person shall play at or engage in any game, athletic sport, or gymnastic exercises in the Gardens.

13. No children under five (5) years of age shall be allowed in the Gardens unless in charge of adult friends or nurses.

14. No person shall, without the consent in writing of the Council, carry, use, or discharge any firearms in the Gardens.

15. No person shall in any part of the Gardens wilfully obstruct, disturb, interrupt, or annoy any other person in the proper use of the Gardens, or wilfully obstruct in the execution of his duty or insult or neglect to obey the lawful directions of any park-keeper or other servant of the Council.

16. No person shall spit or expectorate on the paths or seats or on any structure or erection within the Gardens.

17. No booth, tent, or other structure shall be erected within the Gardens without the consent in writing of the Council.

Every person offending against these Regulations shall for each offence be liable to a penalty of not more than Five pounds; and every person who so offends, and who after he has been warned by any Bailiff of Crown Lands or officer or servant of the Council or by any member of the Police Force does not desist from so offending, may be forthwith apprehended by such bailiff, officer, or servant, or member of the Police Force and taken before some Justice, and shall be liable to a penalty of not more than Ten pounds.

ADDITIONAL REGULATIONS FOR THE CARE, PROTECTION, AND MANAGEMENT OF THE CHILDREN'S PLAYGROUND IN FLAGSTAFF GARDENS, IN THE CITY OF MELBOURNE.

WHEREAS by the Crown grant issued in favour of the Board of Land and Works and the Mayor, Aldermen, Councillors, and Citizens of the City of Melbourne and their successors in respect of Flagstaff Gardens, it is provided and declared that the land thereby granted (hereinafter called the said Gardens) and the buildings for the time being thereon shall be at all times thereafter maintained and used as and for a Public Garden and offices and conveniences connected therewith, under and in accordance with such Regulations as shall from time to time be made by the Governor or other officer for the time being administering the Government of the Colony (now State) of Victoria with the consent of the Executive Council thereof and in the meantime under and in accordance with such regulations as shall from time to time be made by the Board of Land and Works and the Mayor, Aldermen, Councillors, and Citizens of the said City of Melbourne and for no other purpose whatsoever And whereas the Governor in Council did on the ninth day of October One thousand nine hundred and seventeen in pursuance of section 183 of the *Land Act 1915* appoint the Council of the City of Melbourne (hereinafter called the Trustees) to be a Committee of Management of (*inter alia*) the said Gardens. Now therefore the Board of Land and Works and the Trustees do hereby make the following Regulations for the care, protection, and management of such portion of the said Gardens as is set apart for and hereinafter designated Children's Playground and for the preservation of good order and decency therein in addition to the existing Regulations in respect of the said Gardens.

REGULATIONS.

1. The Children's Playground shall be opened daily from 10 o'clock a.m. till sunset, except on Sundays and such other days as may from time to time be specially indicated by the Trustees.
2. Any person found within the Children's Playground except during the hours it is open to the public shall be guilty of a breach of these Regulations.
3. Although the Children's Playground is provided for the use of children only, mothers and female attendants shall be at liberty to be present to watch over them.
4. No male person above the age of twelve (12) years shall be admitted to the Playground.
5. No person above the age of twelve (12) years shall be allowed to use any of the swings or other appliances erected in the Children's Playground. Such swings or other appliances shall not be used by the same child or children for a longer period than five (5) minutes at any one time if any other children are waiting to use them.
6. No children shall use any of the swings or other appliances in the Children's Playground except in the ordinary way.
7. No cricket or football shall be played in the Children's Playground.
8. All paper, fruit, peel or other litter, shall be placed in the baskets provided by the Trustees for the purpose.
9. All persons in the Children's Playground shall obey the directions of the Caretaker thereof.

10. The Trustees shall not be responsible for any accident arising from the use of any of the swings or other appliances in the Children's Playground.

11. Any duly appointed officer or servant of the Trustees shall have the right (in addition to any other penalty under these Regulations) to remove or exclude from the Children's Playground any person who commits a breach of any of the Regulations, or who wilfully damages any of the swings or other appliances or any property in the Children's Playground.

Every person offending against these Regulations shall, in accordance with section 182 of the *Land Act 1915* on conviction before any Justice, be liable to a penalty not exceeding Five pounds for each offence, and every person who so offends, and who after he has been warned by any Bailiff or Crown Lands officer, or servant of the Trustees or by any constable does not desist from so offending may be forthwith apprehended by such bailiff, officer or servant or constable and taken before some Justice and shall on conviction be liable to a penalty not exceeding Ten pounds.

WE, Richard Andrew Gibson, John Finn, John Baulch, jun., Joseph Tilley, James Steele, Edward Hanley, and John William Malcolm, the duly appointed Committee of Management of the land temporarily reserved by Order in Council of 30th April, 1912, as a site for Show Grounds in the borough of Port Fairy, having framed the following Regulations for the care, protection, and management thereof, and for the preservation of good order and decency therein, and also for the collection and receipt of tolls, entrance fees, or other charges for entering therein or thereupon, submit the said Regulations to the Board of Land and Works, to be made by such Board, in pursuance of the powers conferred by section 181 of the *Land Act 1915*:—

##### REGULATIONS.

1. No person shall enter or remain in the Reserve who may offend against decency as regards dress, language, or conduct.
2. No person shall damage in any way the trees, shrubs, or flowers in the Reserve, nor shall fires be lighted therein.
3. Except on the occasion of the Annual Show of the Port Fairy and District Agricultural, Pastoral, and Horticultural Association, no person shall, without the consent in writing of the Committee of Management or of some person duly authorized by them, enter upon any part of the Reserve or any building, shed, or premises thereon.
4. No person shall without the consent in writing of the Committee of Management or of some person duly authorized by them enter or remain within any building, shed, tent, or other premises in the Reserve or in or upon any part thereof after 7.30 p.m.
5. The maximum scale of fees which may be charged and taken for admission to the Reserve on such days (not exceeding more than twelve (12) days in any one year) as the Reserve may be set apart for shows shall be as follows:—

For the admission of each person not under the age of twelve (12) years such a sum as the Committee of Management may determine not exceeding One shilling, and for each person under the age of twelve (12) years, Sixpence.

For the admission of each person to the grand-stand in the Reserve such a sum as the Committee of Management may determine not exceeding Two shillings and sixpence.

For the admission of each horse such a sum as the Committee of Management may determine not exceeding One shilling.

For the admission of each vehicle such a sum as the Committee of Management may determine not exceeding One shilling.

No person except the judge or judges, stewards, and officials appointed by the Committee of the Port Fairy and District Agricultural, Pastoral, and Horticultural Association to act in the particular class then exhibiting, exhibitors and authorized attendants and such persons as may be authorized by the Trustees shall enter the judge's box, the show ring, the judging ring, or any other place where exhibits are being judged in the Reserve.

No person shall enter the committee room, stewards' room, or offices of the Port Fairy and District Agricultural, Pastoral, and Horticultural Association or the approaches thereto, respectively, on the Reserve except the committee, stewards, and officials of the said association and those authorized by such committee or stewards.

No person shall climb or jump over the gates or fences in or around the Reserve, stick bills thereon, or cut names on, or in any way damage or injure any of the buildings, gates, fences, seats, or trees in the Reserve; nor leave or deposit any glass, paper, or rubbish; nor roll or throw stones or any missiles of any kind therein.

No person shall put in the Reserve any cattle, horses, sheep, goats, pigs, or other animals without the permission, in writing, of the Committee of Management first obtained. Provided always that the moneys received for agistment shall be expended in the maintenance and improvement of the Reserve, and that an account thereof shall be furnished annually to the Board of Land and Works.

No person shall bring into the Reserve any dog, unless led by a chain or cord, without the permission, in writing, of the Committee of Management first obtained.

No person shall camp in the Reserve nor erect therein any dwelling, nor any booth or other structure for the purpose of offering for sale any article, without the permission, in writing, of the Committee of Management first obtained.

No person shall bet publicly in any part of the Reserve, and every person infringing this Regulation shall be liable to expulsion from the enclosure and Reserve.

No person, except labourers and workmen employed in the Reserve, shall enter any plots therein which may be enclosed for plantations of young trees or shrubs.

Every person offending against any of these Regulations shall, in accordance with the provisions of section 181 of the *Land Act 1915*, for each offence be liable to a penalty of not more than Five pounds (£5), and every person who knowingly and wilfully offends against any such Regulations, and who, after he has been warned by any Bailiff of Crown Lands, or by any member of the Police Force, does not desist from so offending, may be forthwith apprehended by such bailiff or member of the Police Force and taken before some Justice and shall be liable to a penalty of not more than Ten pounds (£10).

Provided always that the moneys received for agistment shall be expended in the maintenance and improvement of the Reserve and that an account thereof shall be furnished annually to the Board of Land and Works.

6. No person shall bring into the Reserve any dog, unless led by a chain or cord without the permission in writing of the Committee of Management first obtained.

7. No person shall camp in the Reserve nor erect therein any dwelling, nor any booth or other structure for the purpose of offering for sale any article, without the permission in writing of the Committee of Management first obtained.

Persons renting or hiring any stand building erection or enclosure on the occasions of any fêtes, sports or holiday amusements may be required to deposit any sum which the Committee of Management may at any time determine, not exceeding Ten pounds by way of guarantee that due care shall be taken of such stand building erection or enclosure and such Committee in its absolute discretion may make good any damage or injury sustained by such stand building erection or enclosure or anything contained therein during such occupancy or hiring and deduct the cost of making good such loss or damage from the sum of money deposited by way of guarantee and all persons so renting or hiring shall abide by these Regulations and by any order given by the Committee of Management.

13. No person except labourers and workmen employed in the Reserve shall enter any plots therein which may be enclosed for plantations of young trees or shrubs.

Every person offending against these Regulations shall in accordance with the provisions of section 181 of the *Land Act 1915* for each offence be liable to a penalty of not more than Five pounds (£5) and every person who knowingly and wilfully offends against any such Regulations and who after he has been warned by any Bailiff of Crown Lands or by any member of the Police Force does not desist from so offending may be forthwith apprehended by such bailiff or member of the Police Force and taken before some Justice and shall be liable to a penalty of not more than Ten pounds (£10).

CONDITIONS OF CONTRACT.

1. The Government will not be bound to order from the contractor all the articles enumerated in the schedules, but only those articles, and such quantities of those articles, as it may be found necessary to order. Should the Government, however, require a larger supply of any article than the quantity stated in the schedule, the contractor will nevertheless be bound to supply the same at contract rates.

2. The supplies are to be the same as sample where so stated, and of the particular description indicated in the schedule of tenders. In the case of different makers' goods, the contractor will be required to supply the kind ordered. In the event of the tender being accepted for goods of Commonwealth or British manufacture (as the case may be), all such goods supplied shall bear evidence that they are of the particular manufacture tendered for, and, in addition, the contractor may at any time during the currency of the contract be called

on to furnish a statutory declaration as to the country of origin of the goods supplied. The supplies are to be the best quality of their several kinds or manufacture.

3. The value of all packages, cases, &c., whether bulk be broken or not, must be included in the prices stated in the contractor's tender; all such packages, &c., to be considered the property of the Government, and no charges or expenses whatsoever beyond the price tendered and set out in the schedule will be allowed to the contractor for any articles or packages, cases, &c. The net quantity only will be paid for. Contractors must provide, without extra charge, whatever labour may be required in the packing of stores, and the stores shall be packed in such a manner as shall secure them from injury during transit, and until delivery such stores shall be at the risk of the contractor.

4. All orders for supplies will emanate from the Education Department. The goods shall be delivered as may be directed by the officer ordering the supply.

5. Supplies ordered for delivery in Melbourne are to be delivered free of all charges (whether cartage, freight, &c.), and, for the purposes of this contract, Melbourne will include a radius of 6 miles from the General Post Office.

6. Arrangements as to time of delivery and inspection of goods will be made by the Secretary for Education or such other officer whom he may appoint.

7. Orders must receive prompt execution; and in the event of the goods not being delivered within forty-eight hours after the contractor shall have received the order, or within such other time as the order may specify for delivery, it will be competent for the officer named in Condition 6, or the head of the department to whom the goods are to be supplied, on giving the contractor twenty-four hours' notice, to purchase the supplies, or any like supplies that are suitable for the service, at the contractor's risk, and the extra expense incurred over and above the contract price (if any) will be deducted from the contractor's account or from the security money.

8. All orders, duly receipted, shall be returned to the Education Department at the end of each month, accompanied by an account under the Audit Act and Regulations for the articles supplied during the month, and, on receipt of same, the contractor shall be entitled to payment, due time being allowed for the examination and verification of the claim.

9. The acceptance of the supplies shall be subject to the approval of the officer authorized to take delivery of the stores, or such other officer as shall be named in the conditions. Delivery of the articles will not be deemed to be made until they have been handed in good order and condition to the head teacher of the school or such other person as may be authorized to accept delivery, &c. The contractor may, however, claim a survey on any goods objected to; but in that case he must, within twenty-four hours after objection is made, give notice thereof, in writing, to the officer rejecting the goods. If, after the delivery of the supplies has been taken, any deficiency or defect is discovered therein, such stores may be returned to the contractor.

10. All goods forwarded under this contract shall, where practicable, be forwarded by rail, and all consignments shall bear the number of the consignment notes under which they are forwarded, and also the name of the contractor by whom consigned.

11. When the contractor is required to make delivery of goods at a railway station for transmission by rail for any department, he shall obtain a receipt for the goods in duplicate on the Stores and Transport consignment note, at the same time handing in a triplicate of the form as an authority for the Railways to act as agent for, and charge the freight to, the Stores and Transport Department or such other Department as shall be named therein. He shall as soon as possible, and not later than twenty-four hours thereafter, deliver at the Tender Board Offices the original, the duplicate to be forwarded to consignee in accordance with Clause 12. Should the goods thus forwarded be rejected, the contractor must bear the cost of replacing such goods, for which service the departmental consignment note is not to be used. Any infringement of this condition will subject the contractor to such mulct as the Tender Board may recommend under Clause 17 of these conditions. Such mulct may be deducted as in Clause 7.

12. Immediately after the consignment of the goods, the officer to whom they are forwarded shall be notified by the contractor, on the duplicate consignment note provided for the purpose, that the goods have been sent. On receipt of this document, the officer to whom it has been forwarded shall acknowledge thereon the receipt of the goods without delay to the Stores and Transport Office. In the event of loss through failure on the part of the contractor to comply with this condition he will be held responsible, and the amount of the loss incurred for same will be deducted as in Clause 7.

13. Should the order on the contractor specially provide that goods of a fragile character, or such as are liable to suffer loss by leakage, shall be consigned at the risk of the Railways Commissioners under special freight conditions, the contractor shall in such instance provide, in writing, on the consignment



note an intimation to that effect, failing which, in the event of loss, he shall bear the whole cost of replacing the goods, the amount being deducted from the contractor's account or the security money.

14. The official order issued by the Education Department shall be, by the contractor, forwarded by post to the teacher to whom each parcel is directed, for him to sign and return.

15. Delivery will not be deemed to have been made until the goods have been approved of. In case of the rejection or return of any supplies, the contractor shall bear the whole cost of replacing the supplies rejected or returned, otherwise purchases will be effected at the contractor's risk, and the extra expense deducted as in Condition 7.

16. The members of Boards of Survey will be appointed by the Treasurer of the State for the time being, and the decision of the Board is to be considered as final. If the Board shall decide that the article is not of proper quality it must be immediately replaced by the contractor, failing which it, or any like supply that is suitable for the service, will be procured elsewhere, and the survey fees and extra expense (if any) will be charged as in Condition 7.

17. A refusal to execute orders, irregularity in the quantity or quality of the supplies, or delay in delivering or replacing them when required, will subject the contractor, upon report from the Tender Board, to such mulct, not exceeding Fifty pounds, as the Treasurer may direct, and the amount may be deducted as in Condition 7. It will also be in the power of the said Treasurer, upon such refusal, irregularity, or delay, to terminate the contract forthwith, and forfeit the whole or any portion of the security money.

19.
